Dear Debbie,

With reference to the above premises licence variation application, I have no objections in principle but would like to alter two of the conditions to reduce the ambiguity. I would also like to make reference to the original premises licence application which states that a noise management policy is in place. This policy should cover the arrangements for controlling noise from the outside area at the front of the premises and general comings and goings, particularly during night-time hours.

1. The use of the outside area at the front of the building shall be limited to the hours of 0900hrs and 2100hrs. After that all consumption and sales will take place within the premises.

Changed to:

*The general use of the outside area at the front of the premises shall be limited to 09:00 to 21:00 hours. The use of this outside area shall be restricted to a smoking area only after 21:00 hours.*

2. All doors and windows will be closed after 9pm

Changed to:

*Doors and windows shall remain closed during periods of regulated entertainment apart from access and egress.*
