Good Afternoon Mr Manak and Mr Kullar

Following on from the meeting at the Tiki Hut I would like to see the following areas included in the application:

U18's will only be permitted on the premises until 2100hrs.

CSE training for all staff – documented and refreshed on a six monthly bases.

Staff training – challenge 25, selling to intoxicated individuals, proxy sales etc. this is to be documented and refreshed on a 6 monthly bases. Staff to be fully aware of the premises Drug Policy and Dispersal Policy.

Dispersal Policy to be documented

Drugs Policy to be documented

From 2100hrs no drinks will be allowed in the external areas.

SIA door staff will be employed at the premises – minimum 2 on a Friday and Saturday evening (2100hrs until close). A risk assessment will be completed by the DPS as to the need for SIA for the remaining operating hours.

CCTV – this is to cover all areas the public have access to within the premises with specific coverage of the front door and passageway to the toilet area. There will also be specific coverage of the external smoking area. The CCTV will record for a minimum of 28 days and be available on request to the RA. The DPS and/or manager will be able to access the footage and have the ability to download footage.

Personal Licence Holder to be on site after 2100hrs.

If you would like to discuss any of the conditions I will be available on Tuesday.
