At approximately 05:20hrs on Saturday 1st September 2018 a large scale disorder was reported at Club M, Hertford Place, Coventry whereby a large group were fighting and weapons had been seen. Police attended the incident and found a male with serious stab wounds a short distance away (City Arcade). Subsequent to this a further male was found at the rear of Club M with serious stab wounds. The male found at the rear of Club M subsequently died as a result of his injuries; the other male remains in hospital with significant life changing injuries. A murder investigation has been launched by West Midlands Police.

Due to the serious nature of the incident a closure notice was served on Club M for 24hrs preventing them from opening on Saturday 1st September in to Sunday 2nd September. I can confirm they intended to open on the evening of Saturday 1st September despite the serious disorder, life threatening injuries sustained by one of the victims and the male who died as a result of the stabbing related to this disorder.

Whilst the investigation is in its infancy the homicide team have confirmed via CCTV that two groups were involved in disorder inside Club M and this spilled onto the streets outside.

Historically this Club has been involved in serious disorder and were taken to review in 2016. The Club is currently on a Police Action Plan due to serious disorder outside the location in July 2018.

West Midlands Police feel the premises pose a serious threat to the Public if it remains open. The Premises continues to create an unacceptable level of risk to the safety and wellbeing of patrons, staff and emergency services responding to incidents.

The Police therefore request that consideration be made for interim steps to be taken and that the premises licence be suspended pending a summary review.

Notes for guidance:
