### 1 Recommendation

### 2 Background

- 2.1 Coventry is renowned internationally as the City of Peace and Reconciliation.
- 2.2 United Nations Peace Messenger Cities are cities around the world that have volunteered for an initiative sponsored by the United Nations to promote peace and understanding between nations. The movement began in the International Year of Peace, 1986 and lasted until 1991, during that period 74 cities were chosen from among thousands and appointed as Messengers of Peace by the UN Secretary-General Javier Perez DeCuellar. Coventry is a Peace Messenger City.
- 2.3 The Conference was organised by the IAPMC. The International Association of Peace Messenger Cities was established to recognize and encourage the role and responsibility cities have in creating a culture of peace. The IAPMC had its first meeting in Verdun France in 1988. It was formalized at a General Assembly meeting in New Haven, Connecticut, USA in 1990.
- 2.4 There was a debate around: "Dialogue on the Volga Forum of People's Diplomacy: Peace in 21st Century" was conveniently merged with the proceedings of the General Assembly.
- 2.5 Delegates from Coventry participated in round tables, conferences, and plenary sessions and adopted an important resolution which was distributed to all the UN Missions of member countries of the United Nations Organisation.
