The Lord Mayor led a minute's silence in memory of all those who lost their lives in the recent tragic tsunami disaster.

79. New Year's Honours

83. Statement by the Leader of the Council on the Tsunami Disaster which devastated South East Asia over the Christmas Period

Councillor Taylor addressed the Council on the recent tsunami disaster which affected South East Asia to which Councillors Mutton and Nellist responded.

Councillor Mutton moved the following Notice of Motion, which was seconded by Councillor Duggins:-

"We call upon Coventry City Council to make every contribution that can be made to assist the countries affected following the tsunami disaster."

The following amendment was moved by Councillor Asif, seconded by Councillor Sawdon:-

"We call upon Coventry City Council, recognising the enormous contribution already made by Coventry people, to assist the countries effected by the tsunami disaster by promoting specific projects as outlined in the Leader's statement".

Members requested that a copy of the Leader's statement be circulated prior to taking a vote on the amendment and this was done. A copy of the Leader's statement would be appended to the minutes for ease of reference.

Councillor Mutton requested the Conservative Group to amend their own amendment by deleting the words "outlined in the Leader's statement" and inserting the words "agreed by the Leader's group". Councillor Nellist seconded the amendment, and Councillor Asif accepted the amendment which gave rise to the following substantive motion:-

"We call upon Coventry City Council, recognising the enormous contribution already made by the Coventry people, to assist the countries affected by the Tsunami Disaster by promoting specific projects as agreed by the Leader's group."

(NOTE: The vote on this was unanimous.)

Councillor Nellist then moved the following amendment to the Notice of Motion which was seconded by Councillor Ms. McKay and lost:-

"We call upon Coventry City Council to make every contribution that can be made to assist the countries affected following the tsunami disaster, and we believe that a major contribution for the long term future of the countries affected would be the cancellation of their foreign debts, and the use of the money presently paid to service those debts for the needs of local people in relief and reconstruction."

RESOLVED that the substantive Notice of Motion as set out above be adopted.

84. Main Debate - Coventry Older Peoples' Centre (Selected by the Labour Group)

Councillor Mrs. Lucas moved the following motion for the main debate, which was seconded by Councillor Clifford:-

"This Council reaffirms our support for a Coventry Older People's Centre. We believe that such a centre will bring increased activity to the City Centre and will make a contribution to the well being of older people."

The following amendment was moved by Councillor H. Noonan, seconded by Councillor O'Neill and carried giving rise to the following substantive Motion:-

"This Council notes its previous support for a Coventry Older Peoples' Centre. Such a Centre could bring increased activity to the City Centre and make a contribution to the well being of older people. Decisions made in relation to the Centre will be taken as part of the current PPR process."

RESOLVED that the substantive Motion as set out above be adopted.

85. Statutory Consultation on the Future Support Arrangements for Patient and Public Involvement in Health

Further to Minute 35/04 of Scrutiny Board (4) (Health), the City Council considered a report of the Director of Legal and Democratic Services which outlined a draft response to a national consultation on future support arrangements for patient and public involvement in health.

The Commission for Patient and Public Involvement in Health (CPPIH was established in January 2003 as an independent multi-departmental body sponsored by the Department of Health. Its role was to establish and support the 572 Patient and Public Involvement Forums (PPIFs), one for each NHS Trust. On 22nd July, 2004, the Secretary of State announced that CPPIH would be abolished as part of the Department of Health's review of arms length bodies. After confirming that PPIFs would continue, the Secretary of State announced that there would be a consultation on future support arrangements. The consultation began on 5th November, 2004 and ends on 30th January, 2005.

The response indicated that future support for PPI Forums be provided by local authorities subject to there being statutory protection for their independence together with adequate funding being provided to local authorities to undertake this role.

RESOLVED that the City Council:-

- (1) Approve the draft response at Appendix 1 of the report and that a written response be made to the consultation.
- (2) Make the joint response with the University Hospitals Coventry and Warwickshire NHS Trust.

86. Building Communities, Beating Crime: A Better Police Service for the 21st Century – Home Office White Paper on Police Reform

Further to Minute 136/04 of the Cabinet, the City Council considered a report of the Head of Corporate Policy which sought agreement to a response to the Home Office White Paper on Police Reform – Building Communities, Beating crime: A Better Police Service for the 21st Century, published on 9th November 2004.

The report had also been considered by the Scrutiny Co-Ordination Committee at their meeting on 12th January, 2005, (Minute 80/04 refers).

The White Paper outlined how the Government intends to further reform the Police Service and detailed what they believe this reform would mean for the Police, local people, local neighbourhoods and authorities.

The White Paper also sought to enhance the current role of councillors and local authority Community Safety Officers to give them an explicit remit to provide the focal point for local community in terms of dealing with those agencies responsible for community safety.

The response to the proposals had been drafted in consultation with the Community Safety Partnership, a copy of which was appended to the report.

Members noted that Cabinet were advised that the proposed response indicated broad support of the proposals within the paper, with the exception of not providing enforcement powers to Police Community Support Officers (PSCOs). It was considered that if enforcement powers are not given to PCSOs, the public would see them as powerless and they would not be afforded respect, which will be detrimental to them performing their duties. It was accepted that the majority of their time would be spent on the street providing a physical and reassuring presence, but it was felt that enforcement powers should be available should the situation arise where they were needed.

The Cabinet decided to support the response as set out in the report.

RESOLVED that the City Council endorse the views of Cabinet.

87. Functions Delegated to Planning Committee

The City Council considered a report of the Director of Legal and Democratic Services, which sought approval to amend the City Council's constitution following the recent introduction of new regulations insofar as it relates to the functions of the Planning Committee.

The Local Authorities (Functions and responsibilities) (Amendment) (Number 2) (England) Regulations 2004 related to the powers of the Planning Committee and the Regulations dealt with changes brought about by the Planning and Compulsory Purchase Act 2004. A copy of the amendments were appended to the report.

It was proposed to amend the City Council's Constitution insofar as it relates to the functions delegated to the Planning Committee in line with new regulations. The necessary amendments would be made to the City Council's Constitution when the Constitution is next updated.

RESOLVED that the City Council approve the amendments to the City Council's constitution insofar as it relates to the functions of the Planning Committee, as detailed in the appendix to the report.

Notes for the Leader's Statement at Council 18th January 2005 Our Response to the Tsunami Response from Local People

The recent tragic events in the Indian Ocean have brought an overwhelming amount of support from the people of Coventry who have already responded magnificently to the Tsunami by raising funding for disaster emergency relief.

Fundraising efforts in Coventry have included events in schools, collections in workplaces, clubs, places of worship, raffles, a local Band Aid style project, the Coventry Evening Telegraph appeal – the list is endless.

I know that the City Council – members and officers – feel equally passionate about wanting to help the people who have had their lives devastated by the Tsunami. As a first response the City Council has encouraged people to contribute to the major charitable agencies which is the best way to provide emergency humanitarian aid and has set facilities so that local people can contribute to the Disaster Emergency Committee through our offices.

Taking it Further

However, we want to do more. Our City of Coventry has an honourable history of helping other communities to recover from disaster to help them re-build their future. This means providing help and working with local people over time and not just responding to the immediate crisis. The most recent example of this was our response to the earthquake in Gujarat in India.

I am pleased to say that all political groups have been working together to make sure that the City Council and the people of Coventry can provide support where it is most needed and after the Tsunami is no longer front page news.

The City Council has sought advice from the Local Government International Bureau and the Department for International Development. We have been advised that the best way that the City Council's can help is to:

- Provide medium-term technical assistance through release of staff which will be co-ordinated through the LGIB;
- Provide long-term support and assistance to a linked local authority or community in the task of reconstruction.

Coventry was one of the first local authorities to register our intention to provide this assistance and will be looking to establish a partnership link to a specific place which the people of Coventry and the City Council will be able to support in the re-building of a community.

Because of the extent of the devastation that the Tsunami has been caused the current lack of communication and the uncertainty about what the longer term needs will be, we will be waiting for further advice from the Local Government International Bureau over the next months so that we can identify a community to support. This will mean that the city of

Coventry can give the best long lasting financial and practical support where it is most needed.

What we will do when

Once we have identified out partnership community we will work with them to identify the support that is required from Coventry – this is likely to include both providing practical assistance and the expertise of Coventry people and raising funding for re-building projects.

We are hoping to hold a special Coventry fundraising day for out partner community – probably in the early summer – and to involve the whole city in supporting them.

We also know that working in international partnership in this way brings real benefits to the Coventry people of Coventry too.
