Title

Appointment to Outside Bodies - Coventry Airport Consultative Committee

1 Purpose of the Report

1.1 To make an amendment to the appointment made to the Coventry Airport Consultative Committee at the City Council's Annual Meeting.

2 Recommendations

2.1 The City Council is requested to nominate one member as its representative on the Coventry Airport Consultative Committee.

3 Information/Background

3.1 At its Annual Meeting on 24th June, 2004, the City Council nominated Councillors Mrs Dixon and Lakha to represent the City Council on the Coventry Airport Consultative Committee. This appointment overlapped with a re-organisation of the Consultative Committee by West Midlands International Airport. The reorganisation was undertaken for several reasons, the old Committee hadn't met for some time, the ownership of West Midlands International Airport had recently changed and also to respond to recent legislative changes. The re-organisation meant that the City Council was now only allocated one seat, under the previous arrangements two seats had been allocated. The Consultative Committee is chaired by Lord Peter Snape and comprises the following representatives, all having one seat:-

Stratford upon Avon District Council Rugby Borough Council Campaign Against the Expansion of Coventry Airport Coventry Chamber of Commerce Warwickshire County Council Coventry Trades Council Baginton Parish Council Warwick District Council Coventry City Council (vacant) Local Resident Coventry Airport Tenants and Users Association Campaign for the Protection of Rural England 3.2 On 23rd September the City Council considered a report which requested changes to the appointments to a number of outside bodies including the representation on the Coventry Airport Consultative Committee to reflect the single place now allocated. At the meeting Council agreed to defer a decision on any change pending a request to West Midlands International Airport to increase the number of places allocated to the City Council. The Airport Company has now responded and have indicated that they will not increase the number of places allocated to the City Council.

4 Proposal and Other Option(s) to be Considered

4.1 It is proposed that the City Council nominates one member as its representative on the Coventry Airport Consultative Committee.

Guidance has been issued to all members on working with Outside Organisations "Avoiding the Pitfalls" and members have also received a copy of "The Company Director – A Guide to Directors' Duties and Responsibilities".

6 Monitoring

6.1 A report setting a protocol for representatives nominated to outside bodies to report back to the Scrutiny Co-ordination Committee on the work of that body will be considered by Cabinet shortly. The protocol will facilitate a robust annual review of the continuing value of each appointment to ensure that Council representation on outside bodies delivers mutual benefit and value.
