APPOINTMENT OF MONITORING OFFICER FOR THE CITY COUNCIL

#### 1 Purpose of the Report

1.1 This report is to confirm arrangements for the management of Legal Services and the Monitoring Officer function following the recent departure of the Head of Legal Services.

## 2 Recommendations

The Council is requested to:

- 2.1 Appoint Ms Christine Forde as the Monitoring Officer for Coventry City Council with effect from 1st April 2008.
- 2.2 Appoint Mr Andrew Burton as the Acting Monitoring Officer for the City Council from the date of this Report until 31st March 2008.

#### 3 Background and Proposal

3.1 The current Head of Legal Services, who is the Monitoring Officer for the City Council, will leave the employment of the City Council on 24th March 2008 to take up a new post.

Because of outstanding leave and other time owed, she has effectively completed her role with the City Council. It is therefore necessary to appoint both a replacement for the Head of Legal Services who will also be the new permanent Monitoring Officer and an Acting Monitoring Officer to cover the interim period.

## 4 Proposal

- 4.1 An Appointments Panel convened on Wednesday 30th January 2008 has appointed Ms Christine Forde to be the new Head of Legal Services and Monitoring Officer with effect from the 1st April 2008. Council is therefore asked to ratify the appointment of Ms Forde as the Council's Monitoring Officer. The Minute from the Appointments Panel is attached.
- 4.2 Between now and 1st April 2008 it is necessary to appoint an Acting Monitoring Officer. It is proposed that Mr. Andrew Burton, who is a Team Leader in the Legal Services Division, be appointed as Acting Monitoring Officer until 31st March 2008 to ensure that there is

continuity of advice and support available to Elected Members. This appointment forms part of the interim Management arrangements which have been put in place to cover the period between the departure of the former Head of Legal Services and the Appointment of the new Head of Legal Services. These arrangements have already been notified to Members and Senior Officers.
