Public Business

57. Minutes

The minutes of the meeting held on 15 September 2009 were signed as a true record.

58. Coventry Good Citizen Award

On behalf of the Council, the Lord Mayor and his Honour Judge Hodson, the Honorary Recorder, presented representatives from the Earlsdon Echo with the Coventry Good Citizen Award. His citation read:

" The Earlsdon Echo was first published in April 1979 and was printed eleven times a year. The community newspaper was produced by a regular team of volunteers but also welcomed additional material from local people and organisations. The team believed that the essence of a community newspaper was that it was open to anyone who had a contribution to make.

The team wrote the articles, managed the advertising, dealt with the distribution and sales to over 20 outlets and also gave talks in other parts of the city to groups and organisations about the Earlsdon Echo.

The newspaper provided a source of information, comment and entertainment to the Earlsdon, Chapelfields, Hearsall and Spon End districts of Coventry.

The Echo was produced entirely by volunteers as a non-profit making service to the community, being independently financed by sales and advertising.

This team of volunteers deserved to be called Good Citizens of Coventry, especially in this their 30th year of publication."

64. Medium Term Financial Strategy 2010-2013

Further to Minute 59/09 of the Cabinet, the City Council considered a report of the Director of Finance and Legal Services which presented a Medium Term Financial Strategy (MTFS) for 2010-2013 for adoption by the City Council. The previous strategy was approved in January 2009. The Strategy underpinned the medium term policy and financial planning process that was at the heart of setting our revenue and capital budgets.

The Strategy was put forward at a time of considerable challenges being faced by our national and local economies and when we face a significant reduction in the real level of revenue and capital resources available to local government.

The Council had already begun to implement some of the significant change needed

to prepare the financial base to deal with this situation in the form of the Transformation Programme and the bringing forward of the budget setting process.

It was clear from the financial position that the City Council would need to achieve significant revenue savings over the medium term and set a significantly restricted capital programme. At this point, with no Comprehensive Spending Review completed by Government and none expected until after the election, the impact of Government spending on the Council could only be estimated.

The Strategy had three main objectives;

- To provide a stable medium term financial base from which to deliver the Council's priorities and transformation/ABC agenda.
- To move the Council towards a more strategic longer-term approach to delivering our revenue and capital plans.
- To set a sound financial planning framework to underpin the effective financial management of the Council.

The Strategy (which was appended to the report in full) was set within the context of the Council's commitment to delivering the Coventry Sustainable Community Strategy and the Corporate Plan. Although the Council was awarded 4 star status in March 2009 it recognised the need to further improve the quality of its services. This would be particularly challenging at a time when a much lower level of funding would be available to local authorities through Government grant and Council Tax.

In order to deliver better services the Council had embarked on a Transformation Programme that would affect every area of the City Council and all the services we deliver over the next few years. The report noted that over the course of the 3 year strategy the ABC programme would incorporate a number of fundamental developments to the way we work which included the delivery of more efficient and flexible services, greater collaboration with city and sub-regional partners, taking some difficult decisions and increasing focus on our core business and policy priorities.

The assumptions and principles outlined in the report and the Strategy were consistent with those being applied to the Pre-Budget Report and would be used in setting the 2010/11 budget proposals.

The Cabinet noted that the report would be considered by the Scrutiny Co-ordination Committee on 14 October 2009.

RESOLVED that, after due consideration of the options and proposals contained in the report and matters referred to at the meeting, the Council agree the Medium Term Financial Strategy appended to the report and approve the Strategy as the basis of the City Council's medium term financial planning process.

65. Extension of the Contract Term for the Connexions Service

Further to Minute 61 of the Cabinet, the City Council considered a report of the Director of Children, Learning and Young People which asked the Council to consider an extension of the contract with Coventry, Solihull and Warwickshire Partnership for the delivery of Connexions for a further 12 months, until 31st March 2011.

The report noted that Coventry, Solihull and Warwickshire Partnership currently delivered the Connexions Information Advice and Guidance (IAG) Service under contract until 31st March 2010, to both Coventry City Council and Warwickshire County Council. The report sought approval to extend the term of the contract to enable completion of work looking at various re-commissioning options for the future delivery of this service.

Connexions provided impartial careers information, advice and guidance for all Coventry young people aged 13-19. In addition Connexions provided support to help young people progress to further and higher education, vocational training or work with training and employment. The service also provided more intensive and targeted support to the most vulnerable young people who were at greater risk of not securing either employment, education or training opportunities. The Connexions Service aimed to remove barriers to learning and progression, and ensure young people made a smooth transition to adulthood and working life.

RESOLVED that, after due consideration of the options and proposals contained in the report and matters referred to at the meeting, the Council approve an extension of the contract with Coventry, Solihull and Warwickshire Partnership for the delivery of Connexions for a further 12 months, until 31st March 2011 to allow sufficient time for the completion of the joint commissioning work, the decision making process and preparation for implementation of the preferred option.

66. Charging Policy

Further to Minute 63 of the Cabinet, the City Council considered a report of the Assistant Chief Executive and the Director of Finance and Legal Services which introduced a new Charging Policy which would impact on the fees and charges levied for all services across the Council.

The report noted that, with the medium term financial pressures facing the Council, there would be significant challenges to meet in order to deliver a balanced revenue programme over the coming years. Setting the appropriate level for fees and charges was an important element in balancing the Council's revenue budget.

The former Value for Money Partnership Board commissioned a review of income generation opportunities, a number of which have been taken into account in the 2009-10 budget setting process, and also decided that it would be appropriate to establish a Charging Policy, against which the setting of all fees and charges should be measured in the future. The Policy was contained within the report submitted.

The Cabinet noted that Scrutiny Co-ordination had considered this matter at their meeting held on 22nd September 2009 and had supported the recommendations contained within the report.

RESOLVED that, after due consideration of the options and proposals contained in the report and matters referred to at the meeting, the Council:

- (1) Approve the Charging Policy for implementation across the Council
- (2) Note that the Corporate Management Team (CMT) was being charged with the task of exercising governance over charging arrangements, and that a working group of CMT was being tasked with reviewing all the Council's fees and charges, and the way in which the concessions policy should be applied across the Council.

67. Green Paper – Shaping the Future of Care Together – Consultation Response

Further to Minute 68 of the Cabinet, the City Council considered a report of the Director of Community Services, which sought approval of a proposed response to the Government consultation "Shaping the Future of Care Together".

The Green Paper was published by the Government on 14th July 2009 and described as a 'once in a generation review' of how social care in England was to be organised and funded. It invited consultation on the principles for improving the delivery of care, and on a number of options for reform of the current funding system. The Green Paper set out a number of consultation questions, which had each been addressed within the City Council's response which was appended to the report submitted.

The Green Paper identified a range of options for the future funding and structure of adult social care, including a 'partnership' model of funding to give all those in need a basic minimum entitlement funded through taxation – a 'National Care Service' – combined with payments made by individuals who could afford to contribute to their own care. Options also included the addition of some form of 'insurance' to cover the required individual contributions.

The consultation process was to close on 13th November 2009. The Government had committed to establish a 'national leadership group' to ensure the momentum for reform was sustained, and a White Paper on care and support was expected to be published in 2010, although it was considered that a lack of Parliamentary time may frustrate this.

The report had also been considered by Scrutiny Board 4 at its meeting on 14th October 2009, and a briefing note detailing their decision on this matter was circulated to the Cabinet.

RESOLVED that, after due consideration of the options and proposals contained in the report and matters referred to at the meeting, the Council approve the consultation response for submission to the Government.
