Public Business

89. Minutes

The minutes of the meeting held on 8th December, 2009 were signed as a true record subject to Minute 76 headed 'Petitions' being amended by the deletion of the figure '6' and the insertion of the figure '158' relating to the petition submitted by Councillor O'Boyle and Minute 87 headed 'Debate – The Building of New Homes in Coventry' being amended by the insertion of the word 'overwhelmingly' in the fourth paragraph of the substantive motion prior to the words 'majority of brownfield sites'.

90. Coventry Good Citizen Award

On behalf of the Council, the Lord Mayor and his Honour Judge Hodson, the Honorary Recorder, presented Anthony Pillage with the Coventry Good Citizen Award. His citation read:

"Anthony Pillage runs 'The Way of the Spiritual Warrior' martial arts school in Little Heath where he teaches about 250 students, aged from four to 54. He teaches children not only martial arts but also how to avoid bullies and resist peer pressure.

He works for the Positive Futures initiative and the Rathbone Organisation, teaching disadvantaged children and young adults, as well as teaching self defence to students at Bablake School.

He is a personal mentor to many of his pupils and people call him with their problems day and night. Anthony always has time and advice for them and goes out of his way to help and support them, whatever their situation. His non-judgmental approach has led him to be considered not just as a teacher, but also a friend to his students and their families alike.

He came to martial arts a number of years ago after a life-threatening illness meant he had to spend almost a month in hospital. During this time he realised that he was tired of the corporate 'rat-race' and he wanted to do something more from his heart, something that would help people improve themselves.

Tony is a pillar of the community and deserves to be recognised as a good Citizen of Coventry."

91. New Years Honours

The Lord Mayor referred to the awards made to the following Coventry citizens in the New Years Honours List:

- **MBE** to Victor Keene, Chairman of the Bonds Hospital trustees, for services to the community.
- **OBE** to Councillor Ram P Lakha for his services to the Sikh community in the city.
- **MBE** to Pru Porretta for her services to community cohesion and to the tourist industry in Coventry.

Members noted that letters of congratulations had been sent, on behalf of the City Council, to all the recipients.

92. Death of Monsignor Thomas Gavin

The Lord Mayor referred to the recent death of The Right Reverend Monsignor Canon Thomas Gavin on Christmas Day. Monsignor Tom had been the Parish Priest of St Thomas More Church from 1978 to 2004, one of the longest serving priests in the

Archdiocese of Birmingham. He organised the open-air mass of Pope John Paul II at Baginton in May 1982.

Members noted that a letter has been sent to the family expressing the Council's sincere condolences.

93. Civic Engagements

The Lord Mayor informed the Council of his recent civic engagements, which totalled 369 to date. During December and early January he had attended the visit of HRH Duchess of Cornwall to Emmaus and the Council's Christmas Carol Service. He had also hosted an event for the volunteers of the Coventry Half Marathon and the Civic Night at the Belgrade Theatre Pantomime for deserving families.

99. Debate – Government White Paper Regarding Policing

Councillor Mutton moved the following motion which was seconded by Councillor Bains:

"This Council welcomes the recently published Government White Paper regarding policing and in particular this Council welcomes the clearest message conveyed by the Government so far, that Directly Elected Commissioners will play no part in the future governance of our police.

This Council also welcomes the most generous financial increase in the Country from the Government for the West Midlands Police. We believe that the additional sums of money made available will help in the restructuring of the Force and in particular Local Command Units."

The following amendment was moved by Councillor Sawdon and seconded by Councillor Foster:

'On the first line of the first paragraph change 'welcomes' to 'notes' and on the second line delete 'clearest message conveyed by the government so far, that directly elected Police Commissioners will play no part in' and insert 'opportunity to debate'.

A further amendment was moved by Councillor Sawdon and seconded by Councillor Foster:

'After the words 'directly elected' delete the word 'Police' from the above amendment'.

This amendment was carried giving rise to the following substantive motion:

"This Council notes the recently published Government White Paper regarding

policing and in particular this Council welcomes the opportunity to debate the future governance of our police.

This Council also welcomes the most generous financial increase in the Country from the Government for the West Midlands Police. We believe that the additional sums of money made available will help in the restructuring of the Force and in particular Local Command Units."

The following amendment to the substantive motion was moved by Councillor Field seconded by Councillor Nellist:

'The following paragraph be added at the end of the Motion:

"This Council also believes that Neighbourhood Policing Team boundaries should, wherever possible, match the political boundaries in Coventry and should avoid dividing communities. We therefore call upon the Police Authority to review those boundaries that divide existing neighbourhoods and cross political boundaries, such as the split that affects the Upper Stoke Ward".

The above amendment was carried, giving rise to the further substantive motion:

"This Council notes the recently published Government White Paper regarding policing and in particular this Council welcomes the opportunity to debate the future governance of our police.

This Council also welcomes the most generous financial increase in the Country from the Government for the West Midlands Police. We believe that the additional sums of money made available will help in the restructuring of the Force and in particular Local Command Units.

This Council also believes that Neighbourhood Policing Team boundaries should, wherever possible, match the political boundaries in Coventry and should avoid dividing communities. We therefore call upon the Police Authority to review those boundaries that divide existing neighbourhoods and cross political boundaries, such as the split that affects the Upper Stoke Ward".
