12.1 To be moved by Councillor Harvard and seconded by Councillor Townshend:

"This Council apologises unreservedly to the people of Coventry for its failure to provide an efficient and effective domestic refuse collection service over the Christmas and New Year holiday period.

This Council acknowledges that such failure constituted a fundamental breach of trust with the people of Coventry.

The Council resolves to take the measures necessary to ensure that such failures never occur again."

12.1 To be moved by Councillor Windsor and seconded by Councillor Nellist:

"This Council, recognising the severe impact on employment and living standards brought about by the current recession, believes that plans for post election cuts in

public spending of tens of billions of pounds are not only wrong, in that the victims of the economic crisis will suffer further rather than those who caused it, but that such level of cuts risks deepening the recession itself; and therefore calls on whichever party forms the next government not to pass the costs of the economic recession on to working people and their families, but to lift the current annual cuts in local authority funding brought about by the Gershon review, and sufficiently fund local authorities to allow affordable house building programmes, education and community facilities refurbishment, and other useful public works to be publicly funded and to provide continued employment in the city."
