Statutory review of polling districts and polling places

Executive Summary:

The Cabinet Member Corporate and Neighbourhood Services instructed the Electoral Arrangements Advisory Panel to undertake this review and report back to Cabinet and Council any proposed changes to the current polling arrangements scheme. This report sets out a summary of how the review was conducted and the proposed changes as a result of this

Recommendations:

Report title:

Statutory review of polling districts and polling places

1. Context or background

- 1.1 Section 18C (1) of the Representation of the People Act 1983 (the Act) places a duty on all UK local authorities to review their parliamentary polling districts and polling places every four years. The previous review was completed in December 2007.
- 1.2 The following definitions were used within the review:
 - Polling District a geographical sub-division of an electoral area e.g. ward
 - Polling Place a geographical area in which a polling station is located. There is no legal definition of what a polling place is, it can be as tightly defined as a building, a street or as wide as the whole district.
 - Polling Station the actual room where the process of voting takes place. It must be located within the polling place that the authority has designated for the polling district. The location of the room within the polling place is the responsibility of the (Acting) Returning Officer.
- 1.3 Advice from the Electoral Commission was received in August 2010 that the review should be completed in time for changes to be implemented by May 2011 local elections. On 6 September 2010, the Electoral Arrangements Advisory Panel (EAAP or 'the Panel') agreed that the review should be carried out in this timeframe, as set out in Table 1.

- 1.4 In conducting the review, the Act requires local authorities to:
 - seek to ensure that all electors in the constituency have such reasonable facilities for voting as are practicable in the circumstances
 - seek to ensure that, so far is reasonable and practicable, the polling places are accessible to those who are disabled

- have regard to the accessibility to disabled persons of potential polling stations in any
 place which it is considering designating as a polling place or the designation of which
 as a polling place it is reviewing.
- 1.5 The statutory requirements that have to be followed in conducting the review include publishing a notice of the review, consulting with groups representing disabled people, considering the Acting Returning Officer's representations, and considering representations received from electors. These were incorporated into the timetable.

2 Options considered and recommended proposal

- 2.1 The first stage was to identify a list of polling places where there were known problems. Information was brought together from previous elections from the reports of polling station staff and inspectors, together with details of complaints received from electors. The Panel agreed the criteria for the review on 6 September 2010:
 - each ward should have between six and ten polling districts
 - each polling district should contain between 1,000 & 2,000 electors
 - there should be a designated polling place for each polling district wherever possible
 - all Portacabin locations to be reviewed for more suitable alternative arrangements
 - all buildings with known access problems be reviewed together with any buildings where problems were highlighted during the 2010 elections, especially those relating to access.
- 2.2 An initial consultation was carried out in September 2010. Councillors, MPs, MEPs, groups representing disabled persons and members of the public were invited to make representations on the existing scheme of polling districts and polling places. At the same time, as required by the Act, the Acting Returning Officer (ARO) was invited to make representations. There were 14 responses to this stage of consultation including 8 specific comments from the survey conducted during local democracy week.
- 2.3 The Panel met on 2 November 2010 to consider all representations received as part of this initial consultation including the representation of the Acting Returning Officer. The panel agreed a number of proposals for alternative venues to be used as polling places, together with several proposals to amend existing polling districts.
- Questionnaires containing a section on current electoral arrangements were handed to members of the public during Local Democracy Week. Of the questionnaires returned there were 46 questionnaires where the section on electoral arrangements had been completed. Analysis showed that 38 electors were satisfied with the current arrangements and a further 8 made specific comments. These comments have been included in appendix A and considered by the EAAP in drafting their proposals for change.
- 2.5 The proposals for change were published for a further period of consultation between 5 and 26 November 2010. These proposals were circulated to councillors, MPs, MEPs, and groups representing disabled persons, as well as being published on the council's website.

Consideration of findings of the review

- 2.6 The Panel met on 21 December 2010 to consider the two responses to the second consultation, and to agree a final polling arrangements scheme for submission to Cabinet and Council.
- 2.7 Consultation responses: Responses were received which included comments relating to both proposed changes to polling places planned in time for the elections in May 2011 and to polling places which had been planned to be investigated during 2011, to finish by 1

December 2011. All consultation responses were presented to the Panel for consideration as to whether these should be implemented.

- 2.8 The consultation responses were received relating to:
 - Coventry NE, Longford Ward, Hg Samuel Hayward Day Centre, Riley Square (ref no 24) – Objection to the proposal to delete this polling place and amalgamate the polling district Hg with Hi. Considered by Panel and agreed to retain polling place.
 - Coventry South, St Michael's Ward, Lf St. Mary and St. Benedict's RC Primary School, Leigh Street polling place (Ref no. 141). Comment: provide an additional portacabin in the car park in Keppel Street as portacabins used elsewhere in City and to be implemented for the 2011 elections. A further request had been received to investigate the use of the Mosque in Cambridge Street as an alternative polling place in Lf. In the proposals sent out for consultation on 5 November 2010, this polling district was identified as requiring further investigation later in 2011. this was considered by the Panel and it was agreed to update Cabinet on findings from investigations. Since the Panel meeting, the Mosque have confirmed the building would not be available until 2012 due to building works, so this option has been removed from Appendix B.
- 2.9 Following consideration of these representations and other work undertaken by Officers, the Panel agreed a final scheme for submission to the Council for approval. The polling arrangements scheme presented in Appendix B is arranged by constituency and within each by the wards contained in that constituency. This is because this is a statutory review of parliamentary polling districts and polling places.
- 2.10 The polling arrangements scheme in Appendix B includes all 155 polling districts and their relevant polling places. Of the 150 polling places, 123 show no change to current arrangements, 5 show a definite change and 4 show a possible change. In addition there are 18 where the action is classified as 'designate'. For these 18 polling places, a specific reference to a portacabin has been deleted. This will facilitate the proposal made by the Panel (in para 2.13) to use vacant shops instead of portacabins wherever possible.
- 2.11 There were a number of polling districts where the specific premises involved required further investigation in order to agree a change of polling place. These were:
 - Binley & Willenhall (Bh) Investigating use of John White Community Centre, Grange Avenue (replacement for Binley Private Members Club, Grange Avenue). Status: Still awaiting response.
 - Cheylesmore (Dg) Investigating use of the Trevor Webb Sixth Form Centre (part of King Henry VIII School) (replacement for the Hylands Hotel, Warwick Road). Conclusion: Use of this building was initially refused but further discussions are now being undertaken. If the Sixth Form Centre is not available the contingency will be to revert to possible use of 165 Warwick Road where agreement in principle has been given but building requires site visit.
 - Holbrook (Gd) Investigating use of Hen Lane Working Men's Club, Beacon Road as replacement for portacabin, Compton Road.
 Conclusion: agreement in principle – requires site visit.
 - St Michael's (Lf) Investigating use of Mosque, Cambridge Street (additional polling station in polling district).
 Conclusion: The building is undergoing building work and is not available until 2012.

- Upper Stoke (Ng) Army Cadet Building, Wyken Grange Road (replacement for No 8 Squadron ATC Headquarters, Wyken Grange Road).
 Conclusion: agreement in principle – requires site visit.
- 2.12 Where there is a possible change of polling place (such as some of the premises listed in Para 2.10), it is recommended that the whole of the polling district is approved as the polling place, in order that the change can be effected for the elections in May 2011. This enables a change to be made to the specific premises used without further referral to Council as they will sit in the designated polling place i.e. the polling district. The designation of the whole of the polling district is required because two polling places cannot be designated for one polling district. If the premises are not available, the status quo will be maintained. In Appendix B these appear as a 'possible change of polling place' with a recommendation to designate the whole of the polling district as the polling place.
- 2.13 At the Panel meeting of 21 December, officers were asked to investigate the following and report back to the Panel:
 - Exploring the use of vacant shops in the close vicinity of current sites currently used for portacabins. It was accepted that this could only be on an ad hoc basis with short term leases in the three months prior to the election. To be used where possible in 2011 elections.
 - Exploring alternative accommodation to minimise use of primary schools completed and reported to the Panel by end of June 2010.
 - Further investigations required as part of this polling district review (Appendix C) to be completed and reported to the Panel by end September 2010.
- 2.14 Any changes to the polling arrangements scheme arising later in 2011 will be reported back to Cabinet and Council for approval by December 2011.

3 Results of consultation undertaken

3.1 Relevant stakeholders were consulted throughout the process including councillors, MPs, MEPs and groups representing disabled persons. Comments received during the consultation are shown in **Appendix A**.

4 Timetable

4.1 The timetable for implementation is listed below

4.2 No Notice of alteration will be published as no changes to the register are required for any of the proposed changes. All changes agreed by Council will take effect from 1 February and any new polling places will be used in the May 2011 elections.

5 Comments from Director of Finance and Legal Services

5.1 Financial Implications

5.2 Legal Implications

Section 18C (1) of the Representation of the People Act 1983 (the Act) places a duty on all UK local authorities to review their parliamentary polling districts and polling places every four years. The next review is required to be completed prior to the publication of the next register on 1 December 2011. Section 18B of the Act refers to the considerations needed when selecting/reviewing polling places.

6. Other implications

6.1 How will this contribute to achievement of the Council's key objectives / corporate priorities (corporate plan/scorecard) / organisational blueprint / LAA (or Coventry SCS)?

The council will have completed one of its statutory requirements.

6.2 How is risk being managed?

- 6.2.1 The Council needs to review its polling arrangements to ensure they are accessible to all voters. If premises for polling places are chosen which are not convenient in terms of location, or do not have adequate disabled access, or are otherwise not suitable to house a polling station, this could lead to reduced turnout and dissatisfied voters.
- 6.2.2 By carrying out this review promptly and thoroughly, the Council is seeking to maintain and improve the standard and location of polling station facilities, which should assist people wanting to vote, and hence help improve turnout. Within the review, there has been provision made for contingency arrangements and flexibility in the few areas where the specific premises need to be finalised, in order to ensure we do secure the best possible location for the next local elections in May 2011.

6.3 What is the impact on the organisation?

6.4 Equalities / EIA

6.4.1 If premises for polling places are chosen which do not have adequate disabled access this could lead to reduced turnout and dissatisfied voters. Access to polling stations for electors with reduced mobility has been considered as part of this review, and consultation has been carried out with disabled groups.
