16. Changes to the Constitution

The City Council considered a report of the Director of Finance and Legal Services and the Director of Customer and Workforce Services which brought forward proposed changes to the Constitution.

The Council was legally required to keep up to date its Constitution and make copies available for inspection by members of the public. Changes were made to the Constitution in order to ensure that it remained up to date. It was important that the Constitution was an effective suite of powers, protocols, articles and procedures that facilitate the Council's Corporate Vision and Objectives and other key strategic objectives. The report brought forward proposed changes in order to meet these criteria. Attached at Appendix 1 of the report were the proposed changes to be made which were shown as tracked changes, whether they be additions, clarifications, amendments or deletions.

In the future all appropriate amendments to the Constitution would be made by Cabinet/Council.

The following amendment was moved by Councillor Noonan, seconded by Councillor Lapsa and lost:

That the proposed changes to Paragraph 4.10.1.7 of the Constitution relating to Planning Committee Site Visits on page 221 be amended as follows:-

- 1) That the following bullet point be reinserted:-
 - (vii) Only those Councillors attending the site visit may participate in and vote on the application when considered by the Committee
- 2) That the original numbering of the bullet points after (vii) be reinserted
- 3) That the following sentence at the end of the originally numbered (viii) be re-inserted:-

In these cases the rule in the preceding paragraph above as to participation and voting will not apply.

Paragraph 4.10.1.7 (vii and viii) of the Constitution now to read:-

- (vii) Only those Councillors attending the site visit may participate in and vote on the application when considered by the Committee
- (viii) Site visits may be necessary in other instances not involving consideration of an application (such as adoption of a proposed

RESOLVED that the City Council approve the proposed tracked changes to the Constitution as set out in Appendix 1 of the report submitted.

17. Protocol for the Appointment of Honorary Aldermen

The City Council considered a report of the Director of Finance and Legal Services and the Director of Customer and Workforce Services which sought to formalise a protocol for the criteria and process for selecting proposed individuals for the position of 'Honorary Alderman'. Council had previously provided approval to bestow the esteemed position of Honorary Alderman on former Councillors (reference throughout to 'Alderman' was to be taken as also reading 'Alderwoman'. The protocol for the enrolment of Honorary Aldermen was set out in Appendix 1 of the report submitted.

To confer the esteemed title of Honorary Alderman on any former Councillor was a prestigious honour. Legislation provided that this Council may, by resolution passed by not less than two-thirds of Members voting thereon at a meeting of the Council specifically convened for that purpose, confer the title of Honorary Aldermen. The criteria was that this title could be conferred on persons who have, in the opinion of the Council, rendered eminent services to the Council as past Members of that Council, but who are no longer Members of the Council. Those appointed would be addressed as "Alderman", in the same way as "Councillor".

There was no statutory definition of what would constitute "rendered eminent services to the Council". This would enable to Council to determine nominations made on their own individual merits.

Following the Council's approval for the introduction of Honorary Aldermen, it was anticipated that this would commence during the municipal year 2003/04. This did not take place as envisaged and the current position was to agree the protocol for any nomination for Honorary Aldermen.

RESOLVED to approve the protocol for nominations for Honorary Aldermen and the process to be engaged as set out at Appendix 1 of the report submitted.

- 4. To consider, as necessary, specific project issues
- 5. To monitor formal disagreements (at Level 2 and above)
- 6. To note innovation and Continuous Improvement Initiatives

Corporate Parenting Advisory Panel

Terms of Reference

- 1. The group will be constituted as a Cabinet Advisory Panel Group with a politically balanced membership.
- 2. To focus on the requirements in legislation and in good practice advice within Care Matters for Elected Member involvement and support in service improvement for looked after children and young people.
- 3. To develop a work programme and allocate and monitor tasks within the City Council to improve outcomes for looked after children.
- 4. To identify key areas where services and partner agencies need to deliver improved support for looked after children and refer these issues to the Care Matters Steering Group as necessary.

- 5. To develop and support direct communication with looked after children, including formal meetings and consultation leading to the establishment of a Children's Council, a structured pattern of visits to children's homes and social work team offices, and also informal meetings with looked after children and young people with a social and enjoyable element.
- 6. This group will have the opportunity to send issues to the Care Matters Steering Group for action. It is proposed that the Chair of the Advisory Panel sit on the Care Matters Steering Group.

Cabinet Advisory Panel – School Organisation

Terms of Reference

- 1. The group will be constituted as a Cabinet Advisory Panel Group.
- 2. To consider any objections received to school organisation proposals (for example the establishment of a new school or the closure of a school) and make recommendations to the Local Authority (Cabinet) on the determination of those proposals.

Cabinet Advisory Panel (Local Development Framework)

Terms of Reference

There is no legal requirement to set up an Advisory Panel to inform the development of a new Core Strategy, however, it is considered to be good practice to do so. The Advisory Panel would ensure regularly timetabled interaction between Elected Members of the group, in relation to the development of the Core Strategy, and ensure that key issues were identified and discussed early in the process.

Cabinet Advisory Panel (Olympics)

Terms of Reference

To co-ordinate the Council's work on promoting the City in preparation for the 2012 Olympics; to increase the level of investment in the City as a result of our involvement in the Olympic Games and to maximise the level of community involvement in games and associated projects and events.

Cabinet Member (Community Safety and Equalities) Electoral Arrangements Advisory Panel

Terms of Reference

- (1) To review the division of the 18 Wards within the City into Polling Districts in accordance with the Representation of the People Acts and associated legislation.
- (2) In consultation with local Ward Councillors and other such stakeholders as the Panel believe appropriate, to make recommendations to the Returning Officer about suitable polling places within each Ward within the City.
- (3) To consider the staffing arrangements, including the payment of fees, associated with elections and make appropriate recommendations to the Returning Officer and the Cabinet Member.
- (4) To make recommendations to the Cabinet Member and the Returning Officer in relation to any changes to procedures and practices as appropriate with regard to the electoral process within the City, especially in relation to any proposed legislative changes.

Cabinet Member (Community Safety and Equalities) Sexual Entertainment Venues Advisory Panel

Terms of Reference

- (1) To inform and assist the Cabinet Member (Community Safety and Equalities Services) in relation to the implementation of new licensing controls on "sexual entertainment venues" in Coventry.
- (2) To develop a proposed "sexual entertainment venue policy", including proposed fee levels and proposed standard licence conditions and undertake appropriate consultation prior to formal consideration by the Cabinet Member (Community Safety and Equalities).
- (3) To provide feedback to the Cabinet Member (Community Safety and Equalities) on key developments.

Cabinet Member (Community Safety and Equalities) Disability Equality Advisory Panel

Terms of Reference

To advise the Cabinet Member responsible for equalities on disabled people's issues and to monitor, review and advise the Council on the development of the action plan for its Equality Strategy.
