Best Value and Scrutiny Reviews - City Centre strategy

1 Purpose of the Report

1.1 This report updates you on the progress on the Vibrant City Centre and Flourishing Neighbourhoods Plan and the City Centre Strategy Best Value Review.

2 Recommendation

2.1 You are recommended to note the report.

3 Information/Background

- 3.1 The Best Value review of the City Centre Strategy was presented to the former Scrutiny Board 3 on 24 September 2003. This would normally have then progressed to Cabinet, but this was postponed pending the completion of the Vibrant City Centre & Flourishing Neighbourhoods Development Plan, which was part of the council's Modernisation & Improvement Plan.
- 3.2 Cabinet approved the Vibrant City Centre & Flourishing Neighbourhoods Development Plan on 27 January 2004 but decided to refer this to Area Forums for consideration.
- 3.3 The comments received are shown as Appendix 1 to this report. None was considered to have a material impact on either the Vibrant City Centre & Flourishing Neighbourhoods Development Plan or the conclusions of the City Centre Strategy Best Value Review.
- 3.4 The Council's Corporate Plan 2004/5 2006/7 was approved by Council on 20 April 2004. One of the targets in the plan is to achieve 100% of the actions in the Vibrant City Centre and Flourishing Neighbourhoods Plan delivered on time. As such, progress on the plan will be reported regularly to Cabinet. The last report was received on 7 December 2004 when it was noted that performance was 70% as at November 2004.
- 3.5 In the meantime work has continued to implement the recommendations of the Best Value Review of City Centre Strategy where resources were available and no policy decisions were required. Appendix 2 shows the progress made.

Responses from Area Forums on the Vibrant City Centre and Flourishing Neighbourhoods Plan

1 South East Forum

- 1.1 The report was considered by the South East Area Forum on 5 May 2004 and Members of the Forum were asked for comments either at the meeting or through the Chair, the Area Co-ordinator or Legal and Democratic Services.
- 1.2 An issue was raised regarding the former County Court building which was now being marketed as a public house. This could be used as a public building.
- 1.3 Concerns were expressed regarding the length of the document.
- 1.4 No further additional comments have been received.

2 North East Area Forum

- 2.1 The North East Area Forum considered the report on 6 May 2004 and Members of the Forum were asked for comments either at the meeting or through the Chair, the Area Coordinator or Legal and Democratic Services.
- 2.2 On respondent reported incidences where trees had been removed from within the area which he represents for development purposes, and requested information as to whether a replacement Programme had been put in place. Reference was made at the meeting to the City Council's tree planting policy and it was agreed to let the enquirer have the appropriate information in response to his question.
- 2.3 No further additional comments have been received.

3 South West Area Forum

- 3.1 The South West Area Forum considered the plan on 11March 2004 and a further opportunity to make comments was extended at the meeting on 13 May 2004.
- 3.2 A resident expressed the view that individual areas of the City are isolated from the totality, that the problems can be seen but communities are not given what they need and very little has been spent on addressing this in the past forty years. The Council should be turning things round not only in the City Centre and should be aspiring to change people's perceptions so that they can share it with visitors to the City. Councillor Batten indicated that this is being addressed in the context of the priority neighbourhoods identified in the Plan.
- 3.3 Concern was expressed that the Council does not have an overriding strategy to deal with its subways. It was suggested that they should be closed, and, where practicable, low-cost "pedestrian crossing" phases should be introduced at corresponding traffic signals. Councillor Batten explained the City Council's approach to this matter.

4 North Area Forum

- 4.1 The report was considered by the North Area Forum on 20^tMay 2004 and the Chair, Councillor Parker, asked that any comments be fed back to the City Development either through Carl Pearson or herself.
- 4.2 No specific comments were received.

5 North West Area Forum

- 5.1 The report was circulated to the North West Area Forum with the documents for the meeting on 19 May 2004. Owing to a shortage of time the Forum were given an outline of the report and advised that specific comments should be forwarded to James Russell, City Development Directorate or to the North West Area Co-ordination office.
- 5.2 No specific comments were received.

6 South Central Area Forum

- 6.1 The report was considered by the South Central Area Forum on 13 May 2004 and Members of the Forum were asked for comment.
- 6.2 Former Councillor Windsor, whilst recognising the good intentions of the Plan, expressed his concerns regarding consultation and how communities will be involved in the developments.
- 6.3 The Forum noted the report.
