Apologies

An apology for absence was received from Councillor Mutton.

Minutes

The minutes of the meetings held on 16th and 23rd February, 2005, were signed as a true record.

With reference to Minute 105/04 of the meeting held on 16th February, 2005, Councillor Patton commented that although at the meeting it had been reported that information relating to the consultation exercise would be submitted to the City Council meeting on 22nd February, 2005, the relevant council paperwork did not include any references to a petition and letters submitted on the matter and no reference was made at the meeting. Councillor Patton indicated that he was disappointed that the spirit of the minute had not been fulfilled.

With reference to Minute 119/04 of the meeting held on 23rd February, 2005, Councillor Patton requested that the Cabinet Member be credited for listening to the suggestions made by this Committee in setting the Highway Maintenance Programme.

134. Exclusion of Press and Public
