**44. Call-In Stage 1**

The Committee noted that no call-ins had yet been received this week. **45. Listed Buildings – Medieval Precinct Wall to the Charterhouse**

Further to Minute 37/05, the Committee received an update on a meeting that had taken place with Bluecoat School to discuss repairs to the section of the Medieval Precinct Wall believed to be in the ownership of Bluecoat School. The Headteacher had indicated that he was awaiting a response from the Diocesan Lawyers on the issue and would respond to the City Council once this was received.

The Officer went on to explain the difference, in terms of legal process, with regard to listed structures and scheduled monuments. It was noted that the Department of Culture, Media and Sport were the only organisation able to take action with regard to scheduled monuments. The Medieval Precinct Wall to the Charterhouse was both a listed structure and a scheduled monument, the Officer advised that scheduled monument legislation takes precedent to the listed structure legislation; if the wall was only a listed building the City Council would have enforcement powers.

**RESOLVED that the Officer be requested to write to the Department of Culture, Media and Sport and English Heritage to encourage them to take action in respect of the Medieval Precinct Wall to the Charterhouse.**

46. **Outstanding Issues**

The Committee considered and noted a report of the Director of Legal and Democratic Services that identified those issues on which further reports had been requested in order that Members could monitor progress.
