Report Back on the Work Of Outside Bodies - The West Midlands Passenger Transport Authority

1 Purpose of the Report

1.1 At their meeting on 10th May, 2005, the Cabinet approved a process of reporting back to the Scrutiny Co-ordination Committee on the work of those outside bodies appointed to by the City Council. This reports sets out details of the work of The West Midlands Passenger Transport Authority over the preceding twelve months and details of attendance by the City Council's representatives.

2.1 It is required constitutionally to appoint 3 members to the Authority

3 Information on Work of Outside Body

3.1 To oversee Centro with regard to public transport policy and operations across the West Midlands area.

4 Benefits to the City Council of the Appointment

4.1 To ensure representation and influence public transport policy with special regard to Coventry's interests, i.e. bus services, rail services and future proposals for BRT and other initiatives. Of Coventry's three members, one is a Committee Chairman and one a Vice-Chairman.
