Report Back on the Work Of Outside Bodies – Sure Start – North East

# 1 Purpose of the Report

1.1 This reports sets out details of the work of Sure Start over the preceding twelve months and details of attendance by the City Council's representatives.

### 2 Recommendations

2.1 It is recommended that the City Council continue to work with and monitor this outside body. Initial results are looking favourable.

#### 3 Information on Work of Outside Body

3.1 Sure Start Children's Centres provide integrated multi-agency services and are central to local authorities' efforts to develop mainstream early years provision. They are a universal point of access for integrated early learning and childcare, family support, health services, support into employment, and links to other specialist services. Sure Start Children's Centres will improve outcomes for all children, but place a particular focus on the most disadvantaged.

Coventry has a target of 19 Children's Centres by May 2008. The following 14 centres are open and designated, offering the range of services required in 30% and 70% Areas of Need. Of the 19 centres, 17 are in the 30% and only 2 in the 70% Areas of Need.

#### ★ 70% area of need

There are no new childcare places required to be developed in Phase 2. Existing providers of pre-school playgroups at Hill Farm, Richard Lee, Wyken and Cheylesmore will be developing these provisions to extend their current childcare facilities.

Gosford Park and Spon Gate will be continuing their childcare / education provision through their existing nursery class, extending to full daycare on an agreed timescale.

Provision for children  $0 - 2 \frac{1}{2}$  yrs will be through the development of childminding networks linked to each of the children's centres.

#### 3.2 Current priorities

- To complete partnership agreements / Service Level Agreements with Primary Care Trust, University Hospital Trust
- To develop partnership arrangements with primary schools with children's centre on site to include co-ordination of services, to complement schools services and children's centre targets

- Budgets for 2008 2011 have been allocated for Revenue costs, so work has started to profile each centre requirements based on *Performance Indicators*
- Governance Guidance has been issued which gives opportunity to further develop models and review current Partnership Boards in line with role of Children's Trusts
- A Pilot programme, to place Health Visitors within Children's Centres is nearing completion to be tabled between PCT and the City Council

#### 3.3 Support and Development

Children's Centres managers/owners meet on a regular basis to access training information and discussion. Representatives of partner agencies, children's services, library services, inclusion etc update developments in their services and identify opportunities to work together.

Children's Centres managers / providers represent the group on:

- Teenage Pregnancy Group
- Supporting Families
- Asylum Seekers / Refugees
- BME Group
- BookStart
- Marketing & Communication Group
- EYDCP

# 3.4 Monitoring / Review

Each Children's Centre has a Contract / Heads of Terms Agreement which includes *Performance Indicators* for Children's Centres.

Financial monitoring against Business Plans are conducted by the Business Support Officer.

The following table indicates Children's Centres in Phase 2 to be developed / timescales for completion / Capital costs
