Report Back on the Work Of Outside Bodies - Coventry Refugee Centre

1 Purpose of the Report

1.1 This report sets out details of the work of Coventry Refugee Centre over the preceding twelve months and details of attendance by the City Council's representatives.

2 Recommendations

2.1 That appointment should continue to be made to the organisation.

3 Information on Work of Outside Body

- 3.1 The Centre provides essential information and practical help to thousands of refugees and asylum seekers in the Coventry area. Many of the clients have only a limited command of English, so the Centre offers help when dealing with the appropriate agencies, organisations and service providers.
- 3.2 The work of the Centre falls into two main categories:
 - Help for asylum seekers in the many problems they face with subsistence, housing, health, racial harassment etc.
 - Help to to set up home for those given leave to remain

4 Benefits to the City Council of the Appointment

4.1 Coventry City Council provides core funding for this organisation and membership of the Board affords considerable synergy with other service provision of the Council.
