#### 1. Recommendation

To note the benefits to the City Council of attending the above conference.

#### 2. Background Background

A new gallery at The Herbert will explore Coventry's links to peace and reconciliation through the history of the city and its communities. This will include a focus on international links made during and after the Second World War which aimed to start a process of reconciliation and prevent future conflict. In order to develop this section of the gallery we have been working with relevant partners in some of Coventry's twin cities such as Dresden. Part of the gallery development includes an accompanying education programme and we hope to work with these international partners in this area.

As part of this development and through a previous visit to Dresden we have developed a link with the Dresden based education group, the '13th February 1945' Association. We hope to work with this group and other partners on an education project linked to the new Peace and Reconciliation Gallery, supported by the Education Service and the Citizenship Advisor. The project would be based around the key gallery themes of peace, reconciliation and remembrance. Schools have a duty to address community cohesion and they also deliver citizenship as a subject. Citizenship addresses issues relating to social justice, human rights and community cohesion. This project would include linking schools in Coventry with schools and survivors in cities around the world through video conferencing and other digital communications and media.

The '13th February 1945' Association was one of the organisers of the above conference entitled 'Remembrance as a commitment for peace, democracy and human rights'. Other organisers included Kulturbüro Sachsen e.V. which is an independent organisation working against rightwing extremism in Germany, the Jewish community in Dresden and the City of Dresden.

The conference follows on from a series of conferences in Dresden which aim to create a framework of remembrance around the bombing. This includes ways to counteract the use of remembrance of the bombing by far right groups. It focused on themes of remembrance, peace and human rights within an educational context, using the experience of Dresden as the starting point. Participants came from a range of countries across Europe and included most of Dresden's twin cities. Participants included teachers, academics, survivors and youth/education groups. The speakers were a mix of academics and educators working for memorial sites and NGOs.

#### 3. Cost of attending



#### 4. Benefits


- The opportunity to meet with a range of educationalists, academics and NGOs involved in education work around the themes of peace, reconciliation and remembrance.
- To further develop our link with partners in Dresden including the Association 13<sup>th</sup> February 1945 and the Stadtmuseum from whom we hope to borrow objects for the new gallery.
   Meeting face to face provided the opportunity to discuss joint working in more detail and on a practical level.
- Developing knowledge and new ideas about the ways peace and remembrance can be explored in an educational context with a focus on human rights and citizenship.
- Making contacts with potential international partners such as the European Reminiscence Network and the 'Association of March 11<sup>th</sup> Affected by Terrorism' who are exploring similar themes and who we may be able to work with in the future.
- To promote Coventry and the city's involvement in peace and reconciliation represented by the City Council, Coventry University and Coventry Cathedral. Coventry was mentioned by various speakers in relation to Dresden and how remembrance can be used. It was therefore extremely valuable to have representatives from Coventry to discuss this and present our own experience.
- To promote the 'Peace Partners' manual, a resource developed by Coventry education service and Coventry University.
- The opportunity to promote the new gallery in an international arena.
- An opportunity to learn from the ways different organisations in Dresden have come together
  to explore and debate these themes. This includes the city authority, historical groups,
  educational groups, religious groups, the Jewish community, teachers, survivors and young
  people. This is a useful example to explore in the context of Coventry and offers some
  interesting possibilities for future working.
