Subject:

Reports Back on Outside Organisations

1 Purpose of the Note

1.1 To ask the Scrutiny Co-ordination Committee to decide its approach to reports back from the Council's representatives on outside organisations.

2 Recommendations

- 2.1 The Committee is recommended to:
 - 1) Revise the approach to dealing with reports from outside organisations.
 - 2) Support option 5.4 Establish a rolling programme of reports
 - 3) Authorise the Chair with support from officers, to identify which outside bodies report to Scrutiny Boards and when.

Information/Background

3 Current Position and Constitution Requirements

- 3.1 The Council currently appoints representatives to 75 outside organisations, including some of the governing bodies of new academies. The Council's Constitution gives the Council's representatives on each outside organisation the responsibility for reporting annually to Scrutiny Co-ordination Committee on the work of that organisation, the benefits to the City Council of continuing its membership and the added value that the City Council's representatives bring to the organisation. The Committee has also asked for the attendance records of the Council's representatives to be included in each report. Representation on these bodies is usually because the governance structure of the outside body requires Council representation, or that it is desirable for the Council to be represented on the outside body.
- 3.2 The Constitution also provides for this Committee to decide the organisations from which it wishes to receive reports (8.6.1). In the past it has decided not to receive reports from 28 of the outside organisations mostly school trusts/academies, which could be included in the work programme of the Children and Young People Scrutiny Board or small charities which give grants to particular categories of Coventry people. Appendix 1 shows the bodies which are currently required to report. Appendix 2 shows those which aren't required to report.

4 Reasons for Suggested Change

- 4.1 In the past the reporting process has not been entirely satisfactory: Reasons for this are:
 - a) reports have mostly been fairly short, as it is difficult for report authors to provide a succinct but meaningful overview of organisations' work, particularly national and regional organisations such as the Local Government Association. It should be borne in mind the number of outside organisations means that if a lengthy report on each

- one were produced, a great deal of the Committee's time would be taken up in considering them, to the exclusion of other work.
- b) there has been a lack of consistency relating to reports from Trust schools/academies/Colleges: some are required to report and others not. As is the case with a) above, it is difficult for report authors to provide a succinct but meaningful report on the work of these academic institutions.
- c) there has been some duplication in that some organisations are scrutinised by the relevant Scrutiny Board as well as reporting annually to this Committee (e.g. the Belgrade Theatre Trust will be scrutinised by the Wellness, Liveability and Public Health Scrutiny Board, the Coventry and Warwickshire LEP is scrutinised by this Committee in relation to its governance arrangements and strategic direction and the Jobs, Skills and Growth Scrutiny Board in relation to particular projects).
- d) there are some bodies for which reports are not really appropriate e.g. the Bus Lane Adjudication Service Joint Committee (the Council holds membership in order to access the appeals process) or the Board of Directors of Birmingham International Airport Holdings Limited.
- 4.2 Therefore, in order to make the best use of its time in future, it is recommended that the Committee considers how the approach to dealing with reports should be changed. Options for this are set out in section 5 below.
- 4.3 Appendix 1 shows the outside organisations with Council representation, which report to Scruco, whether it receives grant funding, whether its minutes are publicly available, and whether it also reports elsewhere.

5 Options considered

5.1 Keep the Status Quo

5.1.1 The information set out in section 4 above shows that this is not the best way to deal with these reports.

5.2 Minimal reporting - receive attendance reports only

- 5.2.1 The Committee could receive a report showing only the attendance records for the Council's representatives. If the Committee had any concerns about levels of attendance it could ask for more information.
- 5.2.2 Although this would free up more of the Committee's time, it would not provide information on the work of the organisations or the benefits of the Council's membership.

5.3 Receive reports only on the bodies which are funded by the Council and/or support the Council's objectives in the Council Plan

- 5.3.1 With fewer organisations to report on, reports could provide more detail than in the past and the Member representative(s) and relevant officers from the organisation could be asked to attend the Committee to present them and answer questions.
- 5.3.2 This would give the Committee more idea about the work of each of these organisations and would make the organisation more accountable for the funding it receives. There may also be existing reporting mechanisms through funding agreements, which could be used to provide information to the committee.
- 5.3.3 The Scrutiny Co-ordination Committee (or a sub-group of) could also decide whether some outside bodies would be better reporting to specific Scrutiny Boards, such as the Belgrade Theatre Trust, or governing bodies of academies.

5.4 Establish a rolling programme of reports

- 5.4.1 The Committee could consider reports from a small number of organisations each year (different ones each year) and therefore each organisation would report less often.
- 5.4.2 As in 5.3, each report would be more detailed than is currently the case.
- 5.4.3 Over time, this option would give the Committee some understanding of the work of all the organisations.
- 5.4.4 The Scrutiny Co-ordination Committee (or a sub-group of) could also decide whether some outside bodies would be better reporting to specific Scrutiny Boards, such as the Belgrade Theatre Trust, or governing bodies of academies.

6 Recommended options and future approach

- 6.1 It is recommended that the Committee does not approve 5.1 or 5.2, but that it gives further consideration to options 5.3 and 5.4.
- 6.2 Both of these options would provide an opportunity for the Committee to be more aware of the work of outside organisations, but without taking up so much of the Committee's time.
- 6.3 In relation to the organisations where a report is not required, it would be appropriate to include some in the work programmes of the relevant Scrutiny Boards. In addition, if Members have any concerns about any of them, they could request a report to Scrutiny Co-ordination Committee or the relevant Scrutiny Board, or ask questions at the Council Meeting.
- 6.4 In addition, as can be seen from Appendix 1, a number of organisations publish minutes of their meetings on their websites. This information is freely available if members require further information.
