Subject: Population Change and Service Demand

1 Purpose of the Note

- 1.1 To brief Scrutiny Co-ordination Committee on the recent changes to Coventry's population and population projections.

2 Recommendations

- 2.1 It is recommended that Scrutiny Co-ordination Committee:
 - 1) Note the changes to the City's population and potential impact on service demand and the different levels of information available from the 2011 Census and population projections
 - 2) Identify where further briefings are required by Scrutiny Co-ordination Committee and/or Scrutiny Boards

3 Information/Background

- 3.1 The Census, which happens every ten years, provides the most accurate information about an areas population.
- 3.2 The 2011 Census puts Coventry's population at 318,600 and the number of households at 128,600.
- 3.3 Coventry's population grew by 5.2% in the ten years from 2001 to 2011. Much of the growth in Coventry happened towards the latter half of the decade and overall population growth in the city has been at a slower rate than the population growth in England and Wales (7.1%).
- 3.4 More detailed findings from the 2011 Census will be released by ONS through a staged approach between November 2012 and October 2013 (appendix A) This information will include demographics and population characteristics such as ethnicity, employment status and healthiness as well as data at a neighbourhood level.
- 3.5 In addition to Census information the city council receives annual population estimates and bi-annual population projections from the Office for National Statistics (ONS)
- 3.6 Current 'unofficial' population projections from the ONS indicate that the City's population may grow by an extra 66,000 people by 2033, taking the population to 430,900. Updated projections are due in September 2012 and the city council is expecting a lower projection based on the latest Census information.
- 3.7 Whilst there are some questions about the extent of projected population growth in Coventry, the population of the city is expected to increase and this is likely to have a significant impact on service demand in the future especially at a time of decreasing resources.

Quick Statistics refer to one variable on the census questionnaire for example the number of people who report Very Good, Good, Fair, Bad and Very Bad health status. This information will be released at a small area level (output area) and higher geographies.

Key statistics refer to information derived from more than one variable on the census questionnaire, and allow comparison across different small geographical areas (output areas). An example how many hours' people age 16 and over normally work in their main job a week.

Local characteristics provide the most detailed results possible for small areas (output areas), and contain two or more variables such as sex and occupation by age.

Detailed characteristics contain two or more census variables, such as age and sex, but provide considerably more detail than their local characteristics equivalent, for example sex and age and economic activity by religion. The data has a minimum population threshold of 5,000 persons and 2,000 households to reduce the risk of individuals being identified.

Themes such as **armed forces**, **migrant** and **workplace** bring together a range of results on a single variable, for example about those people working in the armed forces or people from particular ethnic groups.
