Subject: Car Parking Pricing Review 2017/18

1 Purpose of the Note

1.1 To inform Cabinet of the outcome of Communities and Neighbourhoods Scrutiny Board (4) consideration of the Car Parking Pricing Review 2017/18 report at their meeting on 28th June 2017.

2 Recommendations

- 2.1 Communities and Neighbourhoods Scrutiny Board (4) support recommendations 1 to 3 and 5 and 6 as contained within the report to Cabinet.
- 2.2 That Cabinet Member City Services revisits recommendation 4 regarding the proposals for Holmsdale Road, in conjunction with the Foleshill Ward Members, and the implementation of any resulting proposals is delayed until September to enable this consultation to take place.

3 Information/Background

- 3.1 Communities and Neighbourhoods Scrutiny Board (4) considered the Car Parking Pricing Review 2017/18 at their meeting on 28th June 2017.
- 3.2 The Board acknowledged that it had been a number of years since prices had been reviewed and understood the rationale behind the review.
- 3.3 Members asked a number of questions on issues which included the number of weekly tickets available and whether a price increase may result in more people choosing to park in residential areas as opposed to car parks, the rationale for introducing charges in out of town car parks including Holmsdale Road and ensuring spaces are available for shoppers but without a detrimental effect on local residents.
- 3.4 Members requested that the decision for Holmsdale Road be reviewed in conjunction with the Foleshill Ward Members, to include a site visit, and that any scheme will not be implemented until September to enable the scheme to be reviewed.
