10. Introduction and welcome

In the absence of Councillor Kershaw, Councillor Chater took the Chair for this meeting. The Chair welcomed everyone to the meeting and this was followed by introduction of the membership of the Forum.

11. Minutes

a) The minutes of the meeting held on 11 October 2013 were agreed as a true record.

b) Matters Arising:

With reference to Minute 2/2013 (b), the Forum received an update from Sue Heawood on the objection upheld by the Schools Adjudicator in respect of the Blue Coat School's policy. It was noted that a new policy would be used for late applicants and for 2015.

12. Primary co-ordinated admissions scheme 2015

The Forum received details of the proposed primary co-ordinated admissions scheme for 2015/16. It was noted that there were limited changes with references included for free schools and some dates were changed to ensure that they fell on a weekday. Members were advised that the oversubscription criteria would be remaining the same so there was no requirement to go out to consultation.

RESOLVED that the report be accepted.

13. Secondary co-ordinated admissions scheme 2015

The Forum considered the secondary co-ordinated admissions scheme and it was noted that there were similar issues changes to the primary scheme regarding date changes and references to free schools. The document also no longer contains references to community schools as all schools are now academies, voluntary aided or trust schools.

RESOLVED that the report be accepted

14. Consultation on school admissions arrangements for 2015

Sue Heawood reported on the consultation in respect of school admissions arrangements for 2015 and the Forum was advised that only St Mary and St Benedict Catholic Primary School had gone out to consultation.

A discussion ensued on increasing places as schools are not required to consult on increasing their admission numbers. Two secondary schools have indicated that they may be planning to increase their size but we will await confirmation

The Forum learnt of a pilot scheme being proposed in Warwickshire, whereby Warwick Town's primary schools would be combining catchment areas into a super priority area to assist siblings from within the wider priority area being offered places at their preferred school. This scheme may be rolled out depending on its workability.

Sue Heawood was thanked for her report.

15. Choice Adviser's Annual Report

Chris Firth gave a presentation on the statistics for non-returned secondary school applications for 2014. The maps illustrated the areas where forms had not been returned for admission to secondary schools in 2014 and highlighted the breakdown of such cases in a variety of ways.

Chris also provided data on in-year transfer requests between city schools.

Chris Firth was thanked for his report.

16. New School updates

The Forum received an update report from Sue Heawood on the new schools due to open in September 2014. The progress was as follows:

 WMG Academy - this is a University Technology College (UTC) and will be opening for Year 10 students in September. The building will be located next to Westwood Academy. At present there are 61 applicants for the places. Offers of places would be made on 3 March but if not filled the Academy would be able to continue to take late applications.

- Coventry Leadership Academy is a secondary Muslim faith school and a site has been located at Lockhurst Lane, which was within the Sidney Stringer Academy catchment area. They currently have 71 applications for the 100 Year 7 places at the school. It was noted that the school was taking applications for up to 50 Year 8 places. The closing date for this process was 14 February 2014 and it was reported that they had 22 applications so far.
- Seva School has planned to admit pupils into Reception, Year 1, Year 2 and Year 7. They will not be participating in the co-ordinated admissions scheme but would be making offers of places direct to parents on 3 March. Concern was expressed in respect of pupils in Reception and Year 7 who are offered places by Seva School and also then having an offer from the local authority scheme.

It was noted that there was no formal confirmation of the location arrangements for the school but work was underway with the trustees, the Education Funding Agency and the Local Authority to agree a site.

There was a question raised in respect of notification by the Local Authority of those that will be leaving their home schools to attend one of the above schools. Sue Heawood confirmed this would be done as soon as the information was available.

The Forum was also advised that bids had been made for the Link extended learning centre to become a free school and for Sidney Stringer MAT to open a primary school. Finham Park School was also preparing a bid to open another secondary school on the west side of the City.

Sue Heawood was thanked for her report.

17. Expanding schools

A presentation was received from Ashley Simpson on increasing secondary school places. The presentation followed on from the report Judith Applegarth presented at the last School Admissions Forum meeting in October 2013. It was reported that plans for an additional 20 forms of entry over the next 10 years were required.

The graphs showed the secondary school pupil growth analyses. The Forum noted that feasibility studies had been commissioned for all 19 current secondary schools to establish the potential for expansion on all existing sites. A report will be presented to the Working Group at Easter 2014.

Ashley Simpson was thanked for his presentation.

18. Any Other business

There was no other business.

19. Date of next meeting



<u>School Admissions Code – consultation on changes to the Code.</u>

The Department for Education (DfE) have consulted on changes to the School Admissions Code 2012. The local authority has responded to the consultation and the details below highlight the proposed changes and the Coventry response.

1. Allow all schools (rather than just academies and free schools) to include priority in admission arrangements for pupils eligible for the pupil premium

This change has been in place since 2012 for all academies and free schools. No academies or free schools have taken up this option to date in Coventry. However, as a general principle the local authority would support all types of schools having the same options.

2. Allow primary schools to include priority in admission arrangements for pupils eligible for the early years pupil premium or pupil premium where they attend a nursery which is part of the school.

Some early years provision in the city is via primary school nursery classes, but this is not at every school and the classes service a wider area than a single school catchment and in some cases offer a greater number of places than the number of places available in the school reception. The Code currently does not allow schools to prioritise applications from nursery pupils where this would be unfair to other local children whose parents did not send them to nursery. The Schools Adjudicator has highlighted a large number of cases in the last year where schools have included a link with nursery provision showing that their arrangements are illegal. They have asked the DfE to issue guidance so that "there is fair access to schools for all children on reaching compulsory school age in order that children are not disadvantaged by any decisions their parents make about the care of their children prior to compulsory school age or by access to specific child care." This recommendation seems to be at odds with the DfE proposal around this specific sub-group of nursery attenders.

Historically parents have sometimes wrongly presumed that admission to the nursery will guarantee admission to the main school, or at least will give them priority. The aim of this change will give priority to a sub-set of these children and lead to continuing confusion for parents.

The statement in the proposal is that this change "will also ensure that there are still sufficient places available in the reception class for local parents who choose not to send their child to the nursery". Whilst there may be some places available after the admission of such nursery children it can't be said that sufficient places will be available.

Also the process of identifying those applicants for Reception places who are eligible for pupil premium is a complex issue. Changing circumstances mean that parents can move into and out of eligibility, and applications are received well in advance of a child starting school. Do admission authorities (ie 26 own admission authority schools, plus the LA on behalf of 58 schools) assess using the position on the closing date of 15 January, or at another date prior to offers on 16 April, and do we need to retain a position which states that places will be withdrawn if the child is not eligible on starting school on 1 September? Given the change on status of any applicant has a knock on effect on all other applicants applying for places, the decisions on these issues and impact on schools and families will be significant.

Given the range of issues identified the local authority would not support this proposal.

3. Require schools to amend their arrangements within 2 months of a decision by the Schools Adjudicator.

In Coventry we have had recent experience of a school being required to amend their admission arrangements by the Schools Adjudicator, and the difficulties when these requirements overlap with application periods. The local authority supported this action to strengthen the position of implementing School Adjudicator decisions.

4. Reduce consultation periods from 8 to 6 weeks and change the timetable for consultation on changing admission arrangements.

The changes to the timescales which are detailed in the table below are in place so that objections can be lodged and dealt with by the Adjudicator and changes can be put in place within the timescales at point 3. In theory this will prevent there being an overlap with application processes which would cause confusion and difficulties for parents and for co-ordination arrangements administered by local authorities.

Some schools in Coventry failed to respond to current deadlines for the submission and publication of their admission arrangements. Late publication means that late objections to the Schools Adjudicator have to be accepted, so the premise of ensuring all disputes are settled before the end of the summer term each year under the new timetable may continue to be difficult to achieve.

5. Incorporating some non-statutory advice within the Code on how to deal with applications for summer born children where parents want them to be admitted into the year below their normal age group

The details provided would fit with the processes currently in place in Coventry, as these already adhere to the non-statutory advice issued.

6. Incorporate recent departmental guidance on definitions of previously looked after children

This is already being followed in Coventry so will have no impact.

7. Minor technical drafting changes to aid clarity

All details will assist in correcting anomalies that are within the Code due mainly to changes in terminology (eg SEN statements to Education, Health and Care plans) or legislative references.

Next steps

• DfE timetable currently identifies that they will aim to issue an amended School Admissions Code by mid-December.
