46. Declarations of Interest

There were no declarations of interest.

47. Minutes

The minutes of the meeting held on 10th March 2015 were agreed and signed as a true record. There were no matters arising.

Further to minute 38/14 relating to Library Petitions, the Cabinet Member indicated that a number of meetings had been held with local residents that had enabled discussions on possible alternative models of delivery which would retain library services but deliver significantly reduced costs to the Council. Options would include the co-location of different services and opportunities to co-operate with statutory and non-statutory partners in the City.

48. Feedback from the Consultation on Potential Changes to the Eligibility Policy for School Transport for Pupils with Special Education Needs and Disabilities

The Cabinet Member for Education considered a report of the Executive Director of People on the Feedback from the consultation on potential changes to the eligibility policy for transport for children and young people with Special Education Needs and Disabilities.

A public consultation began on 24 November 2014 on possible changes to the eligibility criteria for pupils/students in receipt of Special Educational Needs transport to school/college. The consultation ran until 23 January 2015 with the proposal at that time to implement any changes from September 2015.

In December 2014, the Cabinet Member released a statement delaying any possible decisions on revised eligibility criteria. He stated that there would be no changes to the September 2015 criteria but that the consultation would continue in order to gather full public, parental and young people's feedback into proposals. It was made clear at that stage that any changes which may be proposed for September 2016 would be subject to a further period of statutory consultation.

The report detailed the consultation responses received from 7 consultation events held at various venues across the City and to an online questionnaire.

The Cabinet Member acknowledged the difficult decisions that the Local Authority had to make in these austere times. This was an extremely emotive subject and for any proposals for change in the future, every endeavour would be made to work with parents to secure the best outcomes for the children concerned.

RESOLVED that the Cabinet Member for Education notes the responses received from the consultation and agrees to include consideration of these in any further decisions on whether to consult on changes to the eligibility criteria for transport for children and young people with Special Education Needs and Disabilities.

49. Determination of School Terms and Holidays 2016 - 2017

The Cabinet Member for Education considered a report of the Executive Director of People on the outcome of public consultation on the School Terms and Holidays dates for 2016/2017 and sought agreement to the School Terms and Holidays Calendar for 2016/2017.

Currently the local authority was required to set term and holiday dates for community schools, community special schools, voluntary controlled schools, pupil referral units, and maintained nursery schools. All schools in England were free to decide when their school day should start and end.

Governing bodies were required to set term and holiday dates in foundation and voluntary aided schools. The academy trust was responsible for the duration of the school year and term and holiday dates for academies and free schools.

The public consultation on the Coventry school terms and holidays dates 2016/2017 took place from 23 February 2015 to 10 March 2015 to which there were 493 valid replies to the consultation. The most popular of the three options available was Option 1, with pupils beginning their Christmas holidays on Monday 19 December. This was the preferred option of other West Midlands Authorities and also Warwickshire. Details of the options and a copy of the consultation document were attached as appendices to the report.

RESOLVED that the Cabinet Member for Education:

(1) Notes the outcome of the public consultation on School Terms and Holidays and agrees a calendar of School Terms and Holidays for 2016/2017.

- (2) Adopts Option 1 as the School Terms and Holidays programme 2016/2017 for Community, Voluntary Controlled and Community Special Schools and maintained Nursery Schools.
- (3) Invites the Catholic and Church of England Diocesan Authorities and the Governors of Trust Schools and Academies to recommend the same calendar of School Terms and Holidays for their schools.

Report title: Library Petitions

1. Background

1.1 An e-petition "Save Allesley Park Library from Government forced cuts" sponsored by Councillor Bally Singh and signed by 168 people closed on 1st June asking:-

"We, the undersigned, urge Coventry City Council to keep the Allesley Park library open in the face of government led cuts. We recognise the difficult decisions that the city council has to make, especially as funding from the Coalition government cuts spending power by nearly 50% in real terms since 2010. However, we believe the shared service model that the Allesley Park library can support, can also help the council keep sufficient library services open in the west of the city during these tough times."

1.2 An e-petition "Save Stoke Aldermoor Community Library" sponsored by a local resident and signed by 7 people closed on 8th June asking:-

"Save Aldermoor Community Library as we have very little resources in our Community and we would like our Library to stay open"

- 1.3 The City Council currently operate a Library Service comprising Central Library plus 16 community libraries, a mobile service and an at home service. The petitions refer to individual libraries:
 - Aldermoor Library located in Acorn Street, Stoke Aldermoor is one of the City's smaller libraries. The library was re-located to a building previously used as a shop (part of a small retail development) in October 2007.
 - Allesley Park Library is a modern purpose built library, part of Allesley Park
 Neighbourhood Centre in Whitaker Road, Allesley Park. The library opened in July
 2011 and the building is shared by a local GP practice and Pharmacy. The Centre is
 adjacent to the Wilfred Spender Centre.
- 1.4 The petitions relates to genuine concern from local residents regarding the level of service reductions that may need to be considered by Coventry City Council. It is a reality that the City Council has to make significant reductions in the amount of money it spends as a result of Government funding reductions. These reductions have required the Council to carefully consider all the various services it spends money on and this must include libraries.
- 1.5 The way in which library provision is provided across the city may be considered within service reviews. The challenges faced by the City Council present the opportunity to reflect on changing patterns of library use, and the changing needs of library users. The Council is currently exploring whether there are any alternative models of delivery which may retain services but deliver significantly reduced costs to the Council. Options will include the colocation of different services and opportunities to co-operate with statutory and non-statutory partners in the City.
- 1.6 No decisions have been taken regarding the closure of any of the city's libraries. Any future proposals to make changes to the library service will be subject to public consultation. Officers will work over the coming months with the various groups and individuals who have expressed an interest in library services to see if they can work with the Council to deliver a better service at reduced cost.

2. Options considered and recommended proposal

- 2.1 There is no current proposal to close any community libraries therefore, there is no further action that Officers are recommending to take in terms of this request.
- 2.2 The Cabinet Member is recommended to request that Officers write to the petition spokespersons to advise them of the Council's current position and assure them that residents and petitioners will be encouraged to participate in any future discussions in relation to library services in Coventry.
