#### 13. **Declarations of Interest**

There were no disclosable pecuniary interests declared.

#### 14. Minutes

The minutes of the Communities and Neighbourhoods Scrutiny Board (4) meeting held on 16 September 2015 were signed as a true record; subject to the inclusion of apologies from Councillor Skinner and with reference to Minute 9 (Twelve Month Implementation Report) the following: 'KPI data, client data to be supplied and information on internal inspections'.

#### 15. **Community Development Service - Impact and Priorities**

The Scrutiny Board considered a report of the Executive Director of Place on the Community Development Service (CDS) which was established in 2014, following a consultation on the future of neighbourhood working in the City in 2013. As a result of this process £820k was saved. Since its creation a further three posts had been deleted as a contribution towards Council savings requirements.

The same report was due to be considered by the Cabinet Member for Community Development, Cooperatives and Social Enterprise on 20 November 2015 and any comments made by the Scrutiny Board would be considered by the Cabinet Member.

Members questioned officers on a number of issues and responses were provided, matters raised included:

- Number of redundancies within the Council since the budget cuts
- The areas that have been targeted there are 700 different groups/activities listed on the directory. Reaching the deprived areas
- Sharing experiences and connecting people to self-serve empowering communities
- A breakdown of usage over a five month period
- Funding and accessing funding with support from the Council and other organisations
- Feedback and evaluating the impact on the organisation; providing data for a better understanding. Demonstrating the success examples of groups who have benefitted from the community grants

The Scrutiny Board discussed the case studies provided and requested that a briefing note be made available to Members of the Board detailing action that has been taken from the feedback from citizens who have attended the community events.

# RESOLVED, that the Scrutiny Board endorses the recommendations to the Cabinet Member for Community Development, Co-operatives and Social Enterprise.

### 16. Active Citizens, Strong Communities Strategy: Progress Update and Priorities

The Scrutiny Board considered a report of the Executive Director of People on Active Citizens, Strong Communities Strategy. The report provided an update on progress made towards making Coventry a 'social enterprise city', which has been supported in principle by the Cabinet Member for Community Development, Co-operatives and Social Enterprise.

The main aim of the report was to consider key learning that has emerged from a number of pilot engagement programmes and other opportunities for strengthening implementation. Members raised questions in respect of the Ignite Programme and the development of an Early Action Resilience Centre, which

would provide a City-wide resource to share learning and support good practices. It was noted that some of the deprived areas were the most active in terms of helping and supporting.

The Scrutiny Board discussed the strategy and questioned officers on the following:

- Opportunities for all groups in the community
- S106 money allocation and bids e.g. Ignite Programme
- Helping entrepreneurship and growing social enterprise and supporting organisations
- The Council's role as a key facilitator
- Support in affluent areas as well as in areas of deprivation
- The work of the Community Development Service and the Active Citizens, Strong Communities Strategy are very closely linked and it was helpful for the two to be reported together – to maximise opportunities for partnership and networking
- Delivering more for less following the recent cuts

The Scrutiny Board noted that work has been undertaken across the City to provide support in respect of applications for external funding/bids and web based presence to provide information for the community.

# RESOLVED, that the Scrutiny Board endorses the recommendations to the Cabinet Member for Community Development, Co-operatives and Social Enterprise.

#### 17. **Coventry Homefinder Policy - 12 months review**

The Scrutiny Board received a report of the of the Executive Director of Place, which provided an update of the first 12 months of operation of the new Policy, along with analysis of the effects of the changes on the Homefinder Register and the allocation of available properties.

The Coventry Homefinder Policy Review – 12 months from implantation document appended to the report which provided statistical analysis and the effects of the Policy changes. Members sought clarification from officers on the following:

- 10% of properties reserved for current tenants in future existing tenants to have the opportunity to move whilst also ensuring that those in housing need are prioritised and housing associations would be able to assist their tenants
- Allocation of properties choices for families in terms of area and size of property
- Assisting customers with IT needs to enable them to bid for a property
- Impact on homelessness and temporary accommodation. Concern raised on the number of evictions from private sector global impact
- The night shelter, homelessness and the work of the Salvation Army

• Housing needs of the armed forces

The Board acknowledged the work undertaken and supports the Head of Housing and his Team.

Councillor Thay abstained on recommendation 2, as he is a member of the Whitefriars Housing Group.

RESOLVED, that the Scrutiny Board endorses the recommendations to the Cabinet Member for Community Development, Co-operatives and Social Enterprise.

#### 18. **Outstanding Issues**

The Scrutiny Board noted that all outstanding issues had been included in the Work Programme for the current year.

#### 19. Communities and Neighbourhoods Scrutiny Board (4) Work Programme







## Tonnages





Subject School Crossing Patrols

#### 1 Purpose of the Note

1.1 To provide the Communities and Neighbourhoods Scrutiny Board (4) with an overview of the School Crossing Patrol service in Coventry, including an outline of recent service changes.

#### 2 Recommendations

2.1 The Communities and Neighbourhoods Scrutiny Board is recommended to note the contents of this paper and make any recommendations for further consideration by the Cabinet Member for Public Services.

#### 3 Information/Background

- 3.1 Legislative Framework
- 3.1.1 School Crossing Patrols (referred to in this briefing note as SCPs) were first established in the 1950's following the School Crossing Patrol Act 1953. The legislation was amended by the Road Traffic Regulation Act 1984, which contained powers to appoint SCPs to help children cross the road on their way to and from school, or from one part of the school to another, between the hours of 8.00am and 5.30pm only. The 1984 Regulations were further amended by the Transport Act 2000 to allow SCPs to operate at any such times as the Authority thinks fit, including outside the hours of 8.00am and 5.30pm, to help anyone cross the road, whether child or adult.
- 3.1.2 SCPs can only be appointed by an "Appropriate Authority", usually the local highway authority. In essence, the law gives an SCP wearing the uniform approved by the Secretary of State and displaying a prescribed sign (hence the phase "lollipop man/woman"), the power to require a driver to stop.
- 3.1.3 Whilst Coventry City Council, as an Appropriate Authority, has the powers to appoint SCPs, it does not have a statutory duty to do so. The provision of a School Crossing Patrol service is therefore discretionary.
- 3.1.4 Some parents mistakenly believe that the Council assumes responsibility for safety of their children on their whole journey to and from school when it provides an SCP or even



in some cases when an SCP is not provided. This is a misconception as the responsibility for ensuring the safety of children travelling to and from school is a parental one.

#### 3.2 <u>School Crossing Patrols in Coventry</u>

- 3.2.1 Historically there has been anything up to 147 authorised SCP sites in the city at one time or another since the 1950's. The majority of these sites had been authorised using a national criteria which assessed the need for the site based on the numbers of children crossing the road and vehicles passing at that time.
- 3.2.2 In more recent years, up to the point where the service was reviewed in 2015, the number of established sites had reduced down to 82 with only 57 of those sites actually operating with a SCP. In addition to the 57 patrolled sites prior to the review, a further 5 Standby SCPs were employed to act as cover in the case of sickness and other short term absences. The reason for the reduction in site numbers over the years is down to several factors including; sites no longer meeting the criteria, zebra or traffic light controlled crossings having been installed and difficulties in filling vacancies.

#### 3.3 Service Review

- 3.3.1 The Council is facing unprecedented financial challenges following on-going cuts to funding by central government. In 2014, as part of a response to this challenge, a service review was undertaken in order to achieve savings of £300,000 per year within the School Crossing Patrol budget. This effectively meant that in future years the service would have to be self-financing.
- 3.3.2 In the second half of 2014, extensive engagement with the city's primary schools began; this included meetings and presentations to the Primary Head Teachers Steering Group and individual consultation with each school to develop proposals to enable the Council to continue to provide a School Crossing Patrol service. The original plan was for individual schools to take on the responsibility for providing their own SCPs, with the Council being involved only to ensure the correct training and recruitment processes were followed as the law requires. This idea was rejected because schools had concerns about the public liability issues that such a plan would entail. An alternative proposal was then agreed whereby if schools wanted to retain the SCP(s) connected to their school then the school would buy-in the service direct from the Council. By doing so it removed the liability from the school as the service would remain with the Council.

In January 2015, the proposals were formally approved by Cabinet and Full Council through the 2015/16 Budget Report in February 2015

- 3.3.3 Including overheads, the cost to the Council of providing each SCP is in the region of £5,000 per year. In order to make it as easy as possible for schools to make the transition the Council agreed to subsidise the cost for the first two financial years. The subsidy meant that the cost per SCP would be capped at £2,500 in 2015/16 increasing to £4,800 in 2016/17. Participating schools would only be required to pay the full cost of providing a SCP from 2017/18 onwards.
- 3.3.4 During 2015, schools were given the opportunity to buy-in the service on these terms. It was made clear to them at the outset that any SCP sites that schools chose not to fund would be deleted. At the conclusion of this process, of the 82 established SCP sites throughout the city, schools initially agreed to fund a total of 41 of them and Service Level Agreements between the Council and individual schools were signed. (A school has since given notice to withdraw funding for one of their patrols bringing the current total of SCP sites to 40). In addition, the 5 Standby SCP posts were retained.

- 3.3.5 To effect this change consultation took place with employees in the School Crossing Patrol service during the second half of 2015. To avoid compulsory redundancies affected staff were offered the option of re-deployment to any of the remaining vacant SCP sites. For those sites to be deleted the staff and schools affected were given notice that the service would cease at the end of the autumn term on 18<sup>th</sup> December 2015. The Council will therefore commence changing for the service from the start of the new term in January 2016.
- 3.3.6 To help address any ongoing safety concerns a site specific risk assessment has been undertaken at all deleted sites. The outcome of the risk assessment process will be used to guide the justification for the introduction of any additional measures such as warning signs, road markings or enhanced crossing facilities.
- 3.3.7 Whilst the level of SCP sites in the new service currently stands at 40 this number is likely to fluctuate for one of two reasons. Firstly, under the terms of the SLA schools may terminate the agreement by giving the Council three months' notice. Equally schools may also opt to buy in the service from the Council should they chose to and SCPs will be recruited and deployed to new sites as quickly as possible.
- 3.3.8 Appendix A contains a list of the SCP sites that schools are funding and so will continue whilst Appendix B contains a list of the sites that schools have chosen not to fund and therefore have been deleted.
- 3.4 <u>Summary</u>
- 3.4.1 Government cuts have brought about the need to think differently about how the School Crossing Patrol service in Coventry is provided. Following the outcome of consultation with schools, the future service now involves schools buying-in the service from the Council to fund the SCP attached to their school. The costs are being subsidised for the first two years to help schools make this transition to the new arrangements.
- 3.4.2 Whilst every effort will be made to address any ongoing safety concerns at deleted sites, the responsibility for ensuring the safety of children travelling to and from school is, and must remain, a parental one.
