11. Declarations of Interest

There were no disclosable pecuniary interests.

12. Minutes of the Previous Meeting

The minutes of the meeting held on 12th October were agreed and signed as a true record.

There were no matters arising.

13. Recommendations relating to the Serious Case Review for Mrs E

The Cabinet Member for Health and Adult Services considered a report of the Executive Director for People, which presented the action plan in relation to a Serious Case Review (SCR) carried out on behalf of the Coventry Safeguarding Adults Board following the death of Mrs E.

A SCR was undertaken by the Coventry Safeguarding Adult Board following the death of Mrs E, who was 66 years old when she died. Mrs E had lived in housing with care and was the main carer for her husband, who was dependent on her support. Mrs E required hospitalisation following a fall where she sustained a fracture to her spine. Following a short period in hospital, she was discharged home, where her health deteriorated over a short time and her GP recommended that residential rehabilitation may improve her recovery.

After the commencement of the residential rehabilitation, Mrs E deteriorated further and was transferred to hospital as an emergency, where she failed to respond to therapeutic treatment and unfortunately died 5 days later.

The SCR was undertaken and made recommendations to improve practice and these recommendations were incorporated into the multi-agency action plan, attached as Appendix 2 to the report submitted. The organisations involved in the SCR were committed to ensuring that the issues identified were addressed. The

Coventry Safeguarding Adults Board would monitor the implementation of improvements within the individual services.

The Cabinet Member noted that, at their meeting on 18th November 2015, the Health and Social Care Scrutiny Board (5) gave detailed consideration to the Executive Summary Report and the associated action plans. The Board questioned at length representatives from a number of partner agencies involved in Mrs E's care in the weeks leading up to her death.

RESOLVED that the Cabinet Member for Health and Adult Services:

- 1. Reiterates to the Coventry Safeguarding Adults Board, the importance of ensuring that all the health organisations take account of the views of family, friends, neighbours and carers relation to an individual's care and that all the concerns raised about communications in this case are also addressed by those agencies involved.
- 2. Endorses the action plan detailed at Appendix 2 of the report submitted.

14. Recommendations relating to the System Wide Review for Mrs F

The Cabinet Member for Health and Adult Services considered a report of the Executive Director of People, which presented the action plan relation to a System Wide Review (SWR) carried out on behalf of the Coventry Safeguarding Adults Board following the death of Mrs F.

An SWR was undertaken following the death of Mrs F, who was 80 years old when she died. Although Mrs F lived alone in a variety of housing settings prior to her death, her granddaughter remained a major part of her family support network. Mrs F had chronic vascular disease which she was aware would be life limiting if she declined surgical intervention. Following discussions with health professionals and her granddaughter, Mrs F made the decision not to proceed with surgery.

It was acknowledged that Mrs F would require significant support from health care professionals upon discharge from hospital and therefore when it was agreed by her clinicians that she was medically fit for discharge from hospital, Mrs F was transferred to a care home where she could receive the required level of support. While in the care home, Mrs F developed tissue damage which became infected and, as a result, was re-admitted to hospital where she died 5 days later as a consequence of the infection.

The organisations involved in the SWR were committed to ensuring that the issues identified were addressed. The recommendations within the SWR report formed the basis of a Coventry Safeguarding Board action plan, attached as Appendix 2 to the report submitted, with the Board monitoring the implementation of improvements within individual organisations.

The Cabinet Member noted that, at their meeting on 18th November 2015, the Health and Social Care Scrutiny Board (5) gave detailed consideration to the Executive Summary Report and the associated action plans. The Board

questioned at length representatives from a number of partner agencies involved in Mrs F's care in the weeks leading up to her death.

RESOLVED that the Cabinet Member for Health and Adult Services endorses the action plan detailed at Appendix 2 of the report.

15. Transfer of 0-5 Public Health Commissioning Responsibility to Local Authorities

The Cabinet Member for Health and Adult Services considered a joint report of the Executive Director of People and the Director of Public Health, which outlined the current position and the work that had been undertaken to ensure the safe transfer of commissioning arrangements for the commissioning of 0-5 public health services from 1st October 2015.

As part of the Health and Social Care Act 2012, it was agreed that the commissioning responsibility for 0-5 public health would transfer to the NHS National Commissioning Board until April 2015, which was then extended to October 2015. This responsibility in the main covered the Health Visiting and Family Nurse Practitioner Services (FNP). Services were currently commissioned from Coventry and Warwickshire Partnership NHS Trust (CWPT) and cost in the region of £5.35m per annum.

Guidance was published by the Department of Health to support the transfer of the contracts for the service from the NHS to Local Authorities and financial allocations for Local Authorities from October 2015 were subject to consultation and finally published in March 2015.

Since the start of 2015, work had been undertaken to finalise the financial arrangements for the transfer with NHS England to ensure a smooth transition took place. In August a novation agreement was signed by all parties to support the transfer of contracts. In addition, national templates had been developed for a handover pack of information from NHS England to local authorities. Although there had been some delay nationally regarding the handover pack, due to information governance concerns, it was hoped that these concerns would be resolved shortly to enable the handover to be fully completed.

It was currently planned to re-commission the 0-5 public health services from 1st April 2017, alongside other associated public health services, to form integrated children's public health services in the future. A consultation exercise to inform the new service model would commence in the Autumn of 2015.

In considering the report and the matters raised at the meeting, the Cabinet Member expressed concern regarding the delay in receiving an Implementation Plan from the Coventry and Warwickshire Partnership Trust in relation to providing services from 8am to 8pm. It was reported that a further meeting with officers from the Trust and from the Council was due to take place later in the week and the Cabinet Member requested to be advised of the outcome and, if this was not as expected, a meeting be arranged for himself, the Deputy Cabinet Member and Shadow Cabinet Member with the Chief Executive of the Partnership Trust to discuss the matter further.

RESOLVED that the Cabinet Member for Health and Adult Services:-

- 1. Notes that responsibility for 0-5 public health commissioning transferred to the Council on 1st October 2015; that a re-commissioning exercise will be undertaken during 2015/16 and 2016/17 relating to 0-19 public health services and that a report would be submitted to Cabinet in the future to seek approval to take this work forward.
- 2. Requests that the Cabinet Member, Deputy Cabinet Member and Shadow Cabinet Member be advised of the outcome of the officer meeting with the Coventry and Warwickshire Partnership Trust regarding their Implementation Plan.
- 3. Requests that, if the outcome of the meeting detailed in 2 above is not as expected, a meeting be arranged for the Cabinet Member, Deputy Cabinet Member and Shadow Cabinet Member with the Chief Executive of the Coventry and Warwickshire Partnership Trust to discuss this matter further.

16. Ensuring the Quality of Care and Support in Adult Services.

The Cabinet Member for Health and Adult Services considered a report of the Executive Director of People, which set out proposals to ensure the quality of care and support in adult services.

In Coventry the quality assurance of organisations that provide social care funded by the City Council was led by the Council's Adult Strategic Commissioning Team but involved a significant amount of work within Coventry and Rugby Clinical Commissioning Group (CRCCG) and the Care Quality Commission (CQC). This work was co-ordinated through the Provider Escalation Panel, which was led by the City Council and provided a forum for intelligence to be shared and co-ordinated between organisations so that appropriate and proportionate action was taken.

The level of input dedicated to managing quality for a specific provider was subject to an assessment of risk which helped to ensure that resources were focussed on areas where they were most needed as opposed to a standard approach to all providers.

Where issues had risen, the Council was committed to taking an approach that resulted in an improvement in standards and, to deliver this, worked in close partnership with health colleagues. A small team of nurses employed by the CRCCG were incorporated within the Council's adults commissioning function to further support co-ordination of improvement activity.

It was noted that, positively, a recent CRCCG internal audit in relation to the joint quality assurance system for care homes concluded that "significant assurance can be given on the design and operation of the system's internal controls to prevent risks from impacting on achievement of the system's objectives".

A key requirement of the Care Act 2014 was that local authorities must develop their local knowledge in respect of potential provider failure and focus, where appropriate, on supporting providers at risk of failure. Local authorities were also required to have plans in place to manage exits from the market to ensure continuity of care. The CQC had parallel duties in relation to larger providers where provision spanned several authority areas and there was a requirement for co-operation between CQC and local authorities.

The City Council had been actively operating a Quality Assurance Framework since 2010 across adult social care. Quality standards were defined throughout the commissioning process and set out within contracts. A key role for the Strategic Commissioning Team was to monitor contracts against these standards, including supporting providers to develop and implement action plans where improvements were required. All contracted provision within the City had a minimum of one planned quality assurance review per year. In addition, there were a number of mechanisms that enable stakeholders to alert the Strategic Commissioning Team to issues outside of the formal meetings and these were always thoroughly investigated.

The approach to planning for market failure had been taken with the Coventry and Rugby Clinical Commissioning Group, who were a key partner in supporting this process and a commissioner of community health services as well as having its local NHS duties. A market failure plan had been developed and was attached as an Appendix to the report submitted. The Council acted proactively to support providers wherever practicable and worked jointly to manage situations effectively.

RESOLVED that the Cabinet Member for Health and Adult Services approves:

- 1. The approaches taken in Adult Social Care to manage market risk through quality assurance processes.
- 2. The contingency plan to be used in cases of market failure.
- 17. Any other items of public business which the Cabinet Member decides to take as matters of urgency because of the special circumstances involved

Passport to Leisure and Learning – Re-launch and new online application process

Is this a key decision?

No - Although the matter within the report can affect all wards in the City, it is not anticipated that the impact will be significant and it is therefore not deemed to be a key decision.

Executive Summary:

The Passport to Leisure and Learning (PTLL) scheme is a concession scheme primarily for Coventry residents who are eligible for a means tested benefit. The aim of the scheme is to increase accessibility and encourage participation in learning and leisure opportunities across Coventry.

The current take up of the PTLL scheme is extremely low, with only 1,548 cards in circulation and valid. Consultation on the PTLL scheme, which took place in 2013 indicated that the current application and renewal system is expensive, outdated and bureaucratic. The process involves completing a lengthy manual application/renewal form and providing suitable identification alongside eligibility/benefit verification.

The Council cannot currently accurately quantify how many residents in the city would be eligible for the PTLL scheme, due to Data protection rules within the Department of Works and Pensions (DWP).

There are 34,607 homes in the city that are in receipt of either a Housing Benefit or Council Tax Support payment via the Council's internal Benefits and Revenues team. Housing Tax benefit and Council Tax Support that meet the eligibility criteria for PTLL scheme. The Council are recommending targeting these 34,607 homes as part of a re-launch of the scheme.

Coventry residents on other qualifying benefits which are registered with the DWP will be able to apply for the PTLL card through an online application process.

Recommendations:

Cabinet Member for Public Health and Sport is recommended to approve:

- (1) That the council distributes PTLL cards to the 34,607 households in Coventry that currently receive Housing Benefit and Council Tax Support.
- (2) The PTLL scheme will be free of charge, verification of proof of benefits will not be required and all cards issued will be valid until a unified card is implemented.
- (3) All other residents who are eligible for PTLL scheme through alternative qualifying benefits will have the opportunity apply for a card through an online application process.
- (4) The PTLL card will be issued to all foster carers looked after children and any children that are deemed to be at risk in Coventry.
- (5) A project team is established to include all key stakeholders, which will examine the feasibility of a unified concession card for all Coventry residents.

Report title: Passport to Leisure and Learning – Re-launch and new online application process

1. Context (or background

- 1.1 The Passport to Leisure and Learning (PTLL) scheme is a concession scheme primarily for Coventry residents who are eligible for one of the means tested benefit's listed below.
 - Jobseekers allowance
 - Pension Credit
 - > Income Support
 - Attendance allowance
 - Employment & Support Allowance / Incapacity Benefit
 - Personal Independence Payment / Disability Living Allowance
 - Working Tax Credit (Child Tax Credit alone does not apply)
 - Universal Credit
 - Industrial Injury Disablement Benefit
 - Severe Disablement Allowance
 - Carers Allowance
 - Widows Benefit
 - Industrial Death Benefit
 - Bereavement Benefit
- 1.2 Current uptake of the PTTL card is very low, with 1548 cards currently in use, the total eligible population in Coventry is estimated at around 70,000 residents, and current take up is 0.45%.
- 1.3 Use of the PTLL card has declined by 50% between March 2014 until the present day.
- 1.4 Housing Benefit or Council Tax Support data provided by the Council's internal Benefits and Revenues team has identified 34,607 homes that would meet the qualifying criteria for the PTLL scheme. All of the remaining qualifying benefits are managed by the Department for Work and Pensions (DWP), due to data protection the Council cannot access information on which residents are claiming means tested benefits managed by the DWP.
- 1.5 The current application process for eligible residents requires the completion of a printed application form, proof of eligibility, a photographic identification document and a passport style photo that is included on the PTLL card for identification purposes.
- 1.6 The current charge for a PTLL card is £5.20 for an adult and £2.60 for a child. Non-residents can apply for a card the same eligibility criteria applies but charges increase to £16.30 for an adult and £8.15 for a child.
- 1.7 In March 2016 the contract with the Post Office for issuing the PTLL card was terminated by mutual consent, the PTLL card is now only issued at the venues listed below.
 - Coventry Sports and Leisure Centre
 - Alan Higgs Centre Allard Way
 - Moat House Leisure and Neighbourhood Centre
 - Xcel Leisure Centre
 - Centre AT7
 - Central Library
 - Carers Trust
- 1.8 The current PTLL card is renewable on an annual basis; the existing renewal process for the PTLL card follows the same process as a first time application.

- 1.9 Looked after children and foster carers currently have to follow the same application process to access the PTLL scheme as a resident on a means tested benefit. There are currently 585 Looked after Children in the city who would be eligible for a card, and 515 Children at Risk (children subject to a protection plan).
- 1.9 A number of local providers offer variable levels of discount to cultural, leisure and learning opportunities including:
 - Adult Education Service
 - Coventry Sports Foundation
 - Coventry Sports Trust
 - Parks
 - Allotments
 - Atrium Health
 - Belgrade Theatre
 - Coventry Cathedral
 - Henley Active
 - Coventry Heritage and Arts Trust
 - Library and Information Services
 - Midland Air Museum
 - Skydome Planet Ice
 - > Tourist Information Centre
 - Warwick Arts Centre
- 1.8 826 residents responded to a Passport to Leisure and Learning scheme consultation held between January and March 2013. The main findings from the consultation were in relation to the cost of the card, the difficult and bureaucratic application process, issuing venues and the need to renew the PTLL card annually.
- 2 Options considered and recommended proposal
- 2.1 (Option A) All Coventry residents on a qualifying means tested benefit will receive / can apply for PTLL card with no charge (Recommended option)
- 2.2 Coventry City Council's internal Benefits and Revenues team can identify 34,607 homes in the city that are in receipt of either a Housing Benefit or Council Tax Support payment all of these households are eligible for a membership card. The Council are proposing to send:
 - one PTLL card to all single parent households and further cards to cover all children living in that household, and;
 - two PTLL cards where two parents are recorded, again including further cards to cover all children living there.
- 2.3 The 1500 residents that are already members of the PTLL scheme will be sent a new card.
- 2.4 An online application system will be launched in December 2016 allowing residents that qualify for the PTLL scheme through a means tested benefit that is managed through the DWP to apply for a free PTLL card. A targeted communications and marketing strategy will be developed to increase awareness of the PTLL scheme and the online application process.
- 2.5 No photo or benefit verification will be required by applicants at the point of application, as access to scanners/smart phones and uploading information may be a barrier preventing

- eligible residents to apply for the PTLL card. Once the PTLL card has been issued, providers may implement local identification & eligibility verification checks.
- 2.6 The PTLL card will not include a photo for identification purposes, providers are implementing local management arrangements.
- 2.7 The PTLL will not be renewable on an annual basis and will be valid until the launch of a unified Coventry concession card in late 2018. If a current member's benefit allocation alters they will be able to continue to use the card as if they were still in receipt of benefits.
- 2.8 The PTLL card will become part of the offer to potential foster carers. All existing foster carers, looked after children and children at risk will be supplied with a PTLL card through representatives from the People Directorate.

2.9 (Option B) - Continue with the existing PTLL scheme (not recommended)

- 2.10 The Council continue to offer the current PTLL scheme, which has a limited take up of 0.45% of the eligible population.
- 2.11 The existing manual application system would remain, including the need for a passport photo and limited issuing venues across the city which is a major barrier to potential applicants for the scheme.
- 2.12 The Council would need to continue to apply a charge to access the PTLL scheme to cover general administration costs required to issue the card.
- 2.13 Take up of the PTLL card will continue the trend of decline, resulting in the most disadvantaged residents not accessing Leisure and Learning opportunities at concessionary prices.

3. Results of consultation undertaken

- 3.1 In terms of the specific discounts that respondents said encouraged them to get a Passport to Leisure and Learning Card, the Sports and Parks discounts received the highest response it is also the most used discount, followed by Adult Education Service related discounts. Culture discounts proved to be the least encouraging and are also the least used; however, they are still used by over 1 in 4 respondents.
- 3.2 Almost a third of respondents said they use their card once or twice a week to claim a discount and a quarter said they use it this amount per month. A very low number said they never use it (1.7%).
- 3.3 There was a very clear message that the PTLL scheme is not well advertised and a number of advertising/promotional methods were suggested including; posters, leaflets, newspaper adverts and email alerts.
- 3.4 There was particular reference to the signing up and renewal processes in that they are too long, complicated and bureaucratic. It was also mentioned that too much paper work is required as suitable identification. Respondents also expressed their dissatisfaction with the fact that the PTLL only lasts a year and that it is too expensive to keep renewing it and the costs to update the required photographs. Respondents suggested a reminder system so that members are alerted to the fact that their card is due to expire. This was a contributing factor to the high level of respondents that said they didn't have a card (59.0%).

- 3.5 It was also suggested that the eligibility criteria for the scheme is extended so that not just people on benefits are entitled to it. A number of respondents suggested that over 60s should be included in the eligibility criteria.
- 3.6 Almost two fifths of respondents said that they hadn't renewed or had never had a Passport to Leisure and Learning Card because they were not eligible and a quarter said that they were not aware of it. When asked what their 'Other' reasons were, respondents reinforced that it was due to these reasons and that the card is too expensive to renew and the activities are too expensive.

4. Timetable for implementing this decision

- 4.1 All residents eligible for a PTLL card through Housing Benefit and Council Tax Support will be sent a PTLL card in December 2016. The online application process and new PTLL website will go live for all other residents who would be eligible for the PTLL scheme in December 2016.
- 4.2 People Directorate will be issued with a supply of PTLL cards to send out to existing foster carers and their families in January 2017. They will be given a further supply in order to issue to new foster carer families. All children at risk will be addressed via this mail out.
- 4.3 A project group to include all key stake holders will be established in January 2017 to examine the feasibility of a unified concession card. It is intended if feasible the unified concession card would be launched late in 2018.

5. Comments from the Executive Director Resources

5.1 Financial implications

The cost of issuing the required number of Passport to Leisure and Learning cards will create a small - one off pressure on the existing budget of around £30k (worst case scenario), this is expected to affect the 2016/17 budget when the cards are issued.

A loss of future annual income (£10k) is offset by savings on annual production costs as it is not intended to issue any further cards after this issue.

5.2 Legal implications

The issuing of the PTLL card meets the following legislation:

Section 2B of the National Health Service Act 2006 as amended by s.12 of the Health and Social Care Act 2012 which states

- "(1) "Each local authority must take such steps as it considers appropriate for improving the health of the people in its area" and "(3) The steps that may be taken under subsection (1) include:
- (a) providing information and advice;
- (b) providing services or facilities designed to promote healthy living (whether by helping individuals to address behaviour that is detrimental to health or in any other way);
- (c) providing services or facilities for the prevention, diagnosis or treatment of illness;
- (d) providing financial incentives to encourage individuals to adopt healthier lifestyles;
- (e) providing assistance (including financial assistance) to help individuals to minimise any risks to health arising from their accommodation or environment;

- (f) providing or participating in the provision of training for persons working or seeking to work in the field of health improvement;
- (g) making available the services of any person or any facilities and:

S.22 of the Children Act 1989 which places a general duty on the local authority in relation to children looked after by them and (3) it shall be the duty of a local authority looking after any child:

- (a) to safeguard and promote his welfare; and
- (b) to make such use of services available for children cared for by their own parents as appears to the authority reasonable in his case. This particular legislation is used to reflect that the PTLL cards will be issued to all foster carers, looked after children and any children that are deemed to be at risk in Coventry.

6. Other implications

6.1 How will this contribute to achievement of the Council's Plan?

The provision of reduced cost sports, learning, leisure, arts and cultural activities through Passport to Leisure will support local people living longer and healthier lives as the uptake of physical activities is increased. The young people eligible for the card will have safe places to get active, learn and enjoy cultural activities at sports centres, education venues and museums and galleries, helping them to make a positive contribution to the city.

The card will enable many local facilities to be more accessible for almost a third of the city's population and will encourage a creative, active and vibrant city. It will help narrow the gap between the economically well off and the less well-off and will see different communities coming together to play sports, learn and visit cultural venues.

6.2 How is risk being managed?

The PTLL card will no longer feature photographic identification and the application process will not include the verification of a valid means tested benefit. The scheme is potentially open to abuse and as such providers will implement local proof of identification procedures.

The level of uptake of the card with providers is a risk, with the potential for increased usage of all venues at peak times. Providers are implementing local procedures for the management of PTLL usage and 6 monthly meetings with providers will be facilitated to monitor usage.

6.3 What is the impact on the organisation?

There will be some one-off financial implications that need to be considered as part of the re-launch. Loss of income related to the scheme, however limited administration costs will remain as membership cards will need to be circulated to those eligible members who are not captured during the circulation to Housing Benefit/Council Tax Support during December.

6.4 Equalities / EIA

An Equalities and Consultation Analysis has been undertaken and is appendix 3 attached. This assessment showed that there is likely to be a positive impact on protected characteristic groups and no adverse effects.

Consultation told us that by reducing the paperwork and bureaucracy previously associated with the card, those on the lowest incomes in the city will be more likely to engage in sport, education and cultural activities. There will also be a positive impact on the children of those on the lowest incomes as they too, will be eligible for a card. Those on disability benefits will also be eligible.

It is known that engaging in sports and physical activity could increase length of life, improve lifestyle and improve mental health. By re-launching the card and sending it directly to those eligible – a large majority of who live in disadvantage neighbourhoods – there is a much higher likelihood that it will be used and positively impact those who receive one.

Looked after children, children at risk, young people aged between 16 – 19 and asylum seekers are all eligible for a card.

6.5 Implications for (or impact on) the environment

No impact.

6.6 Implications for partner organisations?

There would be no requirement for partners to manually issue the PTLL card to residents; there will be a small financial implication in relation to the commission charges to process applications – this will be lost to current administrators.

Encouraging participation in learning and leisure opportunities will have an impact on all of the providers; more of Coventry's most disadvantaged residents should take part in more activities and the participating avenues.

1. Executive Summary

Awareness and communication

Encouragingly 88.9% of respondents said that they were aware of the Passport to Leisure and Learning Scheme, however the most common way of hearing about the scheme was through word of mouth communication (35.5%) as opposed to more formal communication methods.

Passport to Leisure and Learning Card types

Two fifths (39.4%) of respondents said they currently had a Passport to Leisure and Learning Card. In terms of the types of card held by respondents that did have a card, the majority of respondents said they have an adult card (85.4%).

Discounts

In terms of the specific discounts that respondents said encouraged them to get a Passport to Leisure and Learning Card, the Sports and Parks discounts received the highest response – it is also the most used discount, followed by Adult Education related discounts. Culture discounts proved to be the least encouraging and are also the least used, however, they are still used by over 1 in 4 respondents.

Almost a third of respondents said they use their card once or twice a week to claim a discount and a quarter said they use it this amount per month. A very low number said they never use it (1.7%)

Qualification for the card

In terms of those who have a Passport to Leisure and Learning Card, over half of these qualified as they were in receipt of either a means tested or Disability benefit (57.5%), however a fifth of respondents said that they qualified due to 'Other' reasons, these were largely due to;

- Being a carer
- In receipt of Working Tax Credits (Means Tested)
- Claiming Job Seekers Allowance (Means Tested)

Signing up for the card

Half of respondents said that they had signed up at their local Post Office and a fifth had signed up at one of the City's Sports Centres.

Another popular place where respondents said they had signed up was at the Coventry Carers Centre.

Satisfaction with the Card

Respondents were largely satisfied with the scheme across a number of different aspects – in particular relating to the cost of the card (82.4%), the range of discounts (80.7%) and information about discounts (80.2%)

Suggestions on how to improve the scheme

There was a very clear message that the Passport to Leisure and Learning scheme is not well advertised and a number of advertising/ promotional methods were suggested including; posters, leaflets, newspaper adverts and email alerts.

There was also consensus that the card should be able to be used in more places and should not be restricted to just within Coventry. When directly asked about this, 76.8% of respondents said that discounts at facilities outside of Coventry would encourage them to consider getting a card.

There was particular reference to the signing up and renewal processes in that they are too long, complicated and bureaucratic. It was also mentioned that too much paperwork is required as suitable identification. Respondents also expressed their dissatisfaction with the fact that the Passport to Leisure and Learning card only lasts a year and that it is too expensive to keep renewing and update the required photographs. Respondents suggested a reminder system so that members are alerted to the fact that their card is due to expire. Renewing the card was a contributing factor to the high level of respondents that said they didn't have a card (59.0%).

A number of respondents suggested that the eligibility criteria for the scheme is extended so that not just people on benefits are entitled to it.

Suggestions on where there should be other discounts

Discounts for the cinema and theatre were the most suggested, followed by discounts at restaurants, food and drink outlets and supermarkets. Another common suggestion was discounts on public transport as it would make accessing places that do offer discounts easier and cheaper.

When directly asked about discounts at restaurants, shops and events 81.9% of respondents said that it would encourage them to consider getting a card.

Reasons for not renewing/ never having a Passport to Leisure and Learning card

Almost two fifths of respondents said that they hadn't renewed or had never had a Passport to Leisure and Learning Card because they were not eligible and a quarter said that they were not aware of it. When asked what their 'Other' reasons were, respondents reinforced that it was due to these reasons and that the card is too expensive to renew and the activities are too expensive.

2. Introduction and purpose

This report analyses the results of the Passport to Leisure and Learning Survey 2013. The purpose of the survey was designed to understand what local people think of the Passport to Leisure and Learning scheme and what they think would encourage more people to take up the scheme. The survey also sought to understand what local people think would improve the scheme so that more people can benefit from it.

3. Background and context

The Passport to Leisure and Learning scheme gives discounts on many leisure and learning activities across Coventry for adults and children. Adult residents and non-residents of the city qualify for a Passport to Leisure and Learning if they are:

- o over 16
- o claiming a qualifying benefit
- aged 16-19 years and still in full time education (with a parent still receiving child benefit for them, or on a work based Governmental Training)

Children are entitled to a Passport to Leisure and Learning if they are under the age of 16 and if one of their parents/carers qualify for one.

The Passport to Leisure and Learning offers reduced prices for a variety of activities at many venues across the city which includes:



4. Setting the scene

Obesity

The National Obesity Observatory estimates that 26% of Coventry adults are obese, compared to 24% for England. Childhood obesity is also slightly higher in the city with one in five children obese (20%), compared to 19% nationally.



Levels of adult obesity in the North, North East and East areas of Coventry are high, especially in Aldermoor & Ernesford Grange (32%), Bell Green (31.2%) and Wyken Green (29.5%) areas of the city.

Residents in the North East of the city are also more likely to be referred to health programmes, again highlighting higher incidence of health issues. 47% of all Active for Health referrals and 48% of all GP referrals are for North East city residents.

Deprivation

The map below shows the distribution of deprivation across the city.

Deprivation in the city is largely in the north east with some pockets in the south east and south west.


Binley and Willenhall, Henley and Wyken wards are areas of the city where residents are less likely to take part in regular physical activity, with 40%, 45% and 53% of respondents from the Household Survey stating they took part in any physical activity at least 3 times a week.


Active People Survey - Sports Strategy Key Findings

- 53.2% of the adult population do not do take part in any sport or physical activity lasting for 30 minutes or longer; this is above the national and regional equivalents and female inactivity (61.3%) is significantly higher than the equivalent male rate (45.0%).
- Age clearly plays a role and inactivity rates are highest amongst those aged 55+ (67.9%) and lowest for young adults aged16-25 (43.3%).
- Regular female activity (15.2%) is less than half the corresponding male rate (31.3%) which is itself much higher than the national (25.2%) and regional (23.8%) equivalents.
- The impact of age is most significant for regular participation, with rates amongst 16-25 year olds (32.2%) being noticeably higher (35-54 years 23.5%, 55+ years 14.7%).
- 6.3% of the city's adults are sports volunteers for at least one hour a week; 23.6% are members of a sports club; 15.5% receive sports tuition or coaching and 13.8% take part in organised sports competition(s).
- The top five sports are gym and keep fit, football, swimming, athletics and cycling.
- Further examination of the main sports, as might be anticipated, shows football to be a predominantly male activity with more than 9 in 10 participants being men. Conversely, just under 9 in 10 of those taking part in keep fit exercises and 6 in 10 swimmers are women, while 6 in 10 of those taking part in athletics and two thirds of cyclists are men.
- Similarly, three quarters of footballers are under the age of 35, relatively few 16-24 year olds do aerobics or keep fit and cycling, swimming and athletics are characterised by an even spread throughout the cohorts up to 64 years.
- Cycling and athletics can also be seen as 'doorstep' sports (start/finish at home);
 swimming and athletics can also be relatively inexpensive start-up sports.
- Swimming is the top participation sport, but does not fall in the top ten for TV or spectator sports. Conversely, motor racing is the second most popular TV sport (18.7%) but does not come into the top ten for participation
- Although the worst of the recession is thought to have passed, consumers remain cautious and continue to favour cheaper venues for, and means of, sport participation.
- More than half of adult participants spend less than £5 a week on playing, even at these prices, young people often struggle to afford to play as youth unemployment remains high and students and young earners are often under financial pressure.
- Although women make up just over half the UK population, they remain very much in the minority among the country's sports participants.
- Only one in eight women (2.76 million) play sport regularly, compared to one in five men (4.18 million) and the ratio drops to one in ten within disadvantaged communities.

- Ageing of the UK's population combined with an improved ability for older people to stay active is creating a new market for which time barriers and money are less of an issue.
- Sport England's small area participation estimates are modelled rather than directly
 measured proportions and combine a series of data sources, additional to Active
 People; these include health indicators and socio-economic status. The areas that
 they relate to have a minimum population of 5,000 and are most often around 7,200.

The pattern of participation shown in the two maps (see below) mirrors city's deprivation patterns with lower participation rates to be found in the north and east of the city and higher participation rates to the west and parts of the south.





5. Methodology

From 14 January to 17 March 2013 a survey was available online via the Council's website. A link to the survey was sent to members of a PTLL database and to the database of local people that have expressed an interest in taking part in consultations/surveys (potentially 647 email recipients). The survey was also shared on the Consultation pages of the Council's website, the Passport to Leisure and Learning webpage and on the Council's and Coventry Sports Foundation website. Paper copies of the survey were available to complete by hand which were then data inputted and added to the online responses. Paper surveys were available to complete at:

- All Adult Education buildings
- The Belgrade
- Warwick Arts Centre
- The six main sport and leisure centres in the city
- All city libraries

In addition to the above, an event was held in the city centre, with support from Sky Blues in the Community to encourage more people to complete the surveys

In total, there were 826 respondents to the Passport to Leisure and Learning Survey;

- 254 were completed paper copies
- 79 responses were from the Councils Corporate Contact Database
- 493 responses were from the Passport to Leisure email database and through the consultation tracker and or/ the Coventry Facebook page.

6. Main findings


6.1 Awareness and membership of the Passport to Leisure and Learning Card

Question 1 asked survey respondents if they were aware of Passport to Leisure and Learning scheme - 88.9% of respondents stated they were and 11.1% stated they were not.

N.B. Respondents who stated that they **were not** aware of Passport to Leisure and Learning by-passed questions 2 – 11 of the survey (90). Those that stated they were aware continued to question 2 (723 respondents).

Question 2 asked respondents to select how they had heard about the Passport to Leisure and Learning scheme. Respondents were able to select as many options as were relevant.






The most common ways of hearing about Passport to Leisure and Learning was through 'Word of Mouth' which accounted for just over a third of respondents (35.5%) and 28.8% of respondents who said they had heard about it 'at a leisure or learning site'.

Respondents who said that they had heard about it through an 'Other' method were asked to provide details, common answers included:





The most common 'Other' response was that respondents had previously had a Passport to Leisure and Learning or had known about it for many years (22 respondents), followed by the library and Coventry Carers Centre (11 and 8 respectively). There were 9 individual other sources mentioned by respondents, these included:

- Step Out/Choice
- The Jobcentre
- The Alzheimer's Society
- At a course where people had one
- Many years ago advertising
- Child carers
- Adequate publicity
- Ward Forum
- Trade Union back in the 1980s




6.2 Respondents who hold Passport to Leisure and Learning Cards

Question 3 sought to understand if survey respondents currently, previously or have never had a Passport to Leisure or Learning Card - only 39.4% said that they currently have one, 29.8% said they had one previously and 29.2% said they had never had one.

N.B. Respondents who selected '**No never**' or '**Not sure**' (217) bypassed questions 4 – 11 of the survey. Those that stated '**Yes currently**' or '**Yes previously**' (488) continued to question 4.

6.3 Discounts that encouraged getting a Passport to Leisure and Learning Card






Percentages do not add up to 100% as respondents were allowed to tick more than one option

Of the 459 of the 488 respondents that were able to respond to this question, the 'Sports and Parks' discount accounted for the highest number of respondents who said that that specific discount had encouraged them to get a Passport to Leisure and Learning Card (44.2%). The 'Sports and Parks' discount is not surprisingly then, the most used discount too (57.3%).

The 'Culture' discount accounted for the lowest number of respondents who said that that specific discount had encouraged them to get a Passport to Leisure and Learning Card (17.4%) and also accounted for the lowest number of respondents who actually use the 'Culture' discount (27.7%) – however, this is a still more than a quarter of respondents.

Respondents were also asked to state what other specific discounts had encouraged them to get a Passport to Leisure and Learning Card, commonly named discounts included:

Eleven respondents said that Educational courses were a particular discount that encouraged them to get a Passport to Leisure and Learning Card. A similar number of respondents said that cheaper gym membership or discounts at leisure centres also encouraged them to get a card (10 respondents).

In terms of specific discounts that were mentioned once by respondents, Guitar lessons, help towards car parking costs, and Carer Support were also noted as discounts that encouraged them to get the card.



6.4 Types of Passport to Leisure and Learning Cards held

Question 5 asked respondents to state what type of Passport to Leisure and Learning card they held. Out of the 474 respondents that answered this question, 85.4% stated that they have/ had an adult card, 4.2% have/ had a junior card and 10.3% have/ had both cards.

6.5 Qualification for the Passport to Leisure and Learning Card

Question 6 asked how respondents had qualified for the card and were able to select as many options that were applicable to them.




Percentages do not add up to 100% as respondents were able to tick more than one option

The most common response (57.5%) was that respondents were 'In receipt of either a means tested or Disability benefit'. A fifth (20.6%) said that they qualified for 'Other' reasons.

Other reasons allowing respondents to qualify for the card




The most common 'Other' response for qualifying for the Passport to Leisure and Learning Card was due to being a 'Carer' (19 respondents), followed by respondents who said that they were claimants of 'Working Tax Credit' (17) and 'Jobseekers Allowance/ unemployed' (16). 

Question 7 asked respondents to state where they had signed up for the Passport to Leisure and Learning Scheme.






Over half of respondents said that they signed up for the scheme at their 'Local Post Office'. This is followed by just over a fifth of respondents (22.3%) who said that they had signed up at one of the City's Sports Centres. Civic Centre 1 or 2 received 3.4% of sign ups.



Question 8 sought to understand how frequently respondents used the scheme to get a discounts – the chart on the next page provides details.






Just under a third of respondents said that they use/used the Passport to Leisure and Learning Scheme once or twice a week to get a discount (30.9%), followed by a quarter who said that they use/ used it once or twice a month. 1.7% of respondents said that they never use it.

6.8 Satisfaction rates of aspects of the Passport to Leisure and Learning Scheme

A breakdown of the responses to question 9 regarding how satisfied respondents were with different aspects of the Passport to Leisure and Learning Scheme is detailed below:

How would you rate the following aspects of the Passport to Leisure and Learning Scheme?




Across all aspects of the Passport to Leisure and Learning Scheme, respondents were more likely to be satisfied than dissatisfied, especially concerning 'Value for money' (in terms of the cost of the card (82.4%), 'Range of discounts' (80.7%) and 'Information about discounts' (80.2%). 'Value for money - level of discount' received the highest level of dissatisfaction and the lowest level of satisfaction.

6.9 Suggestions for improving the scheme

Question 10 of the survey asked for respondents to provide suggestions on how the scheme can be improved. There were a total of 299 responses. Common suggestions included:

Suggestions on how to improve the scheme



There was a strong feeling amongst respondents that there is not enough advertising/ promotion of the scheme or where discounts are available. Therefore, almost a third of all suggestions related to better and improved advertising. Respondents also suggested that discounts should be offered at more places/ venues in and outside of the city.

Another key suggestion was to improve the renewal and signing up processes. A number of respondents said that these processes are very long, complicated and are bureaucratic. In addition a number of comments were made in relation to the perceived excessive amount of ID that is required for the registration process. Respondents also said that they would appreciate a reminder alert to inform them that their membership is due to expire and that the membership should last longer than a year. It would also be helpful if the registration process could be completed online.

Inevitably, a number of suggestions related to more and better discount (34 respondents) and that the eligibility criteria for the scheme should be expanded – especially to people that do not claim benefits (27 respondents).


Some respondents did not feel that they could offer any suggestions on how to improve the scheme (17 respondents), however some of their comments included:


- "I think its a fantastic scheme"

6.10 Other discounts that respondents would like to see as part of the scheme

Question 11 asked survey respondents to provide suggestions on any organisations that they would like to see offering discounts. The chart on the next page details their responses.

Discounts for the cinema and theatre were the most commonly mentioned places that respondents felt discounts should be offered. This was followed by restaurants/ food and drink outlets and supermarkets. Discounts on public transport were also mentioned by numerous respondents and discounts at gyms and other leisure/sports facilities.

There were 25 specific suggestions mentioned by respondents that were wide ranging. An example of the wide range of specific suggestions includes discounts at:

- "Dentists."
- "Broadband"
- "Gas and Elec bills"
- "Online-film-rentals, such as Netflix, LoveFilm"
- "an accredited taxi firm"



6.11 Reasons for never having/ not renewing their Passport to Leisure and Learning card

N.B. Question 12 – 16 required responses from non-users of the Passport to Leisured Learning card only (427 respondents)

However, a total of 279 survey respondents actually provided a response to this question which sought to understand the reasons why respondents who previously had a Passport to Leisure and Learning card had not renewed it and why some respondents had never had one at all. A list of reasons was provided to select from and respondents were able to select as many that applied.


If you have never had a Passport to Leisure and Learning or have previously had one and didn't renew it please explain

Of the 279 respondents that provided an answer to question 12, almost two fifths stated that it was because they were 'No longer eligible'. A third said that it was due to 'Other' reasons. Encouragingly, only 6.7% and 5.6% said that it was due to 'Not Value for money' or due to the 'Proximity to services and travel costs' respectively. Common 'Other' reasons are detailed on the next page.


6.13 considerations for getting a Passport to Leisure Card

Would you consider getting a Passport to Learning and Leisure card if it enabled you to access discounts at...





Encouragingly more than three quarters of respondents said that the offer of both discounts would make them consider getting a Passport to Leisure and Learning Card. Between 12.7% and 15.5% of respondents said that they were not sure. Fewer than 7.7% of respondents said that neither discount offers would encourage them to get a card.

6.14 Communication methods

All 826 respondents were able to answer question 16 which asked respondents what devices/ websites/ other communication methods they used.

Which of the following do you use?



8.Conclusions

The next phase of work should include:

- Implementation of a new database and administration process (including application and renewal process)
- Consideration of eligibility of the scheme with particular reference to over 60s concession, families and new benefit changes
- Pricing strategy for PTLL card scheme to be reviewed, for renewals and first time applications to make the scheme more accessible.
- Issuing venues to be rationalised, and in-house Council issuing service to be investigated
- Development of a marketing and rebranding strategy (to include targeted marketing to areas of the city with highest deprivation, obesity & residents on means tested benefits)
- Consideration of other discount/concessionary schemes and any options for integrating with PTLL
- PTLL being expanded to attractions outside the city
- Access to concessionary public transport for PTLL card holders to be investigated with providers
- New concession providers (including city centre offer, restaurants, cinemas etc)

9. Recommendations

- A range of communication and advertising/ promotional methods are required in order to raise awareness of the scheme. These need to be of a traditional nature such as; posters, leaflets and newspaper adverts and of a modern nature such as; social media, apps for Smartphones, the internet and via emails
- Discounts that form part of the scheme needs to be extended to outside of the city and more organisations should be on board the scheme that can offer discounts.
 Better/ cheaper discounts are also required
- The scheme should be made available to people who receive a pension and or are pensioners/ senior citizens
- In terms of eligibility for the scheme, the criteria needs to be expanded so that it is not restricted only to people on benefits.
- The introduction of a family card this would dramatically reduce the expenses incurred for all family members to have a card
- The membership should be longer than one year. It is too expensive to keep renewing memberships and having to have new photographs printed
- The application and renewal process should be made easier, require less identification and should be able to register online

Scoping area of work

1. Briefly describe the area of work this analysis relates to:

The Passport to Leisure and Learning (PTLL) scheme is a concession scheme primarily for Coventry residents who are eligible for a means tested benefit. The aim of the scheme is to increase accessibility and encourage participation in learning and leisure opportunities across the Coventry.

The current take up of the PTLL scheme is extremely low, with only 1,548 cards in circulation and valid. Consultation on the PTLL scheme, which took place in 2013 indicated that the current application and renewal system is expensive, outdated and bureaucratic. The process involves completing a lengthy manual application/renewal form and providing suitable identification alongside eligibility/benefit verification.


The Council cannot currently quantify how many residents in the city would be eligible for the PTLL scheme, due to Data protection rules within the Department of Works and Pensions (DWP).

There are 34,607 homes in the city that are in receipt of either a Housing Benefit or Council Tax Support payment via the Council's internal Benefits and Revenues team. Housing Tax benefit and Council Tax Support that meet the eligibility criteria for PTLL scheme. The Council are recommending targeting these 34,607 homes as part of a re-launch of the scheme.

Coventry residents on other qualifying benefits which are registered with the DWP will be able to apply for the PTLL card through an online application process.

Summary of Data

Current uptake of the PTTL card is very low, with 1500 cards currently in use, the total eligible population in Coventry is estimated at around 70,000 residents.

Housing Benefit or Council Tax Support data provided by the Council's internal Benefits and Revenues team has identified 36,000 homes that would meet the qualifying criteria for the PTLL scheme. All of the remaining qualifying benefits are

managed by the Department for Work and Pensions (DWP), due to data protection the Council cannot access information on which residents are claiming any means tested benefit managed by DWP.

The current application process for eligible residents requires the completion of a printed application form, proof of eligibility, photographic identification document and a passport style photo that is included on the PTLL card for identification purposes.

The current charge for a PTLL card is £5.20 for an adult and £2.60 for a child. Non-residents can apply for a card the same eligibility criteria apply but charges increase to £16.30 for an adult and £8.15 for a child.

Increased take up is unlikely to happen, nothing changes for protected or vulnerable groups, and the status quo is maintained.

Option two – on-line application process

There is likely to be some increased take up of the scheme by protected and vulnerable groups.

• Option three – directly sending cards to those eligible where possible with related focussed promotion

It is expected that this will see the highest increase in take up of the scheme. Results of the consultation suggested that eligible people are put off by the application process, initial cost and yearly renewal. By sending the card free of charge to those eligible these barriers are greatly reduced.

There are no perceived negative impacts through the proposed option (option three).



17. What are the key findings of the consultation?

- In terms of the specific discounts that respondents said encouraged them to get a Passport to Leisure and Learning Card, the Sports and Parks discounts received the highest response – it is also the most used discount, followed by Adult Education related discounts. Culture discounts proved to be the least encouraging and are also the least used; however, they are still used by over 1 in 4 respondents.
- Almost a third of respondents said they use their card once or twice a week to claim a discount and a quarter said they use it this amount per month. A very low number said they never use it (1.7%).
- There was a very clear message that the PTLL scheme is not well advertised and a number of advertising/ promotional methods were suggested including; posters, leaflets, newspaper adverts and email alerts.
- There was particular reference to the signing up and renewal processes in that they are too long, complicated and bureaucratic. It was also mentioned that too much paper work is required as suitable identification. Respondents also expressed their dissatisfaction with the fact that the PTLL only lasts a year and that it is too expensive to keep renewing it and the costs to update the required photographs. Respondents suggested a reminder system so that members are alerted to the fact that their card is due to expire. This was a contributing factor to the high level of respondents that said they didn't have a card (59.0%).
- It was also suggested that the eligibility criteria for the scheme is extended so that not just people on benefits are entitled to it. A number of respondents suggested that over 60s should be included in the eligibility criteria.
- Almost two fifths of respondents said that they hadn't renewed or had never had a Passport to Leisure and Learning Card because they were not eligible and a quarter said that they were not aware of it. When asked what their 'Other' reasons were, respondents reinforced that it was due to these reasons and that the card is too expensive to renew and the activities are too expensive.
