- 1. Create a foundation to drive improved access to services through better use of equalities data.
- 2. Develop better understanding of our diverse communities in order to shape and deliver the Council's Integration policy and practice for the City and its residents.
- 3. To increase year on year the percentage of applications for employment received and appointments made to candidates who are either LGBT+, declare a disability or are from Black, Asian and Minority Ethnic backgrounds.
- 4. Increase the effective delivery of Council Services in key areas.
- 5. Increase participation from residents and visitors with disabilities in sporting and cultural activities in the city.

Consultation on these proposed Equality Objectives ran from 1<sup>st</sup> November to 6<sup>th</sup> December 2021. The outcome of the consultation was summarised within the report and would be fed into the development of action plans for each Equality Objective.

#### **Executive Summary:**

This report responds to a petition submitted by Councillor Male, a Woodlands Ward Councillor, bearing 324 signatures which requests the Council to allocate sufficient funding to provide a tarmac path around the outside edge of the Ponderosa in Tile Hill

The petition reads:

"We the undersigned petition the Council to allocate sufficient funding to provide a tarmac path around the outside edge of the Ponderosa in Tile Hill".

The petition goes onto provide the following justification:

"The Ponderosa is an under utilised outdoor amenity in Tile Hill, bordering Mount Nod. The addition of a tarmac path around its outer edge would significantly improve access for the local community and encourage greater use of the field for exercise and outdoor activity. A path would also allow wheelchair users and those with pushchairs greater access to this great outdoor space".

This petition relates to an area of land known as the Ponderosa which lies adjacent to Jardine Crescent in Tile Hill. The site is approximately 38,012 square metres or 3.81 hectares in size and contains several football pitches and an associated changing rooms. The changing rooms are leased to Mount Nod FC who use the pitches as their home ground.

The cost of installing a tarmac path along the outer edge of the open space would cost approximately £130,000 to complete. The Parks Service does not have the existing resources to undertake this proposal.

#### Recommendations:

The Cabinet Member for Policing and Equalities is recommended to:

- 1. Consider the content of the petition and note the concerns of the petitioners'
- 2. Note that there is insufficient funding for a new tarmac footpath to be provided from the existing Park Service budgets.

# Report title: Petition - . Provision of a tarmac path around the outside edge of the Ponderosa, off Jardine Crescent, Tile Hill Context (or background)

- 1.1. This petition relates to an area of land known locally as The Ponderosa or more formally as Jardine Crescent Sports Ground, which lies off Jardine Crescent in Tile Hill. The site is approximately 3.81 hectares in size. It contains several football pitches and associated changing rooms which are leased to Mount Nod FC who use the pitches as their home ground.
- 1.2. It is recognised that the Jardine Crescent Sports Ground is an important area of open space and very much valued and well used by the local community.
- 1.3. The creation of a peripheral footpath has been considered. Creating a self-bound gravel footpath (with timber edging boards) would cost approximately £77,760 £97,200. A Tarmac path would be significantly more expensive at approximately £130,000 to complete. The Parks Service does not have the existing resources to undertake this proposal.
- 1.4. The Councils Park Service recognise the importance of installating good footpath networks in its green spaces, particularly peripheral footpaths which do much to encourage greater access and use of open spaces as has been recognised.
- 1.5. The creation of a new footpaths in the park will continue to be considered, if and when funds are made available. We will continue to explore and exploit all funding opportunity both external and internal to provide footpaths

#### 2. Options considered and recommended proposal

2.1 The option to do nothing has been considered and we will continue to explore and exploit all funding opportunity both external and internal to provide footpaths

#### **Executive Summary:**

There is currently a Public Spaces Protection Order (PSPO) in place for the environs of Edgwick Park that is due to expire in April 2022. This was introduced to address anti-social behaviour and crime concerns at the location.

It is requested that this order be continued for a further three years to 2025, to allow park users and the local community to benefit from the facilities of the park, without suffering the issues that blighted the park previously.

Contained within this report are impact statements from key partner agencies supporting the extension of the existing PSPO, under the Anti-Social Behaviour, Crime and Policing Act 2014.

#### **Recommendations:**

The Cabinet Member is recommended to:-

- (1) Note the attached impact statements from key agencies and their rationale for extending the existing order.
- (2) Approve that the order should be extended for a period of three years from the date the current order is due to expire.
- (3) Request that all partner agencies continue their current actions and patrol plans and also monitor the surrounding areas for any potential displacement of the issue.

#### Report title: Proposed Public Space Protection Order for Edgwick Park

#### 1. Context (or background)

- 1.1 Edgwick Park is a relatively small park located in the Foleshill ward. It is bounded by the Foleshill Rd, Eld Road and Cross Road. There is also a primary school, Edgwick Community Primary School located within the park. The park has a children's play area and the park itself is particularly intended to be a community park where families with children will come to use the facilities.
- 1.2 Historically, groups of males have been congregating in the park, drinking alcohol and socialising. Partnership intelligence reports identified that there were groups of young people, particularly girls that were attracted to the park to access alcohol from these same groups of males. There were concerns that this was resulting in sexual exploitation
- 1.3 As a result of these concerns a Public Spaces Protection Order (PSPO) was created in 2019 to address these concerning behaviours and to try to give ownership and usage of the park back to the local community.
- 1.4 Community safety partnership resources have subsequently been focused on this area. Police patrols in the park were increased along with dedicated youth workers. In addition, considerable landscaping works have been made to the park to improve visibility for patrolling officers.
- 1.5 On the whole, the order has operated successfully. It has not eradicated issues within the park, but what it has meant is that when officers attend the park, they can disrupt groups quickly and easily, which was not the case prior to the order.
- 1.6 In recent times, Edgwick Park was identified by Police officers specialising in gang concerns as allocation where known gang nominals were congregating. Concerns were such that Edgwick Park was one of a limited number of named locations within injunctions served on a significant number of individuals. We believe this is a significant recent development that lends weight to the need to extend the existing PSPO

#### 2 Options considered and recommended proposal

- 2.1 Do nothing (not recommended). The potential seriousness of the situation is such that the Council and its partners should look to utilise all available tools to address known issues.
- 2.2 Renew the PSPO for Edgwick Park (recommended) for a period of three years. Whilst the Police already have powers to deal with anti-social behaviour, the renewal of the PSPO would be useful to Police officers in managing situations that could potentially escalate. The Council consulted on the introduction of this power previously upon its initial introduction and it was universally supported.
- 2.3 A PSPO allows for restrictions to be placed with a defined area, it can prohibit certain activities or gatherings of groups if they can be shown to be problematic and the PSPO is believed to be proportionate to address the problematic behaviour. An offence committed under a PSPO is when someone fails to comply with an instruction from a Police or Council officer. In this example that instruction would be for a group of individuals to leave the park if their behaviour was felt to be, or potentially to be, inappropriate.

- 2.4 The amount of the Fixed Penalty Notice (FPN) for non-compliance with a PSPO will be set at £100 and reduced to £60 if paid within 14 days; this would be in line with the other PSPO in force in the City for controlling dogs. Where fixed penalties are not paid, the Police would have the option of prosecuting offenders.
- 2.2 Recommendations. Cabinet Member is recommended to:
  - (1) Note the supporting witness impact statements and their rationale for extending the existing order.
  - (2) Approve that the order should be extended for a period of three years upon expiry of the existing order
  - (3) Request that all partner agencies continue their current actions and patrol plans and also monitor the surrounding areas for any potential displacement of the issue.

#### 3 Results of consultation undertaken

- 3.1 A public consultation was conducted in 2016 for the creation of this order. A full public consultation is not required for a renewal.
- 3.2 Impact statements were also obtained from key partners in relation to the park and activities and concerns. These statements can be found in appendix 2.

#### 4 Timetable for implementing this decision

- 4.1 If the Cabinet Member decides to renew the existing PSPO, the Order will be published on the Council's website and it will come into force just prior to expiry of the existing order. Existing signage is already present in the park.
- 4.2 Patrols and patrol plans are already in place for the location and will be continuing. The order will be valid for a period of three years and can be extended or amended, providing due process is followed.
- 5 Comments from the Chief Operating Officer (Section 151 Officer) and the Director of Law and Governance
- 5.1 **Financial implications**. No additional resource will be required to implement the proposed PSPO. Any additional income generated by the introduction of a PSPO will contribute towards Council resources.
- 5.2 **Legal implications.** Under sections 59-75 of the Anti-social Behaviour, Crime and Policing Act 2104, Local Authorities have powers to make PSPOs. PSPOs can only apply to public places.
- 5.3 The Council is entitled to extend the existing PSPO under the Anti-Social Behaviour, Crime and Policing Act 2014 to prohibit congregations, or specific behaviours within the park. The wording of the proposed PSPO is attached at Appendix One. The extension is supported by impact statements from key partners as attached at Appendix Two. Breach of such an Order can result in a person being issued with a FPN up to the value of £100. Should someone continually breach the PSPO, or if the breach is felt to be serious enough, then

the matter could be referred to court where an increased fine of up to £1000, or custodial sentence could be imposed

5.4 This means any place to which the public, or and sections of the public, on payment or otherwise, have access to as of right or by virtue of express or implied permission. Enforcement Officers can issue a Fixed Penalty Notice in respect of a breach of a PSPO. It is a criminal offence to do anything without reasonable excuse which is prohibited under a PSPO or failure to comply with a requirement of a PSPO. Such an offence is punishable by a fine of up to £1000 on prosecution.

#### Appendix 1 - Draft Order

# COVENTRY CITY COUNCIL PUBLIC SPACES PROTECTION ORDER EDGWICK PARK ANTI-SOCIAL BEHAVIOUR

The Council of the City of Coventry ("the Council") hereby makes the following Public Spaces Protection Order (Edgwick Park Anti-Social Behaviour) under Sections 59 to 75 of the Anti-social Behaviour, Crime and Policing Act 2014.

- 1. This Order shall come into operation on 29<sup>th</sup> April 2022 and shall have effect for a period of 3 years thereafter, unless extended by further orders under the Council's statutory powers.
- 2. This Order relates to Edgwick Park and the bordering streets ("the Designated Area") as shown edged in red on the attached plan.
- 3. The purpose of this order is to prevent any activities associated with Child Exploitation of any type and anti-social behaviour in the Designated Area including but not limited to fighting, drinking alcohol, drug taking and dealing, urinating and littering. The Council makes this Order because it is satisfied on reasonable grounds that groups of people within the Designated Area are and have carried out anti-social activities. These activities are persistent and continuing and have resulted in members of the community feeling intimidated and unsafe.
- 4. The effect of this Order is to prohibit the congregation of groups of 2 or more persons in the Designated Area where the behaviour of some or all members of the group has or is likely to have a detrimental effect on the quality of life of those in the community



#### **Appendix 2 – Impact Statements**

#### <u>Impact Statement – WMP (Gangs)</u>

My name is Paul Southern, I am a Chief Inspector that is responsible for, amongst other things, coordinating Coventry's approach to gangs in the City.

This has seen in recent years, significant incidents of public place violence that has resulted in murders and life changing injuries. Fortunately we have recently seen a downwards trend in those incidents and we intend to build upon that as violence specifically relating to young people aged under 25 years old is a priority.

One recent success we have had in the City was to issue approximately 30 injunctions on known gang nominals to limit their associations with other known gang nominals and away from key locations we felt would best limit their activities and protect the wider public.

Edgwick Park is a named location within those injunctions. Intelligence showed that it was somewhere where gang nominals met and associated.

We would support the extension of the existing Public Places Protection Order (PSPO) for the park. Any powers that can better control any groups that may congregate in the park and allow Police officers to disperse those thought to be acting in a manner not beneficial to the local community, is something that we would welcome. This would support our other activity in the park which includes weapon sweeps which are regularly carried out in the park and has resulted in the recovery of knives and other offensive weapons that are secreted in areas of the park to facilitate criminal activity such as robbery and violence.

#### <u>Impact Statement – WMP (Neighbourhoods)</u>

My Name is PC Nicholas Mansell I am the Civil interventions coordinator and Anti-Social Behaviour lead officer for Coventry. As part of my role I regularly work with neighbourhood teams throughout the city to address matters of Crime and Anti-Social Behaviour.

Edgwick Park is a location I am very familiar with. A number of years ago it was featuring very highly in terms of being a priority location for the Police where many incidents and concerns were being raised.

This was largely based upon large groups of males congregating and drinking alcohol as well as associated issues of Child Sexual Exploitation which saw some reports of serious sexual assault associated with the location.

Because of this, we were very supportive of the creation of the original Public Spaces Protection Order (PSPO). Since it's introduction we have seen a marked improvement at the park. The number of reports we receive has decreased significantly and local officers report that having the available powers the order gives them, to disperse problem groups in the park, allows them to make much better use of their time and offers reassurance to other park users.

Even though we have witnessed a marked improvement, there are still significant challenges that we need to address in the location. From recent history we are still seeing fights, some that include weapons, drug related activity and gang related crime.

Should the order expire, our concern would be that dealing with problematic groups at the park would become far more time and resource intensive and would result in park users and the local community being less likely to visit the park, which could see a return to the position we were in before the introduction of the order.

As such, I would like to formally support the extension of the PSPO at Edgwick Park.

#### <u>Impact Statement – Parks Service</u>

My name is Graham Hood and I am the head of Streetpride and Greenspaces and as such I am responsible for the management of the parks in Coventry.

Edgwick Park is a location I am very familiar with. A number of years ago we regularly received complaints from park users about large groups of drinkers that congregated in the park. This discouraged many park users, with parents saying they would not allow their children to use the park and community groups reluctant to hold events.

We supported the introduction of the current Public Spaces Protection Order (PSPO) and since it has gone live we have experienced a marked improvement in the management of the park, and the use of the park by the local community. The order hasn't eliminated all issues in the park, but it has significantly decreased them and if there are issues officers can use the order to quickly move people on.

I support the extension of the current order as I believe the underlying issues haven't entirely gone away and to allow the order to expire would be to the detriment of the park, it's users and the wider community.
