In noting that vaping was not covered by smoke free legislation, the Chair asked that officers write to the Cabinet Member for Public Health and Sport expressing the Committee's wish that the use of e-cigarettes be reviewed by the Cabinet Member from a public health perspective.

**RESOLVED that the Committee request that the Cabinet Member for Public Health and Sport review and bring forward a policy on the safety and use of e-cigarettes (vaping) in the workplace.**
