3. Minutes

The Minutes of the meeting held on 20 November 2023 were agreed and signed as a true record.

4. Complaints to the Local Government and Social Care Ombudsman 2023/24

The Cabinet Member for Policy and Leadership considered a report of the Chief Executive, that would also be considered at the meeting of Ethics Committee on 9th January 2025 and the meeting of Audit and Procurement Committee on 29th January 2025, which set out the number, trends and outcomes of complaints to the LGSCO relating to Coventry City Council in 2023/24. It focused on upheld complaints, compliance with Ombudsman's recommendations, where the Council had provided a satisfactory remedy before the complaint reached the LGSCO, and how the Authority compared to previous years and other local authorities.

Local Government and Social Care Ombudsman (LGSCO) was the final stage for complaints about Councils, all adult social care providers (including care homes and home care agencies) and some other organisations providing local public services. It was a free service that investigated complaints in a fair and independent way and provided a means of redress to individuals for injustice caused by unfair treatment or service failure.

Coventry City Council's Complaints Policy sets out how individual members of the public could complain to the Council, as well as how the Council would handle

their compliments, comments and complaints. The Council also informed individuals of their rights to contact the LGSCO if they were not happy with the Council's decision once they had exhausted the Council's complaints process.

The LGSCO issued an annual letter to the Leader and Chief Executive of every Council, summarising the number and trends of complaints dealt with relating to that Council that year. The latest letter, issued 17 July 2024, covered complaints to the LGSCO relating to Coventry City Council between April 2023 and March 2024 (2023/24).

RESOLVED that the Cabinet Member for Policy and Leadership:

- 1. Notes the Council's performance in relation to complaints to the LGSCO.
- 2. Notes the Council's complaints process and guidance.
- 3. Requests that the Audit and Procurement Committee review and be assured that the Council takes appropriate action in response to complaints investigated and where the Council is found to be at fault.

The Coventry Award of Merit was established by the City Council in the 1960s as a means of acknowledging and honouring personal behaviour reflecting the highest ideals of citizenship or outstanding performance in any field of human endeavour which enhances the good name of Coventry and affords inspiration to its citizens. The grant of the Award of Merit is made by full Council on the recommendation of the Cabinet Member, who is advised by an Advisory Panel established for the purpose. Report title: Nominations for the Coventry Award of Merit

1. Context (or background)

- 1.1 The Coventry Award of Merit was established by the City Council in the 1960s as a means of acknowledging and honouring personal behaviour reflecting the highest ideals of citizenship or outstanding performance in any field of human endeavour which enhances the good name of Coventry and affords inspiration to its citizens.
- 1.2 Any person, company or other organisation shall be eligible for consideration for the Coventry Award of Merit who has:-
 - Rendered outstanding service to the City of Coventry in service to the local community.
 - By outstanding personal effort in the field of sport, industry, government or the arts, brought particular renown to the City of Coventry.
 - Made an outstanding contribution to the national life or in international affairs in any field of human activity in a manner which has brought credit upon the City of Coventry.
 - By personal example of courage or devotion to duty and service to others, demonstrated the highest ideals of citizenship.
- 1.3 The Award has previously taken the form of a citation under the common seal together with a presentation of a gold medallion pendant from a ribbon in the City's colours. The motif on the medallion is the phoenix, symbolising the resurgence of Coventry from the flames of the Blitz. Appendix 1 to the report details the Terms of Reference for the Award and Appendix 2 details the list of former recipients.
- 1.4 The Advisory Panel is made up of the following members:
 - Cabinet Member for Policy and Leadership, Councillor G Duggins (Chair)
 - Cabinet Member for Strategic Finance and Resources, Councillor R Brown
 - Shadow Cabinet Member for Policing and Equalities, Councillor J Lepoidevin
 - Chair of Scrutiny Co-ordination Committee, Councillor G Lloyd
 - The Lord Mayor, ex officio, Councillor M Mutton
 - The Council's Honorary Recorder, His Honour Judge A Lockhart KC
- 1.5 The Advisory Panel will meet on 13 March, 2025 to advise the Cabinet Member for Policy and Leadership on possible recipients of the Award.
- 1.6 The Cabinet Member for Policy and Leadership will consider the advice from the Advisory Panel and make recommendations to Council for approval at the Council meeting on 25 March, 2025.
- 1.7 Where the Cabinet Member is minded to accept the Advisory Panel's advice he will consult the proposed recipients of the Award prior to presenting proposals for approval to full Council on 25 March, 2025. It is recommended that pending such consultation, the nominations should remain confidential.

2. Options considered and recommended proposal

2.1 The Cabinet Member is recommended to consider the advice from the meeting of the Coventry Award of Merit Advisory Panel held on 13 March, 2025 and to make recommendations to Council accordingly.

The Coventry Award of Merit Advisory Panel

Terms of Reference

- 1. The object of the Coventry Award of Merit shall be to publicly acknowledge and honour behaviour reflecting the highest ideals of citizenship or outstanding performance in any worthy field of human endeavour which enhances the good name of the City of Coventry and affords inspiration to its citizens.
- 2. Any person, company or other organisation shall be eligible for consideration for the Coventry Award of Merit who has:-
 - 2.1 Rendered outstanding service to the City of Coventry in service to the local community.
 - 2.2 By outstanding personal effort in the field of sport, industry, government or the arts, brought particular renown to the City of Coventry.
 - 2.3 Made an outstanding contribution to the national life or in international affairs in any field of human activity in a manner which has brought credit upon the City of Coventry.
 - 2.4 By personal example of courage or devotion to duty and service to others, demonstrated the highest ideals of citizenship.
- 3. The grant of the Award of Merit shall be made by the City Council on the recommendation of Cabinet Member for Policing and Equalities, who will be advised by an Advisory Panel established for the purpose.
- 4. The Cabinet Member and Advisory Panel shall endeavour to maintain consistently high standards in the submission of recommendations and accordingly shall be at liberty to make such further enquiry into a nomination as they think proper, and shall be under no obligation to submit any recommendation unless they are satisfied that in doing so such standards would be maintained.
- 5. Any individual or organisation (including any member of the panel of Assessors) may submit a nomination for the Award of Merit. Any such nomination shall be in writing and submitted to the Deputy Chief Executive (Place), with a detailed statement of the grounds on which it is made.
- 6. The Award of Merit shall take such form as the City Council may from time to time determine but shall include a Citation signed by the Lord Mayor for the time being stating the grounds on which the Award has been made. Awards shall be made by the Lord Mayor at a public ceremony.
