#### **Public Business**

#### 39. **Declarations of Interest**

There were no declarations of interest.

#### 40. Minutes

The minutes of the meeting held on 9<sup>th</sup> October, 2013 were signed as a true record. There were no matters arising.

#### 41. Strategic Built Environment Group

The Committee considered a briefing note and received a presentation from the Head of Environmental Services concerning the Strategic Built Environment Group which was set up following a decision of the Cabinet Member (Community Safety and Equalities). The terms of reference including membership was set out at an appendix.

The Group was established to facilitate closer working of the Council's various regulatory activities and was chaired by Sara Roach, Deputy Director, Strategy and Communities. The Group had been meeting on a monthly basis since March, 2013 and their work focused on 'problem properties' or issues which, in most cases, had previously proved difficult to resolve by one department working alone, and cut across professional disciplines. A second appendix detailed the past and current work of the Group.

The presentation provided details of two case studies and the actions undertaken by the Group. The first involved a block of flats. The company owning the freehold went into liquidation whereupon title to the land passed to the Crown, who has legal immunity so enforcement action could not be taken. The external fabric of the flats, the common parts, and the external yard and garages were in a poor state of repair and suffered from fly-tipping and dog foul. The second case related to an empty semi-detached property which was fire damaged and derelict and suffered from fly-tipping and anti-social behaviour complaints. The previous owner died intestate and potential beneficiaries of the estate were not interested.

Members questioned the officers on a number of issues including:-

- The potential to take action against the Crown and was this an issue affecting other Local Authorities
- The potential for tenants who owned the leases to the flats to establish a management company
- The suggestion to raise concerns regarding crown owned land with the local MPs and the Local Government Association
- Details about the number of enforcement officers at the City Council
- The numbers of and options for dealing with empty properties in the city including compulsory purchase
- How issues were picked up by the Group and their impact on improved working relationships across the Council.

#### **RESOLVED** that:

- (i) Officers work with other Local Authorities to identify common concerns in relation to crown owned properties and how this can be pursued nationally through the Local Government Association and the local MPs.
- (ii) Officers review best practice to understand how other Local Authorities deal quickly and successfully with problem properties.
- (iii) Officers review the number of Council owned properties that are causing nuisance.

(iv) Officers review the opportunities and costs of using Compulsory Purchase Orders to deal with problem properties when other options have been exhausted, included the costs of not taking action.

#### 42. Commissioning of Domestic Violence and Abuse Services

The Committee considered a report and presentation of the Executive Director, People on the new service model for the commissioning of Domestic Violence and Abuse (DVA) Services. The report was also to be considered by Cabinet at their meeting on 19th November, 2013. Councillor Duggins, Cabinet Member (Children and Young People) and Councillor Lucas, Cabinet Member (Policy and Leadership) attended the meeting for the consideration of this item. Juliet Hancox, Coventry and Rugby Clinical Commissioning Group and DC Kim Madill, West Midlands Police also attended for this matter.

The report provided an update on the outcome of the extensive review of the statutory and commissioned services involved with DVA and detailed the steps needed to progress the new proposed service model. The proposed new service had been created as part of an integrated multi-agency model which would provide DVA services seeking to ensure a clear first point of contact, prevent duplication and strengthen information sharing. This would include a helpline and interactive website, a single point of access to victim services, a range of accommodation for victims, an aftercare service for victims, a new solution focused programme to work with perpetrators and a children's support service.

The Council currently commissioned nine separate services across five providers and existing contracts had been extended to enable time to design the new model/service. A number of research projects, consultation events and focus groups were undertaken between 2011 and 2013 with providers, referring agencies and service users, in order to assess need and identify gaps in current provision. The findings had been used to develop the specifications for the proposed service to be commissioned within the model, however the final consultation phase for the children's element was still to be concluded.

The Committee questioned the officers and representatives on a number of issues including:-

- the processes undertaken and the timescales involved to date in developing the proposed new service model
- how effectively partner agencies were working together to tackle domestic violence and abuse
- the robustness of information sharing arrangements between organisations
- resources and capacity to meet needs
- how risk would be managed in the new service model to help prioritise activity
- assurance that the voice of the child would be heard in all cases where children were involved
- how service users were involved in the development of services.

The Committee recognised that domestic violence and abuse had wide ranging implications including crime, community safety, protection, safeguarding, health and well-being. A range of organisations and partnerships had responsibilities for action and managing performance and the Committee were keen to understand how these organisations worked together to ensure an overview of all related issues was taken and how responsibility and accountability was managed effectively. In the light of their discussions they suggested that the Health and Well-being Board could adopt Domestic Violence and Abuse as a key priority and hold partners to account for the response of statutory services.

RESOLVED that Cabinet be asked to consider and decide whether to agree the following recommendation: 'That the Health and Well-being Board be requested to adopt Domestic Violence and Abuse as a key priority and hold partners to account for the response of statutory services both in terms of early identification/intervention and response'.

# **Briefing note**

#### To: Scrutiny Co-ordination Committee

#### Subject: Welfare Reform

#### 1 Purpose

- 1.1 The Scrutiny Co-ordination Committee meeting has dedicated the whole of its on 11<sup>th</sup> December meeting to consider issues relating to the government's Welfare Reform agenda. The purpose of the meeting is to review:
  - the latest information on the implications of the Welfare Reform changes on local people, communities and the city;
  - the way services and support to local people are being co-ordinated in the city; and
  - the impact on the City Council and how the authority is discharging its responsibilities.

#### 2 Recommendations

2.1 Scrutiny Co-ordination Committee is recommended to review the current position and actions being taken in response to the government's Welfare Reform agenda and make any recommendations to Cabinet, Cabinet Members, partners or others as appropriate.

#### 3 Information/Background

- 3.1 The government has introduced an unprecedented level of change in welfare reform to which the Council and partners are responding. A set of background information to support presentations, questions and discussion at the meeting is set out in Appendix 2. Key issues for Scrutiny Co-ordination Committee to consider in reviewing this at the meeting will include:
  - What are the combined implications of changes on individuals and communities that decision-makers need to understand?
  - What can be predicted about future impacts that need to be planned for now?
  - How do we make sure that actions being taken now are providing long term sustainable solutions for people, not short term fixes?
  - How is the city's approach to services and support being co-ordinated to avoid either duplication or gaps?
  - Is the Council doing everything required to discharge its responsibilities for elements of the welfare reform agenda?

#### 4 Impact on Individuals, communities and the city

4.1 Working with local partners, the Council's Corporate Research Team has produced a detailed analysis of the impacts of the Welfare Reform changes on individuals, communities and the city. A summary is included at Appendix 1. - 4.2 The issues and challenges emerging from this analysis to date are being considered by partners and include:
  - the need to target support at those losing the most benefit including employees and private sector tenants
  - the demand for crisis support is increasing is enough being done to find sustainable solutions?
  - Labour market inequalities have widened is enough being done to address long standing barriers to jobs?
  - Benefits advice and legal support services are proven to make a big difference, but demand is outstripping supply
  - Lack of rented housing for 'over-occupiers' means families are trapped in unaffordable tenancies
  - Monitor danger signs, evaluate how people are coping and calculate costs to partners?

#### 5 Co-ordination of Services and Support

- 5.1 Through the Coventry Partnership, the Working Together on Welfare Reform group brings together partners including Advice Services Coventry, Citizen's Advice Bureau, Coventry City Council, Coventry Law Centre, Department for Work and Pensions, Midland Heart and Whitefriars Housing. Monthly meetings discuss common issues, share knowledge and work together to tackle emerging problems.
- 5.2 This has led to a range of initiatives and interventions and the Chair of the group and representatives of some of the partner organisations will attend the meeting to contribute to case studies and give their perspectives. Those invited are:

#### 6 City Council Position

- 6.1 A number of council services provide support to people which helps meet long, medium and short term needs, as well as help people in emergency situations. The Council is working to ensure that these are as joined up as possible, particularly at the point of access.
- 6.2 The Council's Benefits Service has dealt with a number of additional pressures through the Governments significant programme of Welfare Reforms. These changes include:
  - the introduction of Council Tax Support (replacing Council Tax Benefit).
  - the size restriction in socially rented properties (also referred to as the 'bedroom tax' or
  - 'spare room subsidy).
  - a new Community Support Grant Scheme (replacing Crisis Loans and Community Care
  - grants previously administered by the Department for Work and Pensions (DWP)).
  - administering the National Benefit Cap from July 2013.
  - additional funding to support people impacted by the changes through the Discretionary Housing Payment fund.

- 6.3 The report to the Cabinet Member Strategic Finance and Resources of 2<sup>nd</sup> December on the Performance within the Benefits Service for the period April 2013 September 2013 includes a summary of some of the impacts of the welfare reform changes on the Council's Benefits Service and is available at: <u>http://democraticservices.coventry.gov.uk/documents/s13999/Benefits%20Service%20Performance%20to%20November%202013.pdf</u>
- 6.4 There are two discretionary funds managed by the service and the Chair of the Scrutiny Co-ordination Committee has asked that progress on these be reported to the meeting.
- 6.5 **Discretionary Housing Payments** (DHP) are used to help people in difficult circumstances with their housing costs. The new DHP policy was approved by Cabinet in March 2013. The Welfare Reforms introduced from April 2013 have resulted in considerable demands on this area of work.
- 6.6 In the first six months of 2013/14, the Service received 1,541 applications. The number of applications in 2012/13 was 727 (a 56% increase from 2011/12). At the end of September 2013, £159,620 had been allocated out of the total budget available of £798,643. The Service has recently reviewed this position and will be undertaking some promotional activity to ensure that awareness of the support available is maximised. The Service also expects a greater demand during the second half of the year due to seasonal factors (pressures with additional spending on fuel and Christmas, for example) and the on-going accumulative impact of welfare reform.
- 6.7 The Service has successfully introduced a new **Community Support Grant** scheme which has replaced the discretionary elements of the Social Fund (Community Care Grants and Crisis Loans) previously administered by DWP. The grants are designed to help vulnerable people living in Coventry who find themselves in a crisis situation or where, for example, they require support to remain in the community. The Council is now responsible for administering the £1,195,847 annual grant for these awards.
- 6.8 Payment is made by the issue of a spending card replacing the cash based system previously used by the DWP. The Service has put in place a responsive process and has worked hard with partners to ensure money is targeted on individual needs. The new team has received 4,340 phone calls and 1,962 applications of which 940 were successful. Spending in the first six months of the new scheme totalled £162,550 (926 were collected with a value of £162,087). Whilst this is relatively low compared to the budget allocation, we do expect demand to increase during the second half of the year. The removal of cash from the system has contributed to a significant reduction in demand when compared to the previous scheme.

#### The Impact of Welfare Reform on Coventry - September 2013

#### **Executive Summary**

The Government is introducing a range of welfare reforms, which won't be fully implemented until 2017. These aim to <u>increase self-reliance</u> through making work pay, whilst supporting disabled people who cannot work.

The emerging picture from evidence reviewed by the Welfare Evaluation Group:

- Recession has exacerbated long standing labour market inequalities. **Women, young adults, disabled people and some black & minority ethnic groups** are finding it harder to get a job
- Housing benefit changes have reduced the incomes of 11,096 Coventry residents, totalling £5million each year. Households more likely to lose the most benefit include: couples, those including children under 5 years old, larger households, those in work, those in Foleshill, St Michaels & Henley wards, in the private sector, in receipt of ESA or Income Support
- 20,000 people have or will be reassessed for Employment Support Allowance and 11,000 for Personal Independent Payments. This is causing anxiety about benefit reductions for many.
- Increasing rent arrears and applications for Discretionary Housing Payments are early warning signs that some people affected are not coping with reduced incomes
- Partner organisations are already experiencing service pressures:
  - > Overstretched specialist debt and benefit advice and legal support services
  - > Shortage of smaller rented housing to house those affected by under-occupancy cuts
  - > Additional work to deal with rent collection, evictions and increased housing repairs

The Working Together Group and individual organisations are proactively supporting those affected:

- General awareness raising and benefits and money advice support through pop-up shops, road shows and campaigns
- Targeted support to individual tenants known to be affected, improving money management & checking eligibility for benefits
- Encouraging and supporting individuals to access employment opportunities
- Providing support through hardship funds and food banks
- Giving priority to 'under-occupiers' to access smaller rented housing through Homefinder
- Continuing to provide Council Tax Support to those eligible for means tested benefits
- Switching resources towards supporting the impacts & increasing the use of volunteers to help


Partner organisations have expressed fears for the future about growing indebtedness, poverty and destitution. Potential social impacts could be increased domestic violence, child neglect, ill-health, homelessness etc. Partners have emphasised the importance of continued partnership working:

- Providing support and advice to mitigate against negative impacts of reforms
- Continuing to focus on tenancy sustainment and preventing homelessness, but widening the focus to include Personal Independence Payments and eventually Universal Credit.

Key issues to watch and understand for the future are:

- Are people adapting and becoming more self-reliant or are some groups of people struggling what further practical support is needed?
- How effectively is support being targeted at those most at risk? Is it aimed at helping people adapt and thrive in the changed welfare system? What is the impact of migration from other areas?
- Around 15,000 working age adults are not in work or education *and* not claiming welfare benefits. Is
  this through choice or is there a growing pool of households at risk of falling over? Information from
  government about what happens to people who come off benefits is required.
- What is the impact of sanctions (loss of benefit) applied to those failing to meet the Claimant Commitment?
