### 34. Minutes

The minutes of the meeting held on 21st January, 2014 were signed as a true record. There were no matters arising.

### 35. Co-ordinated School Admission Schemes for 2015 and Community and Voluntary Controlled School Admission Policies for 2015

The Cabinet Member considered a report of the Director of Education and Inclusion which provided information on the Co-ordinated School Admission Schemes for 2015 and Community and Voluntary Controlled School Admission Policies for 2015.

Each year the Department for Education requires Local Authorities to determine the co-ordination schemes for school admissions in their areas and the admissions policies for community and voluntary controlled schools which are the responsibility of the local authority, by 15<sup>th</sup> April 2014.

In April 2006, Cabinet agreed that consideration of reports on school admission arrangements would be delegated to the appropriate Cabinet Member in years where there were no significant changes to admission arrangements (their minute 196/06 refers).

All schemes and policies referred to in the report were considered by the School Admissions Forum on 7<sup>th</sup> February 2014. As there had been no significant changes to the schemes and policies since the 2013 policies, consultation was not required by the School Admissions Code.

The Cabinet Member noted that increasing the admission numbers at Edgewick Primary School was subject to a separate consultation process and was the subject of separate reports to Cabinet on 4<sup>th</sup> March and 13th May 2014.

### **RESOLVED** that the Cabinet Member (Education):

- 1. Determined the co-ordinated admissions scheme for primary, infant and junior schools in Coventry for 2015/16 and the admission policy for community and voluntary controlled primary, infant and junior schools for 2015/16, as set out in Appendix 1 to the report.
- 2. Determined the co-ordinated admissions scheme for secondary schools in Coventry for 2015/16, as set out in Appendix 2 to the report.

### 36. Appointments to the Coventry Standing Advisory Council for Religious Education

The Cabinet Member considered a report of the Director of Education and Inclusion which sought the approval to the appointments of a representative of the Sikh faith (Group 2) and the National Association of Headteachers (NAHT) (Group 3) to the Coventry Standing Advisory Council for Religious Education (SACRE).

SACRE was established under the Education Reform Act 1988 and comprised of four groups: a Church of England group (Group 1); a group representing other Christian denominations and other Faiths which reflect the principal religious traditions in the area (Group 2); a group representing teachers (Group 3) and a groups representing the City Council (Group 4).

The City Council is responsible for appointing members to the 4 statutory Groups.

The purpose of the Standing Advisory Council for Religious Education is to advise the Local Authority on matters concerning religious education in community schools and the religious education provision to be made in accordance with an Agreed Syllabus. These matters may include methods of teaching, training for teachers and, choice of materials and resources.

**RESOLVED** that the Cabinet Member (Education):

- 1. Approves the appointment of Bimla Paul to Group 2 of the Coventry Standing Advisory Council for Religious Education for a period of four years as a representative of the Sikh faith.
- 2. Approves the appointment of Angela Dawes to Group 3 of the Coventry Standing Advisory Council for Religious Education for a period of four years as a representative of the National Association of Headteachers (NAHT).

Title: Determination of School Terms and Holidays 2015 – 2016

### Is this a key decision?

No – Although the issue affects all Wards of the City, it is not expected to significantly impact on communities

### **Executive Summary:**

This report informs the Cabinet Member of the outcome of the public consultation on the School Terms and Holidays dates for 2015/2016 and asks the Cabinet Member to agree the School Terms and Holidays Calendar for 2015/2016.

Currently the local authority is required to set term and holiday dates for community schools, community special schools, voluntary controlled schools, pupil referral units and maintained nursery schools. All schools in England are free to decide when their school day should start and end.

Governing bodies are required to set term and holiday dates in foundation and voluntary aided schools. The academy trust is responsible for the duration of the school year and term and holiday dates for academies and free schools.

A public consultation on the Coventry school terms and holidays dates 2015/2016 took place from 11 February 2014 to 7 March 2014. There were 112 valid replies to the consultation. The more popular of the two options available was Option 1 with pupils returning to school on Wednesday, 2 September 2015 and finishing the academic year on Wednesday, 20 July 2016. Details of the two options for School terms and holidays dates 2015/2016 can be seen on pages 4 and 5 of the Consultation Document, which is found in Appendix 1.

### **Recommendations:**

The Cabinet Member (Education) is requested to:

(1) Consider the outcome of the public consultation on School Terms and Holidays and agree a calendar of School Terms and Holidays for 2015/2016.

- (2) Adopt Option 1 as the School Terms and Holidays Programme 2015/2016 for Community, Voluntary Controlled and Community Special Schools, and maintained Nursery Schools.
- (3) Invite the Catholic and Church of England Diocesan Authorities and the Governors of Trust Schools and Academies to recommend the same calendar for their schools.

### Report title: Determination of School Terms and Holidays 2015 - 2016

### 1. Context (or background)

- 1.1 Under Section 32 of the Education Act 2002 in the case of a community, voluntary controlled or community special school or a maintained nursery school the Local Authority is required to determine the dates when the school terms and holidays are to begin and end, and the governing body is required to determine the times of the school sessions.
- 1.2 Governing bodies are required to set term and holiday dates in foundation and voluntary aided schools. The academy trust is responsible for the duration of the school year and term and holiday dates for academies and free schools.
- 1.3 The draft Deregulation Bill proposes allowing governing bodies of community, voluntary controlled, community special schools or maintained nursery schools in England to set the dates when the school terms and holidays are to begin and end. The proposed change would take effect from September 2015 onwards. The Local Authority believes that a standard set of holiday dates adopted by all Coventry schools will be better for school attendance, the organisation of admissions to Year R/Year 7 and for parents and carers arranging childcare and transport. Coventry schools will be requested to adopt the outcome of this consultation.
- 1.4 The current Coventry Local Authority principles and protocols were taken into account when setting the 4 options for consideration:
  - a school year is 195 days, with 190 pupil days and 5 teacher days;
  - 1 teacher day is determined by the Local Authority and 4 days by individual schools;
  - statutory holidays are observed;
  - schools prefer, especially secondary schools, full weeks of teaching wherever possible;
  - schools prefer a full week break at half term and two full weeks at Easter and Christmas;
  - half term holidays are set at the same time as those of neighbouring Authorities if possible.
- 1.5 The half term holidays in 2015/16 consultation options have been set to the preferred dates of Warwickshire and the neighbouring West Midlands authorities. Until these authorities have finished their own consultations their actual term and holiday dates are unknown.
- 1.6 There were 112 valid replies to the public consultation, which took place from 11 February 2014 to 7 March 2014. The most popular overall of the 2 options available was Option 1 with 63 votes. Option 2 had 45 votes and 4 respondents sent comments, but did not choose an option.

### 2. Options considered and recommended proposal

- 2.1 The full details of the 2 options for School terms and holidays dates 2015/2016 can be seen in the Consultation Document found in Appendix 1.
- 2.2 The protocols in para 1.3 were complied with in both options.
- 2.3 In previous consultations head teachers and members of the public have expressed a preference for school holidays to be set at the same time as those of neighbouring Authorities. In consideration of this viewpoint the two consultation options had the same dates set for the half term holidays and , as far as possible, the Christmas holiday as neighbouring authorities.

2.4 Teachers have expressed concern that pupils should have enough time in school after Easter to prepare properly for summer exams. They have also expressed a preference for equal term lengths. The table below shows the term lengths for each option offered in the consultation.

Please note that these term lengths include the five teacher days.

Easter Sunday is 27 March 2016 so the Spring term is short in comparison to the summer term.

- 2.5 Easter Sunday is the first Sunday in the school Easter holiday in both options. This is preferred by some schools. Both the Easter and Christmas holidays are two complete weeks.
- 2.6 Having met the criteria in the protocols, para 1.3, and preferences given in paragraphs 2.3 2.5 there was very little scope for alternative options. Head teachers and teachers have frequently mentioned that incomplete teaching weeks lower attendance, but incomplete weeks are unavoidable due to bank holidays and the 190 days pupils are required to be taught. Therefore the consultation options were for alternative start and end dates, giving an opportunity to indicate the best choice for attendance.

### 3. Results of consultation undertaken

- 3.1 The Consultation Document was sent to Head teachers and Governing bodies of Coventry's schools, Diocesan Boards of Education, FE Colleges, Trade Unions, Early Years Providers and Libraries. It was also available on the Coventry City Council website, www.coventry.gov.uk, and Coventry Learning Gateway.
- 3.2 Replies were invited in writing, by email or online from the Coventry City Council website.
- 3.3 There were 112 valid responses to the consultation coming from 99 individuals and 13 organisations.
- 3.4 The most popular choice was option 1 with 63 votes (34%). Option 2 had 45 votes (30%) and 4 respondents chose to send comments only.
- 3.5 The results can be seen in Table 2 below.

3.6 Sixty six respondents sent comments. These were grouped into broad categories and a summary can be seen in Table 3.

- 3.7 More than one reason can be given by a respondent so the total count of reasons is greater than sixty six.
- 3.8 The most common category of comments of comment was miscellaneous, where the comment was too vague or concerning terms and holidays in general rather than the options. The next most common reasons were holidays and benefit to the pupil.
- 3.9 Other common reasons given were coordinating with work, childcare or the family, being the same as other local authorities and pupil attendance.
- 3.10 Examples of comments can be seen in Appendix 2
- 3.11 Option 1 was more popular than Option 2 overall so Option 1 is recommended as the School Terms and Holidays calendar for 2015/2016 for Coventry Community, Voluntary Controlled and Community Special Schools, and maintained Nursery Schools.

### 4. Timetable for implementing this decision

- 4.1 When the cabinet member decision becomes effective schools will be informed of the approved school terms and holidays calendar for 2015/16. The approved calendar will also be displayed on the City Council website and Coventry Learning Gateway.
- 4.2 Catholic and Church of England Diocesan Authorities, Governors of voluntary aided schools, Governors of trust schools and Academy Trusts will be informed and invited to recommend the same calendar for their schools

### 5. Comments from Executive Director, Resources

5.1 Financial implications

There are no financial implications.

5.2 Legal implications

Under Section 32 of the Education Act 2002 in the case of a community, voluntary controlled or community special school or a maintained nursery school the Local Authority is required to determine the dates when the school terms and holidays are to begin and end. The Governing Body is required to determine the times of the school sessions.

The Governing Body in the case of Foundation, Voluntary Aided, Foundation Special Schools and Academies are required to determine school terms and holidays dates. Paragraph 3 of Schedule 14 of the Government's draft de-regulation Bill (which is currently in the House of Commons) moves all responsibility for determining term dates in community, voluntary controlled and community special schools and maintained nursery schools from the local authority to the governing body. If approved the governing body of all such maintained schools will be responsible for determining their school's term and holiday dates each year as is the case now for all Aided, Foundation and Academy schools.

### 6. Other implications

# 6.1 How will this contribute to achievement of the Council's key objectives / corporate priorities (corporate plan/scorecard) / organisational blueprint / Local Area Agreement (or Coventry Sustainable Community Strategy)?

The Local Authority is required to determine the dates when the school terms and holidays are to begin and end for community, voluntary controlled or community special schools or maintained nursery schools.

Appropriate school term and holiday dates can increase attendance and aid curriculum planning so helping pupil achievement.

### 6.2 How is risk being managed?

Current legislation on the number of teaching sessions has been complied with. Trade unions were asked to consider the calendar options prior to the public consultation to ensure that the options were acceptable to their members. The public consultation considered in this report has enabled various points of view from

school staff and governors, parents and carers and pupils to be taken into account.

### 6.3 What is the impact on the organisation?

Centrally employed staff on Teachers Pay and Conditions will have their holiday pattern determined by this consultation.

### 6.4 Equalities / EIA

Although all the views of different groups are considered in setting term dates, Government legislation and the protocols given in paragraph 1.3 limit the flexibility of the dates for school terms and holidays.

Before the start of the public consultation on School Terms and Holidays 2015/16 Warwickshire and West Midlands local authorities and unions were consulted to find out if there were any issues they believed would affect setting the school term and holiday dates. No specific equalities issues were identified through this process.

The public consultation on the Coventry school term and holiday dates 2015/16 took place from 11 February 2014 to 4:00pm, 7 March 2014. The consultation aimed to establish the views of governors, head teachers, teachers, parents and carers of pupils and other school employees.

The Consultation Document was sent to head teachers and Chairs of Governing bodies of Coventry's schools, Diocesan Boards of Education, FE Colleges, Trade Unions, Early Years Providers, Libraries and was also available on the Coventry City Council website, www.coventry.gov.uk, and Coventry Learning Gateway. The consultation document was available in other formats and languages on request. One request for an alternative format was received.

The survey asked for comments from respondents to further inform the decision.

The data received mainly reflected the views of governors, teachers, and parents and carers of pupils and did not raise any equalities issues.

### 6.5 Implications for (or impact on) the environment

None

### 6.6 Implications for partner organisations?

It is desirable to align school holidays with those of neighbouring local authorities to minimise the difficulties to families such as those where parents work or live in a different authority to that of the school attended by their children or where siblings attend schools in different authorities.

### **INTRODUCTION**

Coventry Local Authority is now seeking your views on school terms and holidays options for the 2015/2016 academic year.

The draft Deregulation Bill proposes allowing governing bodies of community, voluntary controlled, community special and maintained nursery schools in England to set their own school term and holiday dates from September 2015 onwards. The Governing Bodies of academies, free schools, foundation/trust and voluntary aided schools currently have the power to set the term and holiday dates for their own schools.

The Local Authority believes that a standard set of holiday dates adopted by all Coventry schools will be better for school attendance, the organisation of admissions to Year R/Year 7 and for parents and carers arranging childcare and transport. The term and holiday setting procedure will continue as in previous years for 2015/16 and Coventry schools will be requested to adopt the outcome of this consultation.

### BACKGROUND

Coventry takes into account the following principles in setting calendars for school terms and holidays:

- a school year is 195 days, with 190 pupil days and five teacher days;
- one teacher day is determined by the Local Authority and four days by individual schools;
- statutory holidays are observed;
- schools prefer full weeks of teaching wherever possible;
- schools prefer a full week break at half term and two full weeks at Easter and Christmas;
- half term holidays are set at the same time as those of neighbouring authorities if possible.

### TEACHER DAYS

A teacher Day is a work day for teachers, but not a pupil teaching day

If a community or voluntary controlled school decides to close to pupils on an election day then one of the remaining four teacher days must be used for this purpose. This is also recommended for foundation/trust and voluntary aided schools and for academies.

### Options for the 2015/2016 Academic Year

Until other West Midlands Authorities and Warwickshire have finished their own consultations their term and holiday dates are unknown. The preferred options for the 2015/16 half term holidays are Monday 26 October to Friday 30 October, Monday 15 February to Friday 19 February and Monday 30 May to Friday 3 June.

Coventry City Council is asking for your option preference for the choices below. Holiday dates are inclusive.

### Option 1

Autumn Term 2015

- Term Starts Wednesday 2 September 2015 for pupils (Tuesday 1 September 2015 for teachers)
  - Half Term Monday 26 October 2015 to Friday 30 October 2015
  - Term Ends Friday 18 December 2015

Spring Term 2016

- Term Starts Monday 4 January 2016
- Half Term Monday 15 February 2016 to Friday 19 February 2016
- Term Ends Thursday 24 March 2016

### Summer Term 2016

- Term Starts Monday 11 April 2016
- Half Term Monday 30 May 2016 to Friday 3 June 2016
- Term Ends Wednesday 20 July 2016

### Examples of Comments from the Consultation

Comments have been anonymised and grouped by category of comment.

### Miscellaneous

Does a single day difference between the two proposals make much difference? It is the large summer break that needs reviewing and should be split into a shorter amount of time off, with the remaining days added to the half term breaks. Such a long period of time away from school is extremely difficult to manage from a child care perspective and financially expensive considering the unreasonable hike in holiday costs. If this is not feasible, then it should be considered whether the summer break can be moved earlier into July or later into September. This would help alleviate the issues regarding holiday price increases (as would returning to the previous system if allowing head teachers to grant permission for term time holidays).

We would follow the local authority dates. We would be prepared to consider a change if all local schools including primaries were going to change to shorter summer holidays and longer half terms as evidence has shown that this can be beneficial to the learning of students.

Best of two bad options. Why not go radical and join the rest of Europe and change the terms about, shorter (but more of them) holidays for one. It causes too many problems trying to get childcare for those of us that work for a living. Staggered holidays would ease the pressure on work/life balance. Teacher friends of mine that have worked abroad say their systems are much better, look at the Scandinavian example......

This seems to be the closest option to what currently happens and I can't see any reason to change it.

Logical week breaks.

### Attendance

Split weeks are always awkward to manage. However, Option 2 allows two days rather than 3 for pupils to get back up to speed after the summer break before starting their first full week. Option 2 also creates a 4 day final week of the school year which is harder to question and dismiss than a 3 day week.

Option 2 could encourage parents to take a late summer holiday and keep their child off school for the first two days of the autumn term; whereas Option 1 would hopefully discourage this.

As I deal with attendance in our school breaking up on a Thursday will bring our attendance right down as some children will not attend those other days.

Option 1 would ensure that the children returned at the beginning of term for three days rather than for two days which may support families not taking holidays which run over the start of term.

### Curriculum

#### Benefits Pupil

The teaching staff and I believe that Option Two will provide the pupils with the best possible start and end to the academic year.

I believe that a longer first week is preferable in order to give children more time to settle in to their new classes or schools. It also gives teacher more opportunity to get to know their pupils.

Back from Summer Holidays for 2 days will ease children into the new academic year.

I have based my decision on a Year 11 students' finishing school earlier in the year, going into 6th form a day earlier could benefit them. I really don't see what a big difference it makes anyway. A lot of unnecessary fuss and administration work.

Starting the term in September with a 2 day week for students does not make for a great start to their learning in my experience.

#### Holidays

I feel that coming back to school on 1st September feels too early and does not give people chance to finish their holidays properly

Finishing earlier in the summer - holiday prices increase!

Family holiday - cheaper at end aug

Neither option is preferable to me. Could you not look at altering the term and holiday dates so that they can be staggered with the rest of the country? Therefore making family holiday decisions easier and affordable?

Later start after the summer- cheaper flights.


### Work, Childcare, Family

Option one is more convenient for working parents.

In truth convenience is the reason for my choice as few split midweek holiday & school time as is possible, as this impacts significantly on annual leave for work.

Option 2 would be impossible for working parents with more than one child. Juggling work and childcare is hard enough without having to do extra days.

Child care clubs finishes at the end of August (30th) and parents have used their annual leave up that adding extra days at the end of summer holidays is very difficult for working parents. At our school they have a BAD HABIT of leaving teacher training days until end of summer term, so you never finish on the Wednesday and again children clubs do not start until the following week so parents are needing to add odd days of already of very stretched annual leave.



In work ......September is the busiest time for me so would prefer my children to go back as soon as possible in September.

...... my children are still school age. Option 2 fits in better with my husband so we can benefit from time off all together.

### LA

My children attend ...schools in Warwickshire and I believe option 1 ties in best with Warwickshire holidays. Also from my teaching perspective, I believe that option one offers better opportunities for curriculum planning.

I cannot decide as I do not have enough information. For our family, we need the dates to be the same as Solihull and Rugby. And currently we do not have those dates. It is lovely that schools can set their own dates...but no one has considered the impact on families with links to more than one school! All schools across the country should have the same dates!

Please align Coventry's term dates with other local authorities, for example, making sure Easter is the same as Warwickshire.

No great difference between the two. Would be good if we were lined up with Solihull, Birmingham and Warwickshire.
