Report title:

Petition – Arms Dealers in Coventry and the West Midlands Pension Fund

1. Context (or background)

- 1.1 A petition with 424 signatures has been presented to Council by Councillor Allan Andrews. The petition states "Coventry has become known as "The City of Peace and Reconciliation". Yet there are several leading arms companies doing business here. In addition, Council Tax money is paid in to the West Midlands Pension Fund, which invests over £60 million in armsdealers. We wish the City Council to remove these investments from the Fund, find better alternatives, and work towards an arms-free economy for this city."
- 1.2 Office of National Statistics (ONS) data sources show that no-one in Coventry is employed specifically in the manufacturer of explosives or the manufacture of weapons or ammunition but a small number are involved in the manufacture of military fighting vehicles. Often companies categorised as "arms companies" have a wide portfolio of activities and some, like Rolls Royce, have a long history in the city.
- 1.3 Coventry City Council takes part in the West Midlands Local Government Pension Fund as an employer along with the other six West Midlands Metropolitan District Councils. City Council employees can opt to be members of the pension scheme and the City Council puts funding into the scheme through its employer contributions.

2. Options considered and recommended proposal

- 2.1 The West Midlands Local Government Pension Fund is independently managed and governed to protect its members' interests and prevent unwonted financial or political influence over its funds. Coventry City Council does not have the ability to make any decisions about the contents of the Fund, therefore cannot not meet the petition's request to remove investments from the fund.
- 2.2 The West Midlands Local Government Fund has its own formal investment policies including a policy on socially responsible investment. These are publically available on the fund's website http://www.wmpfonline.com. Coventry City Council does not have the authority to change these policies.
- 2.3 It is therefore recommended that the Cabinet Member (Strategic Finances and Resources) ensures that the petition is forwarded onto the West Midlands Pension Fund Committee for their consideration.

3. Results of consultation undertaken

3.1 No consultation has been undertaken. The West Midlands Local Government Pension Fund is an independent organisation and undertakes its own consultation processes.

4.1 If the recommendation is approved the petition will be forwarded to the West Midlands Local Government Pension Fund
