Report title: Appointments of the City Council – Tile Hill Wood School and Language College and Lyng Hall School Governing Bodies

#### 1. Context (or background)

#### Tile Hill Wood School and Language College

- 1.1. The former Tile Hill Wood Secondary School converted to academy status in July 2011 and is now known as Tile Hill Wood School and Language College. The Academy was set up by sponsors who own and run the school, with those functions discharged through the Governing Body and Head Teacher.
- 1.2. Following the Academy conversion, the Council were allocated a position on the Governing Body of the School. The position requires the appointment of an elected member.

#### Lyng Hall School

1.3. Colleen Fletcher MP was nominated as the Council's representative on the Governing Body of Lyng Hall School at the Council's Annual Meeting. Mrs Fletcher MP has subsequently resigned from the position, leaving a vacancy.

- 2.1 It is proposed that the City Council be represented on Tile Hill Wood School and Language College Academy Governing Body by the appointment of Councillor Maton.
