## Recommendations

The Cabinet Member is recommended to:

- 1. Consider the objections to the proposed Traffic Regulation Order.
- 2. Subject to recommendation 1 approve the making in part, (i.e. not the part relating to Sunday tariffs), as described in 2.5.2, of the City of Coventry (City Centre Restricted Parking Zone) (Permitted Parking Area and Special Parking Area) (Designation, Waiting Restrictions, Loading Restrictions, Loading Areas and Street Parking Places) Order 2012.
- 3. Approve that a detailed benchmarking exercise of Sunday tariffs be undertaken without delay, after which a proposal on the level of

Sunday charges will be agreed with the Cabinet Member and readvertised for a period of 21 days commencing in October 2012, with any unresolved objections, where appropriate, being reported to the Cabinet Member (City Services) for a decision as to how to proceed

4. Approve that the availability of parking and level of on street parking charges are continued to be kept under review.

- (iv) decisions of the Licensing and Regulatory Committee.
- (v) decisions of the Planning Committee.
- (vi) decisions of the Appeals and Appointments Panels.
- (vii) decisions of the Audit Committee.
- (viii) a matter where the associated report has already been considered by the Scrutiny Co-ordination Committee or a Scrutiny Board who have endorsed the recommendations or made recommendations that have been accepted by the Cabinet/Cabinet Member.

- 3. The call-in form is received after the specified time.
