# ♦ Report 4a Serious Case Review - Mrs C (CSAB/SCR/2012/1)

#### Recommendations

- i. Cabinet Member (Health and Community Services) is asked to note and consider the contents of the report and any recommendations made by Health, Social Care and Welfare Reform Scrutiny Board (5).
- ii. That a further recommendation be approved requesting that Anchor Trust/Anchor Housing Services conduct a review and implement a system to check that residents living in their properties have the appropriate alarm equipment to enable them to call for help at any time and that Anchor Trust/Anchor Housing Services provide evidence that such a system is in place during the review to be held in six months.
- iii. That the Scrutiny Board's request for a report back on the progress made in completing the recommendations of the SCR in six months be noted, and also brought back to Cabinet Member (Health and Community Services).

- a variation to the City of Coventry (City Centre)(No.1) (Prohibition of Driving, One Way, Variation and Revocation) Order 2012 is advertised to address the unintended consequence of an exemption for pedal cycles from the prohibition of driving restriction on certain roads including Hales Street.

# Report 4 Follow-up report relating to tree maintenance works to Stonebridge Highway Spinney

### Recommendations

The Cabinet Member (Community Safety and Equalities) is recommended to:- approve that:

- 1. Approve that the five trees situated in Stonebridge Highway Spinney to the rear of homes in Alfriston Road, be felled and suitable replacement planting undertaken in due season.
- 2. Request officers to continue ongoing scheduled inspections and monitoring arrangements in relation to Stonebridge Highway Spinney in order to take appropriate action in relation to any maintenance/safety work identified, including identifying a specific work programme for Stonebridge Highway Spinney and associated budgetary implications.

3. Officers be requested to provide written briefing notes to the Wainbody Ward Councillors in relation to the work programme referred to in Recommendation 2 above, to keep them informed of any progress. In addition, this information be shared with the petition organiser.

## Report 5 Health and Safety Annual Report 2011-2012

#### Recommendations

(1) The Cabinet Member is asked to accept the Annual Health and Safety report for 2011/2012 and endorse the ongoing approach of further Annual Health and Safety reports to be produced and considered by Corporate Management Board and the Cabinet Member on an annual basis. The Cabinet Member is also asked to share the Health and Safety Annual Report for 2011/2012 with Cabinet colleagues and approve the issue of copies of the document to all Elected Members.

# The above recommendation was amended and approved as per the following, together with the additional recommendations:

- (1) The Cabinet Member approves the content and publication of the Annual Health and Safety report for 2011/2012 and endorses the ongoing approach of further Annual Health and Safety reports to be produced and considered by the Corporate Management Board and the Cabinet Member responsible for this policy area on an annual basis.
- (2) The Cabinet Member directs that the Health and Safety Annual Report for 2011/2012 be distributed to Cabinet Member colleagues and their relevant Management Board Directors to consider and act upon where appropriate.

(3) The Cabinet Member approves the issue of copies of the document to all Elected Members.

# Report 6 Request from Coventry Sports Trust to Withdraw from the Operational Management of the Community Use Facilities at Tile Hill Wood Language College.

### Recommendations

Cabinet Member (Community Safety and Equalities) is recommended to:

1) Not approve at this date the Trust's request to vary the existing grant agreement signed in April 2008, and request the Trust honour their contractual obligations and manage the community use facilities on behalf of the school until another operator is procured to ensure there is no break in service delivery.

# The above recommendation was amended and approved, together with the following additional recommendations:

- 2) The Cabinet Member requested that a further report be submitted to the next scheduled meeting to be held on 20<sup>th</sup> December, 2012, to address, inter alia:
  - (a) any contracts, legal or novation agreement and/or issues that have arisen out of the present operational arrangements and the potential consequences arising there from.
  - (b) The framework for arrangements for a seamless transition to an alternative provider in the event that the Trusts' request is granted at that meeting.
- The Cabinet Member (Community Safety and Equalities) directs that officers support the Academy in sourcing an alternative provider and that unless a timetable for that procurement exercise is produced at the next Cabinet Member meeting on 20<sup>th</sup> December 2012, the Cabinet Member will reconsider terminating the contract with Coventry Sports Trust.
- 4) The Cabinet Member (Community Safety and Equalities) directs that formal written invitation be extended to the three Westwood Ward Councillors, the three Woodlands Ward Councillors, the Headteacher at Tile Hill Wood School and Language College, the Chair of Governors at Tile Hill Wood School and Language College and Mr Paul Breed of Coventry Sports Trust, to attend that meeting and that if any of the parties invited do not attend, the Cabinet Member will not be minded to adjourn making a final decision at that time.
