- (3) Delegates authority to the Leader of the Council in consultation with the Cabinet Member (City Development) and Chief Executive to:
  - a) identify proposed partners for the City Council and enter into discussions with them and Government about its submission of an expression of interest;
  - b) prepare a draft expression of interest for a Coventry and Warwickshire City Deal for submission to the Cities Policy Unit by 30 November 2012;
  - submit an expression of interest for a Coventry and Warwickshire City Deal to Government by 15 January 2013 and/or meet any amended submission timetables;
  - d) enter into discussions and negotiations with Government after the submission of an expression of interest to further develop and finalise the content of the City Deal prior to formal approval of Council by November 2013.

#### # Report 12 Coventry's District Heating Scheme, Heatline – Outcome of Procurement Process

#### Recommendations

- Endorse its commitment to Coventry's District Heating Scheme (Heatline) under the delegated approval to officers in consultation with the Heatline Member Panel to award the contract to Cofely District Energy Ltd acting through its 100% owned company Coventry District Energy Company Limited as the operator for the next 25 years.
- 2. Ratify the Council as the anchor customer without Coventry University.
- 3. Endorse its commitment to support the expansion of Heatline under the contract with Coventry District Energy Company Limited to help the Council achieve the Government-set carbon reduction targets of 80% by 2050 and 34% by 2020

- 3. Approve the appropriation of a small piece of land from its current use as commercial property to highway use, to be adopted under the Highways Act 1980 (see Appendix A: Area A (Blue) and B)).

Health, Social Care and Welfare Reform Scrutiny Board consideration of Adult Social Care Annual Report 2011/12 (Local Account)

#### 1 Purpose of the Note

1.1 To inform Cabinet of the Health, Social Care and Welfare Reform (5) Scrutiny Board's recommendations following their consideration of the Adult Social Care Annual Report 2011/12 (Local Account) on Wednesday 7<sup>th</sup> November 2012.

#### 2 Recommendations

2.1 Cabinet are asked to agree the recommendations included in the report and to endorse a corrected version of the Annual Report 2011/12.

Cabinet are asked to note the issues raised by the Scrutiny Board:

- i That the report is well-written and easily accessible for a wide audience.
- ii That future reports might include data which shows comparisons with previous years.
- iii That before the report is circulated officers check to ensure that no personal details or identifications are included in the case studies, photographs and additional information.
- iv For consideration to be given to how the report is circulated and made available particularly to those who might be interested in the Adult Social Care services provided by the City Council.

#### 3 Information/Background

- 3.1 At their meeting of 7<sup>th</sup> November 2012 the Scrutiny Board considered a report of the Director of Community Services regarding the proposed publication of the Adult Social Care Annual Report for 2011/12. Officers reported verbally at the meeting regarding a number of typographical errors and these should be corrected before a final version of the document is considered by Cabinet.
- 3.2 The Scrutiny Board warmly welcomed the document and particularly emphasised their view that the document was written in such a way as to be accessible and informative to a wide audience.

- 3.3 Members only query regarding the document content related to the inclusion of a range of data which they felt it would have been helpful if some more comparative data had also been included.
- 3.4 The Board also queried the inclusion of photographs of service users in the document, and requested that officers do a further check to ensure that any local people included in the document had given their permission for them to be used and that there was no danger of local people being identified as vulnerable as a result of their inclusion in the document. Officers gave an assurance at the meeting that this would be done.
- 3.5 Finally the Board queried the plans for the circulation of the Annual Report. Members felt that the document was worthy of circulation, and was of particular interest to anyone considering making a request for a service, or being the carer of such a person. Officers reported that there was no budget identified for the printing of large numbers of copies of this document, however consideration would be given to small numbers being printed and placed in libraries etc, and partner agencies would be encouraged to ensure that electronic copies of the Annual Report were circulated as widely as possible.

Limitations on Call-in
