Report 4 Two Petitions – request for the removal of the Stoney Road Bus Gate and request to retain the Stoney Road Bus Gate

Recommendations

Report 5 Further Report Back – Petition against the installation of a Residents' Parking Scheme in the Swanswell Area

Recommendations

Report 6 Report Back - Request for traffic management measures on Lammas Road

Recommendations

Cabinet Member (City Services) is recommended to approve that a oneway traffic order is advertised with the permitted direction of travel being from Moseley Avenue to Holyhead Road. The introduction of the restriction will depend on the necessary budget being made available in a future year's Transportation and Maintenance Capital Programme."

Report 5 2012/13 Quarter 2 Revenue and Capital Monitoring and Treasury Management Report (to September 2012)

Recommendations

Cabinet is recommended to:

- 1. Approve the revised capital estimated outturn position for the year of £52.1m incorporating:
 - (i) £0.2m reduction in spending relating to approved/technical changes, (see Appendix 2),
 - (ii) £5.0m net rescheduling of expenditure into 2013/14, (see Appendix 4).

This spending level, compared with resources available to fund the capital programme, represents a forecast balanced position in 2012/13.

2. Note the revenue position of a forecast overspend of £1.3m and the expectation that this will be brought back to a balanced position by the year-end

Recommendations

- 1. Approve the publication of Statutory Notices under Section 19(1) of the Education and Inspection Act 2006, to increase the admission number for 12 primary schools with effect from September 2014, as set out in paragraph 3 and appendix 4;
- 2. Approve that a further report be submitted to Cabinet in March 2013 on the outcome of the publication of the Statutory Notices and the financial implications for delivering the expansion programme for September 2014;
- 3. Approve a planning margin of up to 5% above forecast citywide pupil numbers;
- 4. Approve the maximum primary school size be increased from 3 to 4 forms of entry; and
- 5. Authorise officers to work with the Archdiocese of Birmingham and the governing body of Corpus Christi and report back on the basic need funding required towards the 10% cost that would not be funded by the Department for Education (DfE).

Report 10 Proposals for Delivery of a Future Care Leaver Service in Coventry

Recommendations

Cabinet is recommended to approve:

- 1. The development of an 'In House' Single Integrated 15+Team under Option C within the Report.
- 2. TUPE of eligible staff from current PA Service Provider to the Council.
- 3. Timescale for implementation of new Service structure by 31st March 2013.

Report 13 Local Transport Body Governance and Assurance

Recommendations

- (2) Recommend that Council appoint an Elected Member (and deputy member) to represent Coventry City Council on the Local Transport Body;

- (3) Approve the establishment of a 'shadow' Local Transport Body to operate in the interim until the formal Local Transport Body is fully established and operational; and
- (4) Delegate to the Directors of City Development and Finance and Legal Services, in liaison with the Cabinet Member (Policy, Leadership and Governance), the negotiation and agreement of the necessary assurance arrangements for the Local Transport Body.

The above recommendations were approved subject to an amendment to No (2) as follows:

(2) Note at its meeting on 4th December 2012, Councillor Kelly had been approached as the City Council representative on the Local Transport Body and to recommend that Council appoint a deputy member at its meeting on 15th January, 2013.

 - (viii) a matter where the associated report has already been considered by the Scrutiny Co-ordination Committee or a Scrutiny Board who have endorsed the recommendations or made recommendations that have been accepted by the Cabinet/Cabinet Member.
