Report 4 Report back - Petition – Concerns about traffic movements around the Cambridge Street Mosque and the risks to young people

Recommendations

The Cabinet Member (City Services) is recommended to approve on road safety grounds the advertisement of a no waiting restriction extending 19 m on the north side of Cambridge Street between the existing extent of the no waiting at any time restriction and the access to the Mosque. The restriction would operate Monday to Friday, 4.30pm to 7.30pm.

Report 5 Report back – Petition – Removal of flowerbeds from Stockton Road

Recommendations

The Cabinet Member (City Services) is recommended to approve that the chicanes are not removed at the current time, but that the demand for

parking on Stockton Road, Redcar Road and Hartlepool Road is kept under review.

The above recommendation was approved, along with the following additional recommendation:

The officers be requested to review the existing waiting restrictions in the vicinity of Stockton Road, Recar Road and Hartlepool Road and report any possible changes directly to the Cabinet Member and the local Ward Councillors.

Report 6 Report Back on Petition – Seashell Close Surface Water Drainage

Recommendation amended to read as follows

The Cabinet Member is recommended to:

Accept that the Council as Lead Local Flood Authority have reviewed the design standards, worked closely with the developer Bellway Homes, Jephson Housing Association, other private owners and the management company CJ Bigwood with a view to resolving the flooding issues in the vicinity of Seashell close and that officers report back after six months on the following issues identified during the meeting:

- i) To determine the level of the inlet to the catchpit and soakaway.
- ii) Request that the non-return valve is installed by the builder, Bellways Homes at 35 Seashell Close.
- iii) Request that the builder provide evidence of the discharge rate of the rear soakway.
- iv) Request the installation of a dipping point to allow for easy monitoring of water levels.

The above amended recommendation was approved.

 - (vii) decisions of the Audit Committee.
 - (viii) a matter where the associated report has already been considered by the Scrutiny Co-ordination Committee or a Scrutiny Board who have endorsed the recommendations or made recommendations that have been accepted by the Cabinet/Cabinet Member.
