#Report 4 Transitions to Public Health and Constitutional Changes

Recommendations

Cabinet Member is recommended to:

- (1) Recommend to Council that the Membership of the Health and Wellbeing Board be confirmed as the membership set out in the table in paragraph 2.3.2 of the report with effect from 1st April until the Annual Meeting of the Council in May 2013 when final membership will be determined;
- (2) Recommend to Council whether or not to make a direction that members of the Health and Wellbeing Board, including members of any sub-committee or joint sub-committee and substitute members, who are not elected members of Coventry City Council are to be treated as non-voting members of the Health and Wellbeing Board, taking into account any views expressed on this point by the Health and Wellbeing Board;
- (3) Recommend to Council that no action be taken to require the Health and Wellbeing Board be politically balanced;

- (4) Recommend to Council whether or not:
 - (a) to direct the Health and Wellbeing Board that it may not appoint a sub-committee or sub-committees to discharge any of its functions (other than functions under Section 196(2) of the Health and Social Care Act 2012);
 - (b) to direct the Health and Wellbeing Board that it may not appoint a sub-committee or sub-committees or an officer to discharge any of its functions under Section 196(2) of the Health and Social Care Act 2012

taking into account any views expressed by the Health and Wellbeing Board on these points;

- (5) Recommend to Council that subject to any amendments required as a result of Recommendations (1) to (4) above, changes to the Constitution set out in section 3 of the report be approved; and
- (6) Recommend to Council that the Council Solicitor be given delegated authority:
 - (a) to make any necessary changes to the Constitutional changes set out in Section 3 arising from Recommendations (1) to (5) above; and
 - (b) to accept formally the legal documents transferring staff and the legal title and legal rights in assets and liabilities and be appointed to sign and seal the legal documents

The above recommendations were replaced with the following:

Cabinet Member is requested to recommend that Council:

- 1) Confirm the membership of the Health and Wellbeing Board as the membership set out in the table in paragraph 2.3.2 of the report, with effect from 1st April 2013, until the Annual Meeting of the Council in May 2013, when the final membership will be determined.
- 2) Confirm the existing terms of reference of the shadow Health and Wellbeing Board as the terms of reference of the Health and Wellbeing Board with effect from 1st April 2013, until the Annual Meeting of the Council in May 2013, when the final terms of reference will be determined.
- 3) Approve changes to the Constitution as set out in sections 3.3 and 3.4 of the report submitted, including the amendments to the delegated powers of the Director of Public Health as detailed in the Appendix attached to the minutes

- 4) Delegate authority to the Council Solicitor to:
 - a) Make any necessary changes to the Constitution set out in sections 3.3 and 3.4 arising from these Recommendations including the amendments to the delegated powers of the Director of Public Health shown in the Appendix to the minutes.
 - b) Accept formally the legal documents transferring staff and the legal title and legal rights in assets and liabilities and be appointed to sign the legal documents and seal the legal documents.
- 5) Defer consideration of recommendations 2 and 4 of the report submitted until such time as the Health and Wellbeing Board have considered the matters further and have submitted recommendations.
- 6) Withdraw recommendation 3 of the report submitted on the basis that this issue is addressed within Legislation.

Subject: Transitions to Public Health and Constitutional Changes

1. Purpose of the Note

1.1 The purpose of this note is to brief the Cabinet Member (Policy Leadership and Governance) on the outcome of a meeting of the shadow Health and Wellbeing Board on 11th March 2013 when the Board considered its response to the choices that the Council needs to make about the future governance of the Board.

2 Recommendations

The shadow Health and Wellbeing Board decided that it wanted to spend more time considering its future role and governance arrangements including terms of reference and membership. It will meet informally to agree its views on the matters raised and report back formally to Cabinet Member/Council. In the meantime it made the following recommendations to Cabinet Member/Council:

- (1) the Health and Wellbeing Board should have the same terms of reference as the shadow Board until such time as it is in a position to review those terms of reference and make recommendations; and
- (2) the membership of the Health and Wellbeing Board should for the time being be the same as the membership of the shadow Board until such time as it reaches a view on whether the membership needs to change.

3 Information/Background

The Health and Wellbeing Board becomes operational on 1st April 2013. From that date it will have legal status and the Council needs to make some choices about its future governance. The Board was asked to consider the following points and to give its views to Cabinet Member/ Council:

(2) the membership of the Board with effect from 1st April 2013;

- (3) whether the Council should give a direction removing voting rights from all or some of the non-elected members of the Board including members of any sub-committees and substitute members of the Board;
- (4) whether the Board should be politically balanced
- (5) the question of whether the Council should give a direction to the Board that it may not: (a) appoint sub-committees to discharge any of its functions (other than functions under Section 196(2) of the Health and Social Care Act 2012; and
 - (b) appoint sub-committees or an officer to discharge any of its functions under Section 196(2) of the 2012 Act; and
- (5) the terms of reference of the Board when it becomes operational.

Limitations on Call-in
