Report 5 London Road Gateway, Parkside, Coventry– Land Assembly

Recommendations

The Cabinet Member (City Development) is requested to recommend the following (subject to the consideration of the private report) :-

- 1. Based upon the terms detailed in paragraph 2.2 to 2.8 in the report delegate authority to the Director of City Services & Development in conjunction with the Cabinet Member for City Development to approve the terms of the land transfers between the Council and Unite.
- 2. Based upon the terms detailed in paragraph 2.9 to 2.15 in the report delegate authority to the Director of City Services & Development in conjunction with the Cabinet Member for City Development to approve the terms for the acquisition of the leasehold interest in the land and building from the Homes & Communities Agency and subject to securing a tenant the budget for the refurbishment costs.
- 3. Delegate authority to Finance and Legal Services Directorate to complete the formal agreements, land transfers and acquisition to complete the land assembly.

The above recommendations were approved.

Recommendations

Report 4Petition for a Pedestrian and Cycle Crossing Facility on Hearsall
Common at the Junction with Earlsdon Avenue North

Recommendations

The Cabinet Member (City Services) is recommended to approve that:

- i) having noted the concerns of the petitioners and considered the need to provide improved sustainable transport facilities at this location, additional pedestrian and cycle crossing facilities are provided on the South and West arms of the junction
- ii) Approve that the cost of the works is taken from existing Cycle Coventry LSTF funding.

Report 5 Petition – Request for Traffic Calming Measures in Glendower Avenue, Brookside Avenue and Wildcroft Road

Recommendations

The Cabinet Member (City Services) is recommended to:

- 1. Note the concerns of petitioners regarding road safety in this area;
- 2. Approve that further traffic volume and speed surveys are carried out to investigate whether Wildcroft Road and/or Brookside Avenue meet the criteria for inclusion on the perceived safety scheme programme;
- 3. Approve that, subject to approval of recommendation (2) above, a report back is made within six months.

Report 6 Petition Requesting that the City Council Installs Heritage Lighting around Stoke Green

Recommendations

The Cabinet Member is asked to approve the request made in the petition for the provision of heritage lighting in Stoke Green through the street lighting PFI.

The above recommendation was approved.

Report 7 Petition Requesting that the City Council takes Immediate Action to Resurface Grafton Street and Bramble Street.

Recommendations

- 1. The Cabinet Member is asked to note that based on the worst first policy the full length of Bramble Street is already included as a carriageway resurfacing scheme on the recently approved 2013/14 Highways Capital Maintenance Programme.
- 2. The Cabinet Member is also asked to approve that Grafton Street is included as a plane and patch reactive scheme this year and is added to the Highways Capital Forward Programme to be considered on a worst first basis for a future years' surface treatment.
