Report 4 Determination of School Terms and Holidays 2014-2015

Recommendations

- (3) Invite the Catholic and Church of England Diocesan Authorities and the Governors of Trust Schools and Academies to recommend the same calendar for their schools.

Report 8 Charities Information

Recommendations

- (1) **Directs that a** page **be** created on the Council website providing links to other organisations that can provide goods **and services** and direct financial support to those who are in financial need.
- (2) In developing the page **referred to in (1) above,** any opportunities for partnership working should be taken advantage of, such as those with the Community Support Grant, the DWP and Voluntary Action Coventry, **etc..**
- (3) **Directs that** resources are identified **by the Communications department of the City Council** for the on-going management of the web-page and the production of a small leaflet/postcard providing information about the web page.
- (4) The leaflet/postcard **referred to in (3) above,** is distributed to organisations, **groups and individuals** that will come into contact with those people who are experiencing financial hardship and Elected Members.

(5) A further report as to progress in respect of matters in (1) – (4) above and any other relevant matters be provided to the Cabinet Member with responsibility for equalities by 30th June 2013.

Report 4 Recommendations from the Transport and Infrastructure Development Scrutiny Board (6) on the Coventry Homefinder Nominations and Lettings Policy

Recommendations

The Cabinet Member (Neighbourhood Action, Housing Leisure and Culture) is recommended to approve that:

- The current Coventry Homefinder Nominations and Lettings policy be re-written and named Coventry Homefinder Choice Based Lettings Policy.
- 2) The policy should retain:
 - a. The current banding system.
 - b. The current policy on dealing with customers who turn down successful bids.
 - c. The current annual review of registration to ensure those on the list still require housing.
- 3) All information in the policy should be available to customers in a user-friendly summary document on the website.
- 4) The new policy should ensure the Council is meeting its statutory duties, including those regarding the military covenant.
- 5) The current 75:25 split for allocation is changed to 100% of the properties on Homefinder are prioritised to those with a housing need (bands 1 and 2).
- 6) Access to registration should remain open to enable those without a housing need to register should they wish to.
- 7) There should be links on the website to information about Housing Associations' other properties out of city, to increase choice.
- 8) There should be clear and easy to find information on the website about the different partner Housing Associations' policies for accepting or refusing tenants, such as rent arrears or anti-social behaviour.
- 9) The Cabinet Member should also consider including links on the Homefinder website to a Council endorsed website providing

information about private tenancies, such as the Kirklees model www.letshelpyou.co.uk to increase choice for the customer.

10) That any operational or procedural changes to Homefinder be delegated to the Assistant Director (Public Safety and Housing) in consultation with the Cabinet Member providing they are in line with the priorities and strategic approach identified above in the recommendations from the Transport and Infrastructure Development Scrutiny Board Homefinder Task and Finish group.

The above recommendations were approved.

Report 5 Coventry's Cultural Offerings – Recommendations from Scrutiny Visits

Recommendations

The Cabinet Member (Neighbourhood Action, Housing, Leisure and Culture) is recommended to approve:-

- To support and encourage collaborative working with partners to develop and promote Coventry's offering to the public as a heritage and cultural trail, including options for theatre trips with an evening stay.
- 2. That discussions are entered into with coach tour companies to encourage them to offer a day in Coventry as part of the Stratford and Warwick Castle route
- 3. That discussions are entered into with the Open University about what the City could offer as an attractive base for residential schools.
- 4. That discussions are entered into with English Heritage at the earliest opportunity to discuss options for the future of the Lunt Fort.
- 5. That discussions are entered into with the Belgrade Theatre to promote their community work to the city's other cultural organisations in order to share their good practice.
- 6. That the options for increasing the revenue of St Mary's Guildhall are considered and balanced with the need to preserve the heritage of the building.
- 7. That operational concerns in respect of St Mary's Guildhall are raised with managers in the City Services and Development Directorate and that the Scrutiny Board receives an update on actions being taken.

The above recommendations were approved, together with the following additional recommendations:

- 8. That a letter be sent to the Television Series Time Team and the Royal Engineers inviting them into discussions relating to the Lunt Fort.
- 9. That comments from the Wellness, Liveability and Public Health Scrutiny Board relating to St. Marys Guildhall be sent to the Cabinet Member (City Services).
