## Cabinet Member (Public Services) – 8<sup>th</sup> July, 2013

#### Report 4 Petition – 20mph Speed Limit in Whitley

#### Recommendations

The Cabinet Member (Public Services) is recommended to:

- (i) note the request of the petitioners for a 20 mph speed zone in the residential part of Whitley;
- (ii) approve that the Public Services, Energy and Environment Scrutiny Board (4) be asked to consider the matter of 20 mph limits and zones and pass back their recommendations;
- (iii) approve that traffic surveys are carried out in Abbey Road, The Avenue and Tonbridge Road in the meantime to determine the average weekday mean speed; and
- (iv) approve that a report back on this request is made within one month of when the Public Services, Energy and Environment Scrutiny Board (4) have made their recommendations.

#### **Report 5** Petition – Westwood Business Park Traffic Congestion

#### Recommendations

The Cabinet Member (Public Services) is recommended to note the concerns of the petitioners and approve that:

- the City Council continues to work with residents of the estate to encourage alternative modes of transport and car sharing to be used where possible to reduce traffic volumes on the estate;
- (ii) traffic surveys and modelling work is carried out to develop infrastructure proposals for future funding.

# The above recommendations were approved, together with the following additional recommendation:

(iii) officers be requested to monitor the part-time traffic signals at the junction of Charter Avenue and Mitchell Avenue.

#### **Report 6** Report Back: Station Avenue – Request for Traffic Calming

#### Recommendations

The Cabinet Member (Public Services) is recommended to:

- (i) note the average weekday mean speed recorded on Station Avenue was greater than 28mph in the southbound direction;
- (ii) approve the inclusion of Station Avenue on the perceived safety scheme list for funding from a future year's Highways Maintenance and Investment Capital Programme;
- (iii) approve that the results of the speed surveys are passed to the Police with a request that they carry out enforcement of the 30 mph speed limit.

Report 4 Lease and Asset Transfer Agreements for Proposed Academy Status of St Bartholomew's C of E Primary School, Hill Farm Primary School, and Three Spires School

#### Recommendations

Cabinet is requested to:

- 1. Approve the 125-year lease agreements at a peppercorn rental with the appropriate sponsor for each proposed academy at St Bartholomew's C of E Primary School, Hill Farm Primary School and Three Spires School.
- 2. Approve the asset transfer agreements for Hill Farm Primary School and Three Spires School with the sponsor for their proposed academy.
- 3. Delegate authority to the Directors of Children, Learning and Young People and Finance and Legal Services, in consultation with the Cabinet Member (Education) to agree any amendments to the Lease and Asset Transfer Agreements arising from further consideration by the academy sponsors.

#### Report 5 Priority Schools Building Programme: Progress Report

#### **Councillor Kershaw**

#### Recommendations

Cabinet is requested to approve the following recommendations:

- 1. Note the progress made in respect of the delivery of the Coventry batch of schemes;
- Authorise officers to continue supporting schools and the Education Funding Agency (EFA) in procuring and delivering the six capital grant funded PSBP schemes;
- 3. Approve capital expenditure within the CLYP Capital Programme of:
  - £510k in respect of the replacement of Richard Lee Children's Centre as part of the new school build; and
  - £30k in respect of the refurbishment of a former SSO property at Ernesford Grange to facilitate the relocation of a nursery and SEN base.
- 4. Agree to receive further monitoring reports on the final stage of the procurement process and delivery of the remainder of the PSBP programme for Coventry.
