Subject: Sexual Health Services: Review and Re-tendering

Recommendations and Comments from the Health and Social Care Scrutiny Board (5)

1 Purpose of the Note

1.1 The Health and Social Care Scrutiny Board considered proposals to Review and Re-tender Sexual Health Services at their 2nd April meeting. This Briefing Note provides Cabinet with the recommendation and comments made at this meeting.

2 Recommendations

- 2.1 The Scrutiny Board endorsed the proposals contained in the report for both Cabinet and the Arden Joint Sexual Health Project Board, and requested that in finalising the arrangements for the re-tender of these services the following issues be considered:
 - (a) Officers are recommended to work with local faith communities including the free schools, taking up the offer of assistance from Councillor Sehmi with access to local temples and mosques.
 - (b) A continuous assurance be provided that lesbian, gay and bisexual residents will continue to be provided with the appropriate sensitive support.
 - (c) The service to continue to work with the different community groups including supporting black Africans ensuring that individuals whose immigration status is not clear are not discouraged from accessing services.
 - (d) The service to continue to develop links with the mental health, drug and alcohol services.
- 2.2 Cabinet are also asked to note that the Scrutiny Board has requested that the Director of Public Health provide the Scrutiny Board with an update once the new contract for sexual health services has been awarded.

3 Information/Background

- 3.1 The Scrutiny Board considered the proposals of the Director of Public Health in detail, and following a presentation by the Assistant Director Public Health Members questioned officers on a number of detailed points including:
 - Seeking an assurance that the commissioning documentation would seek to perpetuate current good practice within the service
 - The experience of working with the different communities within the city
 - Clarification about the requirements for the work with HIV patients

- The links that the service has other services ie mental health, drug and alcohol services
- How the service reaches older people at risk
- The different requirements from the service for Coventry compared to Warwickshire
- Potential health checks and support for asylum seekers
- Clarification that the consultation reached all the different groups in the city
- The potential local and national providers who might be interested in the new contract and whether there would be just one or several smaller contracts
- The work to be undertaken with the different faith groups including consulting with the mosques and temples
- In cases of positive testing of sexual diseases, the work carried out to trace partners
- The availability of NHS data for the service
- The impact of the work of the school nursing service and whether the school academies were accessing this service
- How the service picked up on cases of female genital mutilation
- 3.2 In conclusion the Board gave its support to the re-tendering exercise and sought to raise the points raised in Section 2 with commissioners to ensure the new service was as inclusive of the diverse needs of the Coventry population as possible.

Limitations on Call-in

- (viii) a matter where the associated report has already been considered by the Scrutiny Co-ordination Committee or a Scrutiny Board who have endorsed the recommendations or made recommendations that have been accepted by the Cabinet/Cabinet Member.
