# Report 4 Petition – Request to Complete Works to Improve the Grass Verges on Daventry Road

#### Recommendations

The Cabinet Member (Public Services) is recommended to approve that a scheme to facilitate parking between 209 and 221 Daventry Road on hardened sections of verge is taken forward for prioritisation for funding alongside other requests for verge schemes across the City in a future report to the Cabinet Member (Public Services).

The above recommendation was approved.

# Report 5 Petition – Request for a Pedestrian Crossing at Broad Lane / Banner Lane Junction

### Recommendations

 The Cabinet Member (City Services) is recommended to note the measures which are being funded through S106 and S278 contributions and to approve that no additional pedestrian crossing measures are provided.

# The above recommendation was approved, with the following additional recommendation:

ii) Consideration to be given in the design of the proposed roundabout at the Banner Lane/Broad Lane junction to the needs of pedestrians wishing to cross at the junction, including the use of road markings and signs. Also that the speed limits on the roads approaching the junction should be reviewed.

# Report 6 Petition Requesting that the City Council Resurfaces Brownshill Green Road.

#### Recommendations

The Cabinet Member is asked to note that Brownshill Green Road is due to be surface dressed from its junction with Radford Road to the roundabout at Coundon Wedge Drive during the summer months of 2013. This work has already been included and approved by Cabinet as a carriageway surface dressing scheme as part of the 2013/14 Highways Capital Maintenance Programme.

The above recommendation was approved.

# Report 7 Petition – Removal of the Bollards Outside the Optician's Practice at 175 Ansty Road

#### Recommendations

The Cabinet Member (Public Services) is recommended to approve that having considered the options available and the collision history of the site, the bollards remain in place as they have reduced the risk of vehicles and pedestrians colliding on the footway.

The above recommendation was approved.

# Report 8 Report back on Petition – Engleton Road, Request for Pedestrian Facilities

#### Recommendations

The Cabinet Member is recommended to:

- 1. note the results of the pedestrian counts and endorse that no further action is undertaken in regard to the installation of a refuge.
- 2. note the average speed recorded on Engleton Road was greater than 28mph in the northbound direction and approve the inclusion of Engleton Road on the perceived safety scheme list.
- approve the installation of a SLOW carriageway marking on Engleton Road

4. The officers be requested to investigate the concerns raised regarding parking at the junctions of Engleton Road with Dugdale Road and Wyley Road.

- (vii) decisions of the Audit Committee.
- (viii) a matter where the associated report has already been considered by the Scrutiny Co-ordination Committee or a Scrutiny Board who have endorsed the recommendations or made recommendations that have been accepted by the Cabinet/Cabinet Member.
- 2. The call-in form is not completed correctly.
- 3. The call-in form is received after the specified time.
- 4. The reason for the call-in is unclear or does not relate directly to the decision specified on the call-in form.
- 5. The reason for the call-in is a question, the answer to which can be found in the report relating to the decision which is being called in.
