#### Report 4 Evenlode Crescent, Request for Traffic Calming

#### **Recommendations:**

The Cabinet Member is recommended to:-

- i) Note the concerns of the petitioners
- ii) Note that the speed checks undertaken on Evenlode Crescent recorded an average speed below 28mph and endorse that it is not included on the perceived safety scheme list at this time
- iii) Endorse that the petition signatures are included in the next 20mph zone prioritisation
- iv) Approve that the proposal to install double yellow lines at the junctions along Evenlode Crescent is advertised in the next waiting restrictions review.

# Report 4 Devolution and Economic Growth - A Combined Authority for the West Midlands Engagement Strategy

  - (ii) To recommend that the changes to the Petitions Scheme be reviewed by the Cabinet Member for Policing and Equalities – Constitutional Advisory Panel 12 months from the implementation of the changes.

#### Limitations on Call-in

  - (b) a decision of the Cabinet/Cabinet Member taken as a matter of urgency and the Chair of the Scrutiny Co-ordination Committee (or his/her nominee) had been invited to attend the meeting where the urgent decision had been taken or the Scrutiny Co-ordination Committee has previously agreed the need for urgency.
  - (c) a decision made by an employee exercising delegated authority unless it is a key decision
  - (d) decisions of the Licensing and Regulatory Committee, the Planning Committee, the Appeals and Appointments Panels and the Audit and Procurement Committee
  - (e) a matter where the associated report has already been considered by the Scrutiny Co-ordination Committee or a Scrutiny Board who have endorsed the recommendations or made recommendations that have been accepted by the Cabinet/Cabinet Member.
- 2. The call-in form is not completed correctly.
- 3. The call-in form is received after the specified time.
- 4. The reason for the call-in is unclear or does not relate directly to the decision specified on the call-in form.
- 5. The reason for the call-in is a question, the answer to which can be found in the report relating to the decision which is being called in.
