Executive Summary:

The Coventry and Warwickshire Local Enterprise Partnership Board (CW LEP) has reviewed their structure in order to better reflect public sector representation within Coventry and Warwickshire on the Board. To achieve this and maintain the necessary balance on the Board of private and public representation the Board has asked both Coventry City Council and Warwickshire County Council whether they would be prepared to reduce their current representation of two to one.

Given the structure and integrity of the Board it is considered that the reduction in numbers of Coventry City Council Directors will not disadvantage Coventry and will enable a more representative public sector element of the Board.

Recommendations:

That the City Council agrees to the reduction in their representation on the Coventry and Warwickshire Local Enterprise Partnership Board from two to one and appoints Councillor J O'Boyle as the City Council representative and Councillor A Khan as the substitute representative accordingly.

Report title: Amendments to Appointments to Outside Body – Local Enterprise Partnership

1. Context (or background)

- 1.1 The Coventry and Warwickshire Local Enterprise Partnership Board (CW LEP) has reviewed their structure in order to better reflect public sector representation within Coventry and Warwickshire on the Board. To achieve this and maintain the necessary balance on the Board of private and public representation the Board has asked both Coventry City Council and Warwickshire County Council whether they would be prepared to reduce their current representation of two to one. The current make-up of the CW LEP Board is attached to the report.
- 1.2 Given the structure and integrity of the Board it is considered that the reduction in numbers of Coventry City Council Directors will not disadvantage Coventry and will enable a more representative public sector element of the Board. Once the proposals have been agreed and formal approval given, a new structure will be established.
