Title: Joint Coventry and Warwickshire Health and Well-being Board Development Day and Local Government Association Peer Challenge

1 Purpose

1.1 To ask the Board to endorse the steer from Joint Health & Wellbeing Board Development Session to participate Local Government Association (LGA) Peer Challenge with Warwickshire Health and Well-being Board, which is proposed to take place between 14th -16th March 2017, and to agree the focus of the Peer Challenge.

2 Recommendations

It is recommended that the Board:

- 2.1 Endorse the steer from the Joint Health & Wellbeing Board Development Session to participate in the joint LGA Peer Challenge; and
- 2.2 Note the proposed focus and provide feedback on the joint LGA Peer Challenge.

3 Information/Background

- 3.1 Over recent months the Coventry and Warwickshire Health and Wellbeing Alliance Concordat has been developed and agreed. It sets out principles for joint working with Warwickshire Health and Wellbeing Board, with an emphasis on delivery of the Coventry and Warwickshire Sustainability and Transformation Plan. The concordat has the dual purpose of enabling people across Coventry and Warwickshire to pursue happy, healthy lives, and put people and communities at the heart of everything we do; whilst transforming our services and making significant financial savings.
- 3.2 At the September meeting, Coventry Health & Wellbeing Board agreed to hold two joint development sessions this municipal year aimed at seeking greater alignment of interest and approach across the two Health and Wellbeing Boards, with an opportunity to agree further development sessions in 2017/18.

4 Joint Development Sessions

4.1 The first development session was held in October 2016 which looked at how the Concordat could be put in practice and to identify ways of working together in future. In January 2017, the second development session took place between the two boards. The aim of the session was to look at the Sustainability and Transformation Plan (STP) and understand the governance arrangements in relation to it. The session also focused

on the Proactive and Preventative work stream of the STP to understand how the boards can support the delivery of this. The feedback from the workshop is currently being collated and will be shared with Board members and the STP Board. .

- 4.2 One of the recommendations from the day was the creation of joint working group to identify and implement ways to improve joint working between the two boards. Officers from Coventry and Warwickshire are working together to develop this. From Coventry's perspective, it is suggested that the working group consists of:
 - The Chair of the Board or delegated nominee
 - Partner agency
 - · Officer lead for the Board

5 LGA Peer Challenge

- 5.1 Following the signing of the Alliance Concordat and the commitment to work together as one system, the opportunity has arisen for Coventry & Warwickshire HWB Boards, in the context of the emerging STP, to take stock and undertake a joint gateway review of our current position and approach to making the Concordat real by piloting the refreshed Peer challenge offer from the LGA.
- 5.2 The new System Wide Care & Health Peer Challenge is in pilot phase and has been developed in consultation with national partners (including NHS Providers, NHS Clinical Commissioners, PHE, Association of Directors in Public Health, ADASS, NHSE, NHS Confed, NHSi). The aim of the review would be to:
 - provide a constructive assessment of the current and potential value to the HWB system of the HWBBs of Coventry and Warwickshire, independently and together; and
 - understand the contribution individual organisations, as members of the HWBBs, can make in bringing the spirit and commitment of the Coventry and Warwickshire Alliance Concordat to life.
- 5.3 The peer review team will be composed of senior leads from across local government as well as health, and it is proposed that the review takes place between the 14th 16th March 2017. Appendix 1 sets out detailed information in relation to the proposed peer challenge. Board members are invited to share their views as to what they would like the peer challenge to focus on and identify what outcomes they would like to achieve through the review.
