#### Report title: Appointments to Outside Body – West Midlands Police and Crime Panel

## 1. Context (or background)

- 1.1 At the Annual General Meeting of the Council on 17th May 2018, appointments of the City Council representatives to Outside Bodies were approved, including appointments to the West Midlands Police and Crime Panel.
- 1.2 The purpose of the Panel is to both scrutinise and support the work of the Police and Crime Commissioner, to be consulted on the Police and Crime Plan, the budget for policing, as well as the council tax precept and certain key appointments.
- 1.3 The Council appointed a City Council representative, Councillor A Khan, and a substitute representative, Councillor P Akhtar, to the Panel for the year 2018/2019.
- 1.4 In addition to the individual appointments made by Coventry City Council and Solihull Metropolitan Borough Council to the Panel, one further Member and one further substitute Member are required jointly appointed by the two authorities. The joint appointments rotate annually with the 2018/2019 appointments being Elected Members from Coventry.

## 2 Options considered and recommended proposal

- 2.1 It is proposed that Councillor P Akhtar be appointed as the joint representative and Councillor F Abbott as the joint substitute representative of Coventry City Council and Solihull Metropolitan Borough Council on the West Midlands Police and Crime Panel for 2018/2019, with immediate effect.
- 2.2 It is further proposed that Councillor K Sandhu be appointed as the City Council's substitute Member on the West Midlands Police and Crime Panel to replace Councillor P Akhtar, with immediate effect.
