121. **Application FUL/2021/3316 - Argyle House, Collingwood Road**

122. **Application FUL/2021/2386 - 8 Bransford Avenue**

This application was withdrawn from the agenda.

123. **Application S73/2021/3360 - Butts Arena, Butts**

The Committee considered a report of the Strategic Lead for Planning, detailing the above application for removal of condition No.15 - the Rugby stadium shall not be used for musical concerts, religious festivals or social gatherings; imposed on planning permission reference 47266/A granted on 21/01/2003 for partial demolition and re-grading of existing sports ground and replacement with new rugby stadium incorporating three spectator stands, a business/ leisure/function centre, new student residences, ancillary car parking, landscaping and access arrangements. The application was recommended for approval.

Councillor B Singh, a Whoberley Ward Councillor, spoke in respect of his request that consideration be given to a residents parking scheme. The applicant had been invited to respond but was not in attendance.

RESOLVED that planning permission be granted in respect of Application S73/2021/3360 subject to conditions listed in the report.

124. **Application HH/2021/2957 - 28 Fairlands Park**

The Committee considered a report of the Strategic Lead for Planning, detailing the above application for the erection of a single storey extension to an existing outbuilding and conversion to granny annexe. The application was recommended for approval.

RESOLVED that planning permission be granted in respect of Application HH/2021/2957 subject to conditions listed in the report.

125. **Application HH/2022/0568 - 75 St Ives Road**

The Committee considered a report of the Strategic Lead for Planning, detailing the above application for erection of rear extension, two storey side extension and dormer window (retrospective). The application was recommended for refusal.
