#### **Report 4      Adult Social Care Five Year Plan 2025-2030**

**Report 6                      Coventry One Strategic Plan and Education Capital Programme  
2024 - 2028**

Recommendations:

The Cabinet is recommended to:

- 1) Consider any comments/recommendations from Scrutiny Co-ordination Committee
- 2) Authorise the programme of work outlined within the proposed Coventry One Strategic Plan for Primary, Secondary and Special Educational Needs (SEN) Education.
- 3) Delegate authority to the Director of Children and Education Services to agree the most appropriate procurement route for the works to be delivered and awarded.
- 4) Authorise the funding stream as set out in section 6 of this report to be utilised for the delivery of programme of works in relation to primary, secondary and SEND within the Coventry One Strategic Plan and add 24/25 high needs allocation, 26/27 and 27/28 education basic needs allocations totalling £102.8m to the Council's Capital programme.
- 5) Subject to acting within existing budgets, authorise the acquisition of land by way of agreement as is required to facilitate sufficiency of school places within Coventry.
- 6) Delegate authority to the Director of Children and Education Services, following consultation with the Director of Finance and Resources and Director of Law and Governance, to undertake all necessary due diligence including acceptance of terms for such acquisition and the entering into appropriate legal agreements to bring into effect the recommendation in (5) above. The power under this delegated authority shall also include all necessary actions required to commence the free school presumption process to appoint an operator and any ancillary or incidental actions required.

**Report 4      Treherne Road – Prohibition of left Turn in from Burnaby Road – Objections Report**

- 2) Support the proposal to install a permanent variable message sign on Treherne Road to aid driver compliance with the existing 30mph speed limit

- 4) Approve the proposals within Variation 13 which received no objections.

## Limitations on Call-in

  - (iii) a decision made by an employee exercising delegated authority.
  - (iv) decisions of the Licensing and Regulatory Committee.
  - (v) decisions of the Planning Committee.
  - (vi) decisions of the Appeals and Appointments Panels.
  - (vii) decisions of the Audit and Procurement Committee.
  - (viii) a matter where the associated report has already been considered by the Scrutiny Co-ordination Committee or a Scrutiny Board who have endorsed the recommendations or made recommendations that have been accepted by the Cabinet/Cabinet Member.
2. The call-in form is not completed correctly.
3. The call-in form is received after the specified time.
4. The reason for the call-in is unclear or does not relate directly to the decision specified on the call-in form.
5. The reason for the call-in is a question, the answer to which can be found in the report relating to the decision which is being called in.
